Dear Hualapai Community Members,

It is of great importance that I update you on the things that have been taking place with the Diamond Bar Road it has been quite a situation for the last 3 weeks. The United District Court yesterday did give us some relief in this very unfortunate situation we have been in. I would like to share some history with you first.

In the beginning of planning to pave Diamond Bar Road a lawsuit was brought against the Mohave County, and the United States Government. In order to drop that lawsuit Nigel Turner signed an agreement with the two parties. The Hualapai Tribe was not allowed to be a part of this agreement (court decision). In the agreement there was a four year period of time that the Diamond Bar would be considered "abandoned" or the New Diamond Bar Road would be completed whichever one came first. In February 2012 the four year period was up. Mr. Turner did not say or do anything until the new road was under construction. He then filed to open up the old lawsuit. Mr. Turner closed the road and set up a toll charging \$20 and person (everyone in the car) \$500 for buses, \$1000 for Double Decker buses. Finally, he shut down the road completely not even allowing the employees to pass.

In the June 13 court ruling the Judge told Mr. Turner that he gave the United States no alternative but to build a bypass, after his attorney asked for construction to stop for 30 days. The Judge also scolded him for placing a building on United States property even when he was aware of what he was doing and that it was wrong. Mr. Turner was sent a letter from the United States telling him to remove the building by July 12, 2013. The case remains open incase if something else occurs.

On June 17, 2013 at 10:30 2300 visitors had been at Grand Canyon West. I happened to be there and witnessed many visitors even the First Lady of Mali was there to visit. We are still in business!! All Hualapai's should be proud of the things we have accomplished here and that we can provide for the future of the people.

There are many issues to discuss to keep you informed. We will be having a General Meeting for the community on July 3, 2013 from 12 noon to 4 p.m. at the Tribal Gym. So please come out to listen. The Tribal Council will be sponsoring a meal and then speaking about important issues. Thanks for your continued support as we work through all the issues at hand.

Solar Energy Workshop

The Hualapai Planning and Economic Development Department is holding a workshop on Tuesday, 25 June, 2013, at the Conference room of the Health, Education and Wellness Center from 11:00 AM to 4:00 PM to explore the opportunities for solar project development on the Reservation. The Tribal Council has invited TAWA Power, a Native American-owned solar project development services firm, to propose project initiatives based on the work of consultants previously retained by the Tribe and on recommendations of the Department of Energy's START program. TAWA will review with the Tribe which proposed solar projects are priorities and possibilities within the framework of the Tribe's economic and sustainability strategy.



The solar projects to be explored range in size from net-metered systems that provide power to individual buildings such as the Juvenile Detention Center, to stand-alone solar arrays covering a few acres to serve the community like the new array being built for the Havasupai Tribe on Long Mesa, and then up to large-scale solar fields covering a square mile or more designed for the Tribe to sell power to utility companies such as Arizona Public Service, Southern California Edison and others. The potential for each kind of solar array at several locations including Peach Springs, Grand Canyon West, the Nelson area and the Hualapai Valley will be discussed as well as the role of TAWA and its finance partners. Lunch will be provided.

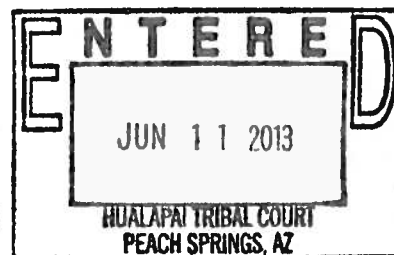



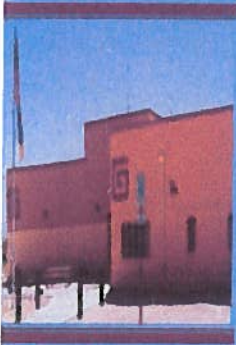

It is my pleasure to announce that on May 30, 2013 one of our detained youth acquired a General Equivalency Diploma (GED).

This is the first youth from HJDRC to accomplish such a momentous feat. When this youth first came to detention she did not have enough credits but still wanted to earn her high school diploma. Many of the youth in detention lack the credits needed to earn a high school diploma but feel the pressure to receive a high school diploma instead of a GED. Earning a high school diploma if they are 16 years or older and with only a couple of credits may not be a realistic goal they could very well be graduating at 20 years of age. Once a youth is remanded to detention our juvenile detention teacher initiates an education plan and a decision is made as to what is the best way to meet their educational needs; their age and the amount of credits they have completed will determine what action plan will be implemented. We inform our students that obtaining a GED is just as important as earning a high school diploma.

Even though this youth did not pass the test the first time she took it she did not let this setback deter her from obtaining her goal for academic achievement. She continued to study and even on the days when she was not attending class she would continue to work on the subject matter that had robbed her of her academic goal. Because of all her effort, determination and the overwhelming support from the detention teacher, HJDRC administration, her parent, the green reentry manager, and all our staff she was able to fulfill her dream.

This youth will now be able to attend a graduate school and continue her education. She has developed discipline, persistence and most of all the self-confidence in knowing that she can set goals and accomplish them.

All of us at HJDRC are very proud of this individual and wish her the best of luck on her future goals.

Annual Sobriety Festival

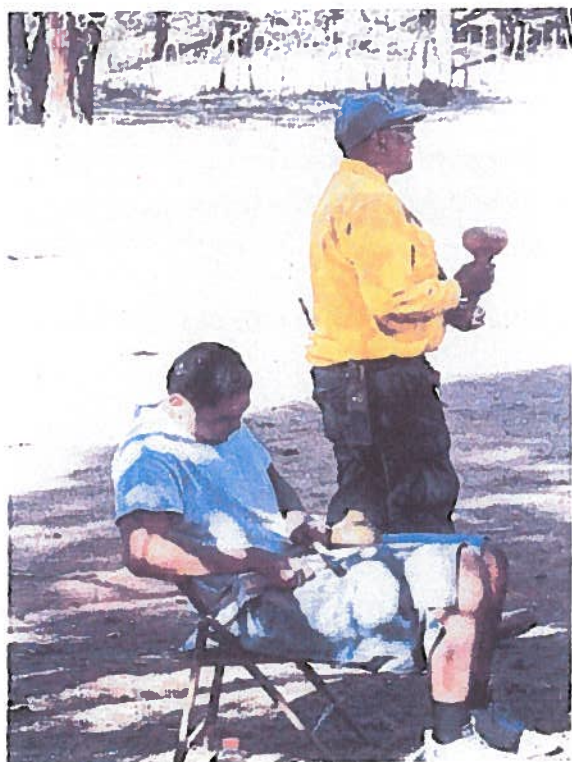

FUTURE TRIBAL LEADERS STUDY THE TWENTY PINES FOREST

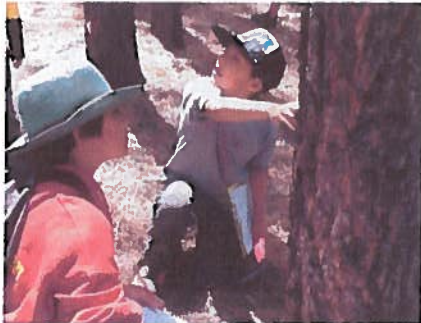
This quarter, fourth grade students have been engaged in a research project that involved working with experts from the community and scientists from Northern Arizona University.

In the classroom, students studied trees in general, the parts of trees, the structure of trees, and photosynthesis. Later, they were joined in the classroom by Dendrochronologist, Amanda Stan, PhD. from NAU where they learned about the study of tree rings and fire science.

Once the students had quite a bit of background knowledge, they loaded up on a bus and headed out to the Twenty Pines forest where they were joined by Dr. Stan and two other scientists from NAU, as well as a team of representatives from the Hualapai Cultural Department. While in the forest, the students collected data to take back and analyze in the classroom. At the same time, they participated in activities that helped them understand the forest as a significant Tribal resource, and also as a habitat for many of the animals that inhabit the area.

Back in the classroom, students compiled their data, and graphed the results. The graphs allowed them to draw conclusions about the health of the forest and what actions need to be taken to preserve and protect it.

Concurrent with the forest and culture study, students completed a research project on the animals that live in the Twenty Pines forest. They wrote expository essays and developed a presentation of their knowledge, which was given at the school on Monday, May 20, 2013 to a large audience of community members.

This summer, a group of students will be asking the tribal council to hear their recommendations for future management of the Twenty Pines forested area. Way to go, fourth graders!

David Jin Death | Las Vegas Review Journal

LAS VEGAS (AP) — A Las Vegas businessman who developed the Grand Canyon Skywalk glass bridge in northwestern Arizona and later became entangled in legal battles about it has died in Los Angeles, a company representative said Friday. David Jin died Thursday at UCLA Medical Center after a four-year battle with cancer, Grand Canyon Skywalk Development spokesman David Weissman said. He was 51.

Jin's death comes amid a continuing legal fight over his contractual rights to the Skywalk, a horseshoe-shaped, glass-bottomed walkway that has become the Hualapai Tribe's premier tourist attraction. An attorney for the development company said Jin's family will continue to pursue Skywalk legal rights. Jin, originally from Shanghai, moved to the U.S. in 1988 and operated Oriental Tours Inc. and Y-Travel LLC in Las Vegas. He already was ferrying tourists 2½ hours from Las Vegas to the west rim of the Grand Canyon on the Hualapai reservation when he approached the tribe

with an idea to build the Skywalk. It opened in 2007. The structure juts out 70 feet from the edge of the Grand Canyon's sheer limestone walls, offering visitors a unique view some 4,000 feet down to the Colorado River, which appears as a thin brown ribbon.

"Our thinking is that, if a human being could walk over the canyon, if they had the opportunity, even handicapped people, it's just really, really, you know, something," Jin told The Associated Press in 2006. Jin invested \$30 million to build the Skywalk. In exchange, the tribe agreed to split the profits from ticket sales with him over 25 years. But Jin's relationship with the tribe soured in recent years, with the two sides wrangling over management fees and an unfinished visitor center. The tribe enforced eminent domain over the contract last year, essentially writing Jin out of his management role. Jin challenged the jurisdiction of the Hualapai court overseeing that case. A three-judge panel of the 9th U.S. Circuit Court of Appeals ruled that Jin had to exhaust the battle in tribal court before turning to the federal court. A request for rehearing by the full court was rejected last week.

The tribal business that succeeded Jin in managing the Skywalk filed for bankruptcy after an arbitrator awarded Jin more than \$28.5 million in the contract dispute. The judgment is being appealed. Jin also filed a federal defamation suit against tribal Chairwoman Sherry Counts, the tribe's public relations firm and other tribal members. On Friday, Counts issued a statement offering condolences and sympathy on behalf of the Hualapai people to Jin's family. "Our thoughts are with Yvonne, Michael and Catherine at this very difficult time," she said.

Attorney Mark Tratos in Las Vegas represents Grand Canyon Skywalk Development. Jin was not part of a recent dispute involving the Hualapai Tribe and a neighboring property owner over payments for access on the main road to the Skywalk. Jin's wife and business partner, Yvonne Jin, will take over ownership responsibilities of Grand Canyon Skywalk Development, Oriental Tours and Y-Travel, Weissman said. Hualapai tribal member Ted Quasula, Jin's longtime business associate, will continue to manage Grand Canyon Skywalk Development. "The Grand Canyon Skywalk will be David's legacy for eternity," Quasula said in the company statement.

Child Passenger Safety Certified Technicians in Hualapai

In March a National Child Passenger Safety Certification Training Program was held by Safe Kids. The training was made possible by the TIPCAP program in collaboration with Social Service and Law Enforcement.

There are 9 new certified Child Passenger Safety Technicians and 3 re-newal who passed the training. The Hualapai Tribe now has a total of 14 Certified CPS Technicians in the community for the safe installation of car seats in the Hualapai Community.

CPS Ts put their knowledge to work through a variety of activities, including child safety seat checks in which parents and caregivers receive education and help with the proper installation and use of car seats and seat belts.

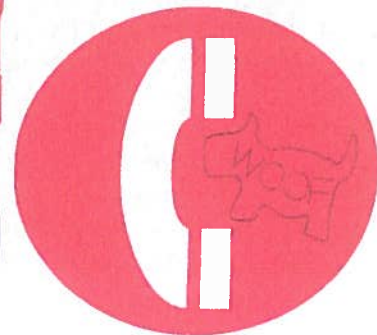

July 8th - 11th, 2013



The 13th Annual Pai Language/ Immersion Camp will be held at Twenty-Pines, which is located in Peach Springs, AZ.
