Rural Youth Loans

Overview

The U.S. Department of Agriculture's Farm Service Agency (FSA) makes operating loans of up to \$5,000 to eligible individual rural youths age 10 through 20 to finance incomeproducing, agriculture-related projects. The project must be of modest size, educational, and initiated, developed and carried out by rural youths participating in 4-H clubs, FFA, or a similar organization.

The project must be an organized and supervised program of work. It must be planned and operated with the assistance of the organization advisor, produce sufficient income to repay the loan, and provide the youth with practical business and educational experience in agriculture-related skills.

Who May Borrow

To qualify for a loan, the applicant must:

- comply with FSA's general eligibility requirements;
- reside in a rural area, city or town with a population of 50,000 or fewer people; and
- conduct a modest incomeproducing project in a supervised program of work.

How Loan Funds May Be Used

These loans can finance many kinds of income-producing agricultural projects. The loan fund may be used to:

- buy livestock, seed, equipment and supplies;
- buy, rent or repair needed tools and equipment; and
- pay operating expenses for the project.

What Details to Know

To apply, the applicant must submit completed plans and budgets signed by the project advisor and parent or guardian along with the FSA application for loan assistance. These loans:

- have a maximum loan amount of \$5,000 (total principal balance owed at any one time cannot exceed this amount);
- have an interest rate which is determined periodically, based on the cost of money to the federal government,
 - after the loan is made, the interest rate for that loan will not change;
- will be secured, in addition to promissory notes, by liens on the products produced for sale and on chattel property, including livestock, equipment and fixtures purchased with loan funds; and

- have a repayment schedule which varies depending on the type of project for which the loan is made,
 - for example, if it involves raising livestock or crops, the loan is paid when the animals or produce are normally sold.

Requesting Review and Comments on Hualapai Water Quality Standards

To: The Hualapai Tribal members and the community at large

From: The Hualapai Department of Natural Resources

Water Resource Program

Regarding: Public review and comments are requested on the Hualapai Tribes Water Quality Standards revisions to Appendix A: Table 1. Human Health and Agricultural Designated Use, Numeric, Water Quality Criteria. Most of the criteria numbers to protect human health are being made fairly modestly more stringent because the national average fish consumption value was amended from 6.5 grams/day to 17.5. The revisions have incorporated recommendations from the U.S. Environmental Protection Agency (EPA) for inclusion in our latest triennial review (2012) of the Tribe's Water Quality Standards.

In accordance with water quality management regulations in 40 CFR 130.3 (b)(6) and public participation regulation 40 CFR part 25, the Water Resource Program is receiving comments on revisions to the

Tribe's Water Quality Standards for 30 days. Commencing November 15, 2012 and ending at the close of business December 14, 2012. A public scoping meeting is scheduled for December 14. 2012 at the Multipurpose building in Peach Springs, AZ from 8:00 a.m. to 4:30 p.m. Upon completion of the review and public meeting we will respond to comments received with the assistance of U.S. EPA and will compile a list of the comments and our responses. Then we will submit to the Hualapai Tribal Council the final revised water quality standards for ratification and adoption.

Housing Choice Vouchers Fact Sheet

What are the housing choice vouchers?

The housing choice voucher program is the federal government's major program for assisting very low-income families, the elderly, and disabled to afford decent, safe and sanitary housing in the private market. Since housing assistance is provided on behalf of the family or individual, participants are able to find their own housing, including single family homes, townhouses and/or apartments.

The participant is free to choose any housing that meets the requirements of the program and is not limited to units located in subsidized housing

project. Housing choice vouchers are administered locally by public housing agencies (PHAs). The PHAs receive federal funds from the U.S. Department of Housing and Urban Development (HUD) to administer the voucher program.

A family that is issued a housing voucher is responsible for finding a suitable housing unit of the family's choice where the owner agrees to rent under the program. The unit may include the family's present residence. Rental units must meet minimum standards of health and safety; as determined by the PHA. A housing subsidy is paid to the landlord directly

by the PHA on behalf of the participating family. The family then pays the difference between the actual rent charged by the landlord and the amount subsidized by the program. Under certain circumstances, if authorized by the PHA, a family may use the voucher to purchase a modest home.

Hualapai Tribal Court Security Information

Citizens entering the Tribal Court Building may be subject to security screening, including the following:

- Passing through a metal detector;
- Having handbags and briefcases inspected;
- And, if necessary, being checked by a hand-held metal detector.

Cell phones, pagers, packages, and electronic devices of any kind are also subject to inspection.

While your case is proceeding through the court system, please observe the following standards:

- No weapons are permitted in the Hualapai Tribal Courthouse.
- Sit quietly in the courtroom whenever court is in session. The proceedings are being recorded and background noise may interfere with the quality of the recording
- Any issue that causes a distraction to the court proceedings will not be tolerated. Person(s) causing such distractions will be asked to leave the

Weapons of any kind are strictly prohibited If weapons are brought into the Courthouse, you will be asked to remove them from the building.

Prohibited items include, but are not limited to, the following:

- Guns, ammunition and explosive materials,
- · Swords, utility blades, knives,

razor knives and blades, pepper spray and mace.

• Illegal substances, including illegal drugs,

• And any type of dangerous or

Food items and drinks, other than water, are also prohibited from being brought into the courtroom. For a more detailed list of prohibited items you may contact the Court.

Courtroom Standards

- When addressing the Judge, stand at the table provided before the bench.
 Do not approach the bench.
- No food, drink or gum chewing is allowed in the courtroom.
- Smoking is prohibited by law in all areas of government buildings.
- Do not appear before the Court under the influence of alcohol or any illegal substances or immediately recovering from substance use.
- Avoid bringing small children to court. If you must, please have an

adult monitor their behavior outside the courtroom, so that they play quietly. Adult and child may be asked to leave the court building if the child becomes noisy or unruly while in the court building.

• Respect the court and wear suitable clothing to court. It is inappropriate to wear clothing that carries offensive pictures and slogans or clothing that does not cover the body appropriately, will not be tolerated. Hats must be removed before entering the courtroom.

Arizona Tax Credit

Where do you want your tax dollars to go?

State law (A.R.S. 43-1089.01) allows you to get a tax credit when you pay up to \$200 for single filers and \$400 for married filers to a public school for extracurricular activities that require enrolled students to pay a fee. This means taxpayers may help Peach Springs School –not the state treasury – and reduce their tax bill at the same time.

For a tax credit to be claimed for 2012, the donation must be postmarked or delivered to the school district by December 31st. The school district will issue you a receipt that will allow you to claim the tax credit. You will receive the receipt at your mailing address by January 31, 2013.

Donations to public schools have always been tax deductible. A **tax deduction** allows you to subtract the contribution amount from your taxable income. If you work in Arizona and pay state taxes, the **tax credit** will save you dollar for dollar on the amount of taxes you owe.

What will the funds be used for?

Eligible activities include: **field trips** to fine arts activities, such as the Phoenix Zoo, **science and art events**, **overnight trips** for fine arts programs, and **athletic programs** such as volleyball, basketball, and cross country meets.

Extracurricular activities such as sports, band, speech and debate, or field trips generally cannot be fully funded by school district revenues and depend on fees from students. Thus, your donation allows the school to offer additional enrichment programs.

Who can take advantage of this opportunity?


