Members of the Hualapai Indian Tribe are hereby advised that a Secretarial Election will be held **October 23, 2014**, for the purpose of voting on ratification or rejection of proposed amendment(s) to the Hualapai Indian Tribe's Constitution. This election is being conducted by the Bureau of Indian Affairs in accordance with Part 81 of Title 25 of the Code of Federal Regulations 25 CFR Part 81 (web link: www.ecfr.gov).

Pursuant to the requirements of 25 CFR Part 81.6(d), members must register to vote in this election. A Registration Form is being mailed to eligible members. Any member who does not receive such a form by mail should request one from the Election Board Chairperson, Mr. Jim Williams (928) 769-3306 or Mr. Melvin Hunter, Jr., Election Committee Member at (928) 769-3305.

Request for Proposal • Brush Removal*Submitted by: Annette Bravo, Hualapai Department of Natural Resources***Request for Proposal****Title:** Brush Removal in Livestock District 3**Requested by:** Hualapai Tribe, Department of Natural Resources**Project Location:** This project is located in Livestock Grazing Association #3. Hualapai Indian Reservation, Peach Springs, AZ (Figure 1).**Scope of work:**

Juniper (Utah juniper (*Juniperus osteosperma*) and Oneseed juniper (*Juniperus monosperma*) will be mechanically cut down and/or treated with chemicals. For mechanical treatment, the juniper skeletons will be cut down so that the slash is no greater than 20" tall and no stump over 12" remains on site. In areas of erosion, hand cleared trees will be placed in wash ways with the crown of the tree facing upstream. Brush removal will stay below 15% slope and away from cobbly areas. Pinyon pine and other species on the site will not be removed. For chemical treatment, evaluation of the selected herbicide will need to be conducted before use. The timing of the herbicide will be carefully planned to be applied at the appropriate and most effective conditions for that type of herbicide. The same target post treatment pounds per acre will need to be achieved with the herbicide as with the mechanical methods.

Target: • No more than two junipers, 6' tall per acre or no more than 7-9' tall juniper per acre.**Bid Selection Criteria:**

There are 3 (three) 40 acre blocks available to be cut. The Bidder may bid on all three blocks or just two blocks or on only one block.

1. Written description of how the Bidder will complete the proposed project. Identify if the bid is for all three blocks, only two blocks, or for one block.
2. Description of crew that will be working.

Director, Hualapai Housing Department**

Jamie Navenma was hired as the Director for the Hualapai Housing Department. He is Hopi/Tewa from First Mesa, Si'tsu'movi village. His mother's clan is Roadrunner and his father's clan is Sun Forehead from Second Mesa, Si'pa'lovi. Jamie has worked with various tribes throughout the country, providing technical assistance for HUD and tribal housing programs, training and technical assistance for Administration for Native Americans grantees, and providing program/grants management for federal grantees. He has served as a Senior Program Manager with the Western Region team of Corporation for Supportive Housing, and led the American Indian Supportive Housing Initiative (AISHI), promoting systems and policy change to help end homelessness for tribal communities throughout the United States.

Mr. Navenma has worked in tribal housing since 1993 and started off as a Homeownership Counselor. He has since been involved in every aspect of the tribal housing program, including serving as the Executive Director for the Hopi Tribal Housing Authority. He has also worked for a General Contractor so he knows

the "other side of the fence" as a contractor working for tribal entities. Jamie is grateful for the opportunity to serve the Hualapai Tribal members and will work to ensure more homes are built, housing opportunities are sought after, and housing services are developed for the Hualapai Tribe. There are current homes that also need to be taken care of and with a limited annual budget, he will work with the staff, the Tribal Council, Tribal Programs and the community members to find ways to address these issues.

There will be challenges, but with everyone willing to work with one another to ensure the community as a whole benefits from the Housing Program it can be done. Please feel free to contact Mr. Navenma in regards to Hualapai housing needs, issues, challenges and solutions.

Call to Order/Roll Call/Welcome

The regular meeting of the First Things First Hualapai Tribe Regional Partnership Council was held on August 13, 2014 at 3:00 p.m. at the Hualapai Health, Education and Wellness Department in Peach Springs, Arizona, 86434.

Members Present

Member Absent

Chair Hunter called the meeting to order at 3:01 p.m. and welcomed new member Zavler Benson. Chair Hunter took roll to document the members present and on the phone.

Possible Approval of July 9, 2014 Meeting Minutes

Reverend Imus made a motion to approve the July 9, 2014 meeting minutes. Member Irwin seconded the motion. The motion passed unanimously.

Call to the Public

There were no responses to the call to the public.

Regional Partnership Council Member Announcements and Reports

Reverend Imus spoke briefly about the West Regional New Member Orientation, and Member Tinhorn stated she found the orientation very informative.

Possible Approval of 2014 Regional Needs and Assets Assessment

Regional Director Ashley Pascual reviewed the timeline and gave a brief overview of the actions taken during the Needs and Assets Assessment process. Violeta Dominguez, a Research Scientist with the University of Arizona, Norton School, confirmed the newest regional council members were familiar with the purpose of the report, then provided a brief background of the work to date. Ms. Dominguez stated the demographic information is obtained from the U.S. Census, other public agencies and Tribal departments. She highlighted new information that has been included in the report, such as healthy weight/obesity data, oral health data and immunization data. The report also includes data gathered through a parent/caregiver survey conducted in the region. Special attention was given to the School Readiness indicators chosen by the regional council. Senior Director Gary Arnold inquired about an after-action report, and Ms. Dominguez advised there would be a white paper provided to report on best practices. Referencing the health data in the report, Reverend Imus requested Director Pascual invite Connie Hunter from the Peach Springs Unified School District to the next meeting to discuss the school's successful new program incorporating fruits and vegetables into children's diets. Director Pascual requested regional council members provide final feedback by August 14, 2014. Reverend Imus made a motion to approve the Fiscal Year 2015 Regional Needs and Assets Assessment as a final draft, with permission to allow staff to continue working with the contracted vendor to conduct minor editing prior to submitting to the State Board by September 1. Member Hudak seconded the motion. The motion passed unanimously.

FTF Grantee Spotlight: Hualapai Maternal Child Health Program

Vivian Sue Parker, Hualapai Maternal Child Health Program Coordinator, introduced the new Maternal Child Health Advocate, Roxanne Rodriguez. Ms. Parker presented information about the Parents as Teachers curriculum the program employs with families. The curriculum's eight home visits enable staff to connect with families on many levels to discover strengths and set goals. The program has promoted several recent events to encourage healthier choices, with more planned to continue working to build partnerships with parents. There was some discussion about the target service number of thirty families served, and grant-funding remaining as a result of serving only fourteen at this time; however, Ms. Parker discussed the staffing noted the focus is on quality, not quantity.

Discussion on Grantee Data and Fiscal Updates

Director Pascual advised Attachment 3 is unavailable since the data report was not finalized by the Evaluation division; Instead, she shared grantee narrative report information.

Director Pascual reviewed the FY2014 financial expenditures and noted grantees have 45 days after the end of the fiscal year to finalize reimbursement requests. The overall expenditure rate is projected to be approximately 75%.

Director Pascual reviewed the FY2015 contracts, which include Quality First, a full twelve-month grant for the native language strategy, the home visitation strategy and a reduced food security grant. Member Tinhorn inquired about the unused funding for TEACH scholarships, and Director Pascual explained these funds from FY2014 would become part of next year's (FY2016) allocation.

SFY2016-2018 Strategic Planning Discussion

Director Pascual provided an update on the State Board fiscal policy decisions, as outlined in Attachment 5. Following the presentation of the decisions, there was some discussion surrounding non-funded approaches, such as the recent Hualapai Kids' Health Fair used as an example. These partnerships with community organizations offer additional opportunities to provide services without expending funds.

Director Pascual then provided an update on the State Board program and policy decisions, as outlined in Attachment 6, including the separation of Quality First programs from Quality First scholarships, the addition of incentives for rating only sites, and the requirement to pursue cost efficiencies and continuous quality improvement.

Director Pascual reviewed the strategic planning framework and the school readiness indicators prioritized by the regional council. Director Pascual reviewed the next steps, which include inviting neighboring regional directors to present on September 10; a presentation to Hualapai Health, Education and Wellness staff on September 4; and scheduling a meeting with Head Start staff, all to compile information for the Regional Partnership Council to consider in developing the next funding plan. Member Irwin mentioned a past survey completed by Northern Arizona University that may help during the planning process, and expressed the need for a place for families to learn social skills before entering Head Start. Member Irwin mentioned the process for requesting tribal financial support, as well.

Parent Awareness and Community Outreach Report

Erin Taylor, Community Outreach Coordinator provided a flyer from the Gamyu highlighting the recent Mother Daughter Retreat, which included an early literacy activity. Coordinator Taylor also informed the regional council that she had participated in the Back to School Bash and the My Kid Your Kid event, where Dr. Perkins shared information about the Pride and Tutoring programs the school has developed to build up students. Coordinator Taylor announced there are public service announcements planned on The Peach radio station.

Regional Director's Report

Director Pascual shared that the newly named Communications and Public Affairs Division is conducting interviews for the Senior Director of Tribal Affairs position, the Communications Coordinator and the Government Liaison position. She noted that the entire Hualapai Tribe Regional Partnership Council would be attending the Summit, with both Dr. Perkins and Reverend Imus presenting during sessions.

Director Pascual reviewed upcoming events, including the Early Childhood Coordination meeting in Parker on September 3.

Next Meeting

Chair Hunter checked in with the Regional Partnership Council members regarding the new meeting time. Consensus remained for the 3:00pm meeting time.



DESCRIPTION OF TRANSPORTATION SERVICES

The Hualapai Tribe through the Hualapai Health Department's Non-Emergency Medical Transport provides transport services which include services to the elderly and disabled. The Hualapai Tribe is a Tribal Government which provides governmental services for individuals who live on the Hualapai Indian Reservation. One of those services is Non-Emergency Medical Transportation.

Hualapai Health Department's Transport Services

1. The priority is medical transports. These trips are for medical appointments or for medical admissions. The trips are requested by completing the Non-Emergency transport form located at the Health, Education and Wellness Reception desk. Please attach a copy of your appointment slip. The completed transport request and appointment slip. Submit transport request as soon as you know you need the transport. The completed transport form should be given to the HEW Reception staff. If you do not receive a call informing you that you have been scheduled, you may call 928-769-4188. The trips are provided between 3 AM to 10 PM, Monday through Friday. The trips are normally made to Kingman, Arizona but also include, Flagstaff, Phoenix, Parker, Tucson Arizona and occasionally to Las Vegas, Nevada. Seat belts and car seats are required for all transports. You must bring your own car seat.
2. AHCCCS is billed for medical transportation for those Individuals who are on AHCCCS or who may qualify. Non-AHCCCS ,who qualify, patients are covered through the Hualapai Tribe's general funding.
3. Non-Medical Transports. There is a charge for other types of transports of \$10.00 per 100 miles per person. Those trips include: food bank, shopping, pick-up or drop off at various places, trips to medical facilities where their immediate relative has been flown or taken by ambulance, individuals who need to pick up their vehicle, shop for a program, and other social or program issues that may arise. The trips are available between 8 AM to 5 PM, Monday through Friday. The trips are made to Kingman, Flagstaff, Parker, Phoenix, Las Vegas, Supai Hilltop.
Local transports may be provided if a driver and vehicle are available.
If an escort is needed, please complete that portion of the transport form.

Summary Statement

The driver may encounter a situation not covered in this or the Hualapai Tribe's Policy and Procedure and may not be able to discuss alternatives with the Supervisor or Director and will need to make the best decision they can. In these instances, they must notify the Supervisor/Director as soon as possible and follow-up with a letter explaining what happened - follow-up and outcome. The Hualapai Tribe does not discriminate against any individual on the basis of race, color, sex, religion, national origin, age, pregnancy, disability and/or sexual orientation.

Mental Health Crisis Planning for Families

MENTAL HEALTH CRISIS PLANNING FOR FAMILIES

What is a mental health crisis?

Any situation in which the child's behavior puts him or her at risk of hurting the self or others and/or when the parent (caregiver) isn't able to resolve the situation with the skills and resources available.

This brochure was provided by Mohave Mental Health Clinic, Inc. 1-888-757-8111. Our mission is to improve, enhance and promote the emotional well-being of Mohave County residents who experience life-disrupting problems, and to strengthen the quality of personal, family and community life. Mohave Mental Health is contracted through NARBHA, the Regional Behavioral Health Authority for Coconino, Navajo, Yavapai, Apache and Mohave counties. Funds for services are provided through a contract with the Arizona Department of Health Services/Division of Behavioral Health Services and AHCCCS.

What causes a mental health crisis?

Many things can lead to a crisis. A situation or stressor may trigger a crisis:

HOME or ENVIRONMENTAL TRIGGERS

- Changes to family structure
- Loss of any kind - may be due to a death or relocation
- Loss of a pet
- Transitions between two homes
- Strained relationships with step-siblings and/or step-parent
- Changes in friendship
- Fights or arguments with friends or family
- Conflict or arguments with parents

SCHOOL TRIGGERS

- Worrying about tests or grades
- Overwhelmed with homework or projects
- Feeling singled out by peers or feeling lonely
- Pressures at school; transitions between classes or activities
- Bullying at school
- Pressure by peer
- Suspension, detention or discipline
- Misunderstanding by teachers who may not understand that the child's behavior is a symptom of their mental illness.

OTHER TRIGGERS

- Changes in medication/stops meds/starts a new med/misses medication
- Use of drugs or alcohol
- Unusual stimulation or changes in routine
- Being in large groups
- Change in expectations
- Rapid transitions or new challenges

What may be the warning signs of a mental health crisis?

Sometimes families or caregivers observe changes in a child's behavior that may indicate a crisis may be impending. Other times the crisis occurs suddenly and without warning. You may be able to minimize or prevent a crisis from happening by identifying early changes in your child's behavior, an unusual reaction to daily tasks, or an increase in stress, for example. Families may keep a journal or

calendar documenting what proceeded concerning behaviors. Here are some warning signs:

Inability to cope with daily tasks

- Doesn't bathe, brush teeth or take care of hair
- Refuses to eat or eats too much
- Sleeps all day or refuses to get out of bed
- Doesn't sleep

Rapid mood swings

- Increase in energy
- Inability to stay still, pacing
- Decrease in energy

Displays abusive behavior

- Hurting others
- Cutting self
- Hurting self
- Alcohol or drug use

Increased agitation

- Makes verbal threats
- Displays out of control behavior
- Destroys property
- Cruel to animals

Isolation from school, family, friends

- No interest in normal activities
- Changes in friends
- Stops doing homework or going to school

Unexplained physical symptoms

- Eyes or facial expression looks different
- Increase in headaches or stomachaches
- Complaints about not feeling well/not specific

HOW DO FAMILIES MANAGE A MENTAL HEALTH CRISIS?

When a crisis occurs, families often don't know what to do. A crisis can occur even when a parent has used de-escalation techniques or other options. It's nobody's fault. Children's behaviors can be unpredictable and occur without warning.

Talk about and prepare for a mental health crisis by working with your Managing Clinician to develop a plan so that you will feel more comfortable with the situation arises.

You can seek help in a number of ways:

Use your crisis plan; which may include involving supports. Immediate mental health professional help is also available by calling the **Crisis Line: 1-888-757-8111**

If you or others are in immediate danger, you may need to **call 911**. Assess the situation of hurting him or herself or others or property.

You may decide to bring your child to the **Emergency Room** to be assessed for hospitalization if you feel that the child is dangerous to the self or others.

De-escalation Techniques are helpful in a crisis situation

- ✓ Keep your voice calm
- ✓ Use short sentences
- ✓ Listen to the child's story
- ✓ Offer options instead of trying to take control
- ✓ Ask how you can help your child
- ✓ You may want to avoid overreacting
- ✓ Move slowly
- ✓ Don't argue or shout
- ✓ Express support and concern
- ✓ Keep stimulation level low

- ✓ Avoid eye contact
- ✓ Be patient and accepting
- ✓ Announce actions before initiating them
- ✓ Give them space, don't make them feel trapped

SAFETY FIRST-

In a crisis situation, when in doubt, back off or get out

How do families create a prevention plan?

Families work with their managing Clinician, and other supports, such as friends and family or other agency helpers to create a plan that can help and that works.

These are some questions that are discussed during the Crisis Prevention Planning:

- Have we had a crisis intervention plan in the past? Did it work? Should we update? What situations have led to a crisis in the past?
- What seems to trigger behaviors for my child?
- What has worked to help reduce my child's stress or to avoid a conflict in the first place?
- What helps calm the child or reduce symptoms?
- What can I do to reduce family stressors?
- Have I used all available resources?
- What steps can I take to keep everyone calm and safe?
- Who should I call for support in a crisis or to help calm the situation?
- What skills could my child or I learn and practice to reduce the impact of a future crisis?

Create a helpful resource that includes:

- A copy of your crisis plan
- Names and phone numbers of anyone working with your child
- A list of phone numbers of supportive family and friends who are helpful to you in a crisis (even if you have a cell phone programmed with their numbers)
- List of medication and dosages
- Copies of any documents that may be helpful to providers such as IEP plans or Behavioral Health service plans.

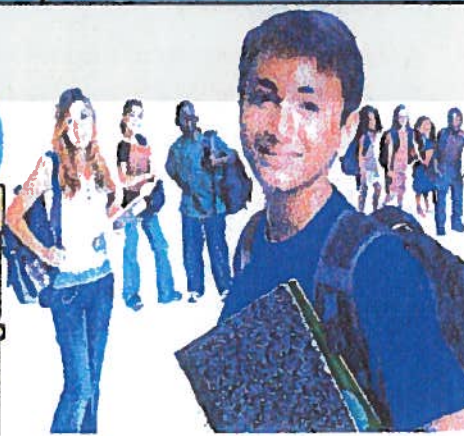
How can families learn more about reducing crisis?

Dr. Ross Green, in his book the **EXPLOSIVE CHILD**, outlines a collaborative problem solving approach which creates partnership between an adult and child. This approach helps the adult and the child engage in finding solutions. The focus is on preventing problems before they occur. Children do as well as they can and have some missing skills, which can show up as "misbehavior". With this approach you "lend" your brain to your child by breaking down the problem solving steps in a way that helps them do better in the long run.

Dr. Green has some innovative ideas about helping children with challenging behaviors and understand what gets in the way. This approach may be helpful for parents of children with persistent, problem behaviors that don't respond well to typical parenting strategies such as sticker charts or time out. Your managing Clinician will be able to talk with you more about dealing with behaviors using this approach.
