Re: Candidate Incligibility Determination

Dear Ms. Parker:

The Election Board received your Candidate Filing Form for the upcoming 2016 General Election. In review of your Candidate Filing Form, we note that you did not include a complete Social Security number and therefore did not complete the Candidate Filing Form by 5:00 pm on April 5, 2016. On April 6, 2016 we were notified by Advanced Surveillance Group Background Check Central that they were unable to process your background check due to an incomplete social security number provided.

The Constitution and Election Ordinance of the Tribe require the Election Board to conduct elections including the certification of candidate qualifications. Article IV – QUALIFICATIONS, Section 1(c) of the Election Ordinance states:

The Election Board shall certify that all candidates for Tribal Council positions meet the qualifications before establishing a final list of candidates.

The Election Ordinance also mandates a nomination deadline. Article III, Section 1(b) of the Election Ordinance states in pertinent part:

Nominations shall be closed thirty (30) days before the general election at 5:00 p.m.

In light of the foregoing, the Election Board is unable to include your name as candidate for a seat on the Tribal Council; therefore, your name will not appear on the ballot in the 2016 General Election on June 4, 2016.

Because of my past experience in what I was, an educator, I would like to share with you the following message:

Control Your Inputs

Your mind is your ultimate personal computer. Like your laptop at home, sometimes you might forget to turn on your mental virus protection program allowing negative thoughts to invade your mind - without even realizing it. So, the computer adage "Garbage in, garbage out" as it applies to your mind should really be "Garbage in, garbage stays."

Your mind never sleeps. You can't pull a "fast one" on it. Whatever your mind hears from others, and especially from you, it records and stores.

The mind doesn't discriminate between input that is good for you or harmful to you - it collects all input. If you hear something often enough, you will tend to believe it and act upon it. Your mind can be your greatest ally or worst enemy. Seek positive inputs and you will improve your chances of producing positive outputs.

We draw into our lives that which we constantly think about – good or bad. If you are obsessing about what your boss will do if you make a mistake, then guess what's likely to happen? If you are always thinking about why you can't seem to get a break, or when the next shoe will drop in your relationship, or what will happen if you can't afford to pay for your car repairs or why you don't get as much recognition as your colleague, then you are programming your mind (and those around you) to turn these thoughts into your reality. Negative thoughts are landmines along the pathway to being your best.

Consider three common influences that can program us daily. They have the potential for a positive or negative impact on our thoughts and, ultimately, our results.

Television - Studies show that the subconscious mind is most receptive five minutes before we doze off at night, a common time for watching the news. Unfortunately, much of the news today shows the worst side of people and the world. When I was a kid my mom used to say, "Boy oh boy, we can watch the six o'clock news and not eat or watch the 11 o'clock news and not sleep." Mom's words still apply today. So, when you hear a news story, remind yourself that it's considered news because it is unusual. Doing so will help you balance potentially negative input with more uplifting thoughts.

So how can we remain well-informed and maintain a positive outlook? Monitor what you watch. More recently, my mom said, "I have 600 T.V. channels and nothing to watch!" An exaggeration of course, but if we choose programs that are more educational, artistic, spiritual or sports and comedy oriented, we will stimulate positive thoughts. Our thoughts today form our results tomorrow.

Newspapers – Many people, particularly in the business world, start their day with the newspaper. Whether it's a glimpse at the headlines or a front to back reading, there is plenty of positive and negative news to read. Before you dive into the daily newspaper or on-line news portal, take a quick inventory of all the things you have to be grateful for. Additionally, make it a habit to finish your reading with an inspiring story so your mind is primed for a positive day.

Other people – Make the choice to surround yourself with people who offer positive inputs. There will always be negative people and perspectives. Since we cannot hide from them, we must learn to filter out negative input to minimize "garbage" in our thoughts. The best strategy is to make a conscious effort to get to know and spend time with people who have a positive outlook.

These three sources of input have the potential for a positive or negative impact on your attitude, and ultimately, your results.

I would like to thank you for your votes for my re-election for the Chairwoman of the Hualapai tribe. My commitment to be a strong outspoken leader for the tribe is my mission and goal. Through this administration we have solved many issues especially those big legal battles that I was presented with when I was elected in 2012. These battles were not easy for any of us but we stood our ground and had significant victories. I believe these were the big issues that the people wanted me to address when you put me in this office.

During my term we have maintained employment at the tribe as well as GCW. There are always jobs posted for many positions within the tribe. It is unfortunate that more tribal members do not want to work so we must hire non-members to do the job and I know this makes many upset. If you want to work fill out the applications and if hired come to work every day.

The Hualapai Tribal Council decided to sell the Truckee property with the best intentions for the tribe. It was never my thought to violate the Hualapai Constitution. Since, the tribe had received the property as a gift and we had never been able to use it due to the zoning and would not be able to put anything there that would benefit the tribe so I thought we could at least get something for it instead of just continue to pay taxes on it. I know that we have sent delegations up to Truckee city council to ask about rezoning but they were not agreeable. So when I voted to sell the property it was for the best interest of the tribe.

On the night of May 3, 2016 the tribal council rescinded the motion to sell Truckee land. We heard the voices of many people that night from the general public regarding the Truckee land issue. There was an injunction filed by 7 tribal members previous to our general meeting on May 3rd. We appeared in court on May 23rd and the case was dismissed. (Please see court order attached.)

It is important to know that this council has moved on many important legal matters and have progressed for the hope and future of the tribe. We have many more battles to fight for our water and utilities that will ensure that we have these resources for the future benefit of our people. We have the support of the congressional people who see our needs and want to help. We have many obstacles that we must work through and I believe that we can do it with hard work, positive thinking and communication.



VOTE FOR RON QUASULA, SR.

I am running for Hualapai Tribal Council Vice-Chairperson. I believe my 18 years experience as a tribal council member prepares me well to serve as Vice-Chairperson. I have lived on the Hualapai Reservation all of my adult life. My employment background has been in protecting the tribe's lands and providing public safety in fire and emergency response services.

Tribal Council members are required to adhere to our Constitution, Tribal Council Code of Ethics, Tribal Council Oath of Office and the Personnel Policies and Procedures Manual. Many times these guiding documents have been violated or ignored. For example, on April 4, 2016, the tribal council voted to sell the tribes 202 acres of land in Truckee, California. Another Council member including myself voted NO, on the vote to sell the land.

The biggest complaint I hear from the tribal members is that the people are not told what the tribal council is doing. Members have an absolute right to access and read tribal council meeting minutes and resolutions. The annual tribal government operating budget should be available to the members to see how much the council is spending and for what purpose. The way it works now is that every few months some outdated council meetings are printed in the Gamyu. Every member should have timely access to tribal council business either through the tribal government website or mail. Members have a right to ask questions and provide their input!

Another complaint is there are too many closed tribal council meetings! There is little more degrading than when tribal members are kicked out of tribal council meetings without some explanation. It gives the impression only the tribal council is smart enough or privileged to know what's going on even though it's the people who voted us into office. I understand that occasionally executive sessions are necessary like when dealing with employee personnel issues or issues that could negatively impact the tribe, especially business involving our corporations.

The third complaint I hear is from Hualapai members who do not live on the reservation. Nearly half of our members live off the reservation. Most cannot regularly attend council meetings or community meetings. They say the only time they hear from the council is when we want votes. I do not have all the answers. Tribal members, no matter where they live should tell the council what's important to them – education, health care, transportation, recreation, housing, criminal justice, public safety, electricity & water development, etc. Younger tribal members need to get involved. Young people are our future!

Tribal members must come together not just for today but the future. Our children, grand children and beyond deserve better.

Let us not focus on what we cannot do but let us focus on what we can do!

I HAVE LIVED ON THE HUALAPAI RESERVATION ALL OF MY LIFE—AND YOU ALL KNOW ME. I GRADUATED FROM WOODLAKE UNION HIGH SCHOOL IN WOODLAKE, CA. I THEN ATTENDED JUNIOR COLLEGE AT COLLEGE OF THE SEQUOIAS IN VISALIA, CA AND YAVAPAI COLLEGE IN PRESCOTT, AZ. IN THE EARLY 1990s, I SERVED ON THE TRIBAL COUNCIL. I HAVE WORKED ALL MY ADULT LIFE INCLUDING FOR THE TRIBE'S NATURAL RESOURCES DEPARTMENT FOR THE LAST 20 YEARS. MY PRIORITIES & GOALS HAVE NOT CHANGED ALL THESE YEARS: I BELIEVE WE MUST WORK TOGETHER AND KEEP POSITIVE, I STRONGLY BELIEVE THAT EVERY TRIBAL MEMBER SHOULD BE TREATED EQUALLY, AND EVERY TRIBAL MEMBER SHOULD BE AFFORDED THE SAME OPPORTUNITIES TO SUCCEED. WE ARE EQUAL. MY PLATFORM IS SIMPLE:

- I WANT TO ENSURE THE HUALAPAI TRIBAL CONSTITUTION IS FOLLOWED, AND THE CIVIL RIGHTS OF TRIBAL MEMBERS MUST NEVER BE VIOLATED.
- I WANT TO IMPROVE THE EDUCATION OPPORTUNITIES FOR OUR YOUTH BY ENSURING THAT THEY HAVE ACCESS TO THE RESOURCES THEY NEED TO BE SUCCESSFUL IN SCHOOL.
- I WANT TO DEVELOP A BETTER PLAN FOR ANNUAL PER CAPITA DISPERSMENT FOR ALL TRIBAL MEMBERS, ESPECIALLY FOR THE ELDERLY AND THE YOUNG PEOPLE.
- I WANT THE ENTIRE TRIBE TO VISIT THE ISSUE OF THE CURRENT BLOOD QUANTUM REQUIREMENT FOR ENROLLMENT. FOR MANY REASONS OUR OVERALL BLOOD IS THINNING OUT. WE CAN'T IGNORE IT OTHERWISE OUR TRIBE WILL BEGIN TO FADE AWAY.
- I WANT TO REVIEW EACH TRIBAL GOVERNMENT PROGRAM TO SEE IF THEY ARE WORKING FOR THE PEOPLE. THESE ARE PROGRAMS FOR THE PEOPLE—NOT SIMPLY TO KEEP PEOPLE EMPLOYED. IF WE CAN IMPROVE PERFORMANCE AND PRODUCTION, I'M ALL FOR IT.
- COUNCIL POSITIONS SHOULD BE PAID POSITIONS/NOT GETTING THE MEETING STIPENDS
- LASTLY, OUR TRIBAL COUNCIL MUST PUT THE PEOPLE FIRST-NOT THEMSELVES. COUNCIL MEMBERS
 MUST SERVE THE PEOPLE. I WILL DEFINTELY INVOLVE THE MEMBERSHIP. THE BEST WAY TO DO THAT IS
 TO KEEP THE PEOPLE INFORMED, INCLUDING DEVELOPING AND DISTRIBUTING AN ANNUAL HUALAPAI
 FINANCIAL REPORT AND POSTING ALL TRIBAL COUNCIL MEETING MINUTES ON OUR TRIBAL WEBSITE.



We are thrilled that voters have spoken and confirmed K-12 education remains a top priority in Arizona.

THE IMPACT TO SCHOOLS AND STUDENTS

All Arizona public schools will get an adjustment for this current year in June of 2016 to use immediately to retain teachers and support student learning. Their vote has settled a seven-year legal battle that our public schools have been waging to receive the annual inflation funding that is guaranteed them by law.

As a result of a successful passage, more than half-a-million Arizona public school students in kindergarten through seventh grade will finally have the opportunity to learn in a classroom that was funded in the manner voters intended when they passed Prop. 301 in 2000.

Next Steps to Address Arizona's K-12 Funding Issues

We are relieved that the dark cloud placed over schools since 2008 has been removed, and now it's time to focus on fully funding classrooms. With the passage of Prop. 123, the focus now must shift to creating a long-term plan to better meet the needs of K-12 students.

Our next steps include:

- Work collaboratively with leaders in business, education, government and the nonprofit sectors to continue to keep education front and center in the debate for Arizona's future.
- Renew and update the funding elements in Prop 301, which generates more than \$600 million annually for educa-

tion each year and expires in 2021.

- Address the capital funding needs of our public schools, which have had to defer repairs and improvements for far
- Advocate for responsible use of the state surplus dollars, part of which could be used to restore funding cuts from previous years.
- Restoration of state funded Full Day Kindergarten, an unfortunate victim of the Recession-era cuts.
- Continue to educate state leaders on the need for policy changes to address current-year funding in the coming
- Address the collapse of the state funding system for the maintenance and building of school facilities to ensure that all students are in schools conducive to learning consistent with our constitution.

We continue to advocate for a collaborative effort from state leaders to fully fund education, and implement the changes we need in public education to ensure that students can succeed in Arizona.





Jo Gamyuje, Today I am having a difficult time concentrating but I want to write this letter as times are changing personally for me at these very moments, and for our people upon the election next week. While I cannot go into the details of my own situation other than it has shaken my soul and spirit to the core, and if I were any weaker it could have taken me. In short, a person who had great meaning to me for thirty years turned out not to be the person I thought I knew. The person I knew long ago apparently died and another took the shape and form. It is like waking up one morning and a very important person to you is no longer there; a child, a partner, a parent, a grandparent or best friend; gone and/or different. I led my life thinking that our lives would be shared somehow until our deaths and while I don't have children this person's children were most special and always in my thoughts. I am not sure what happened exactly to push such a horrible change of circumstances. I did all I could to be a good friend and uncle or grandpa. I will be sadder than normal because of this and I suspect it will tear at what's left of my heart until the moment I draw my last breadth.

This kind of change for a person, a human being, is a bad thing, is devastating and destructive. I guess the comparison for a people, a nation, or a tribe is like being in a war and in the end losing, then absorbed into another group of people, a forced change and existence. This should never happen to us, nor would I wish it upon any polity, though it happens and probably will again in the future. The opposite of such abrupt, drastic and demanded change of a group of people is done in different ways and I will mention two of them, of which we all have the opportunity to participate beginning on June 4 through the election of the majority of our legislature and after that for a long period of time; constitutional reform. We know elections as we have them every couple years and sometimes actual change is small, maybe a couple different people. Other times it is four or five new people, who bring a different way of thinking, different concerns that are generated by life experiences. Personalities also can dictate the nature of change instigated by new leaders and sometimes these personalities clash and makes thing more difficult than they should be. We all know how that goes and have seen it happen. I am hoping that this election the group of people who end up as our leaders can work together in a good way for the benefit of all of us. I as Chief Justice, given I am kept on the Court and my own situations do not lead me astray and/or away pledge my support and cooperation, my good hopes and thoughts, I hope they accept my good will and support, as it hasn't always been accepted by a few leaders in the past.

The second way for change, constitutional reform, of which I and others have been selected to facilitate for the people; is a much longer and time consuming endeavor. It will require lots of talking and listening and thinking and writing by all of US. It should also be put into the Hualapai language so that future Hualapai generations can share in the culture and past that our language preserves. I realize, however, and have said before that because Hualapai dialects can be different and things expressed differently, we may have some good arguments or I should say healthy debates about how exactly to translate English into Hualapai. I am hoping that many of you participate, the radio station carries all meetings, and that everyone be able to express themselves throughout the whole process. I look forward to this work and seeing a lot of you there. Tis work will help me keep busy and not thinking sad and sorrowful thoughts of the regretful things in life,

which I need now more than ever. Ma, Haink Wayo: hiyu!

My fellow tribal members,

You should vote for someone who is honest. Someone who will not hire their family/cousins, give their family/cousins loans or a house. It is ok if a candidate does not know all the issues because they can learn. We need honest people to make decisions in <u>our</u> best interest.

We are one tribe, we are all equal and the one thing that irritates everyone is favoritism. We all hear about it, we know it happens and it makes us mad because it is not fair. We need council members who will be fair and honest in every decision, in every action.

I was on tribal council for ten years and we had tribal members ask for loans, ask for jobs, ask for houses, etc. Some tribal members asked for money to go to conferences, visit loved ones who were sick, to move to another house or apartment, etc.

This life is hard. We will all encounter difficult times and we may need a helping hand at one time or another. The problem occurs when some tribal members get more than the rest of us.

One time we voted to give a tribal member around \$4,000 to pay her bills but we denied the next tribal member who made a similar request. This was in 2010 or 2011 so I might be mistaken on the dollar amount.

We have tribal members who save their money, pay their bills, buy their own food, etc. They live within the money they make. We have tribal members who <u>never</u> ask for a loan. My problem is that some tribal members ask every month or every year, like clockwork and they get more than the rest of us.

On one occasion the total amount of tribal loans went over \$50,000 so we stopped giving out loans. It was our FELLOW tribal members who did not pay back and in this instance the tribal council forgave them. I was there, I voted to forgive these loans because there was little chance the loan would get paid (in some cases the tribal member had a loan and he/she passed away).

Tribal Council should always report who gets a loan and why. Who gets a house and why. Don't tell us after the fact. Tell us before the favor is given.

Again, we want council members who will be fair to everyone. Vote for someone who is honest and will be fair to all tribal members.
