**Governor's Office On Tribal Relations
Organizer of 25th Annual Indian Nations
and Tribes Legislative Day**

Formerly known as the Commission of Indian Affairs, The Governor's Office on Tribal Relations is established by the legislature pursuant to A.R.S. § 41-2051(A), to assist state agencies in implementing tribal consultation and outreach activities.

In accordance with A.R.S. § 41-2053(A), The governor's office on tribal relations, in cooperation with representatives from this state's Indian nations, shall annually facilitate an Indian nations and tribes legislative day on Wednesday of the first week of each regular legislative session.



The office shall coordinate the planning and preparation of the legislative day with the president of the senate, the speaker of the house of representatives and legislators who are native American. The senate shall host the legislative day in odd-numbered years and the house of representatives shall host the legislative day in even-numbered years. The hosting chamber shall hold a joint session of the legislature.

The office shall invite the legislature and other elected officials to pay tribute to the history and culture of the American Indian peoples and their contributions to the prosperity and cultural diversity of the United States.

The office shall schedule activities and discussions between state and Indian nations and tribal leaders on issues in which the state and Indian nations and tribes share a common interest or jurisdiction.

B. Indian nations and tribes legislative day is not a legal holiday.

Election Types Key:

Jurisdictional- Refers to off-season elections where Jurisdictions like Cities, Towns, School Districts, and Special Districts may choose to hold their elections. Stay informed about whether or not your local district is having an election by visiting our website Maricopa.Vote.

Presidential Preference- Ballots are political party specific. Voters registered without a political party by the Voter Registration Deadline cannot participate in this election. The only candidates in this election are the Arizona qualified Presidential Primary candidates.

Primary- In August of even years partisan candidates run on this ballot to represent their party for the General Election. Ballots are party specific and voters without a political party must tell MCRO which ballot they would like to receive. See page 5 for more details.

General- In November of even years the winners of the Primary election, judges, nonpartisan candidates, and propositions appear on this ballot. Ballots are precinct specific, not party specific.

Fine Art Museum of Sedona Presented Tea and Turquoise • Carrie Cannon

The Fine Art Museum of Sedona for its Tea and Turquoise explored the natural beauty and history of this exquisite gemstone on Sunday, December 8, 2019 2-4:30 p.m., at the Heartline Café, 1610 Hwy. 89A for a Southwest inspired tea.

The “Tea” featured Trailhead Teas; and southwest influenced teacakes and sandwiches created by Heartline Café. Speaker Carrie Cannon, a member of the Kiowa tribe of Oklahoma, will discuss the special significance of turquoise to individual tribes, as well as distinctive cultural styles, and the mining of this wondrous stone. Cannon has a bachelor’s degree in wildlife biology and an master’s degree in resource management. She began working for the Hualapai Tribe of Peach Springs in 2005 where she created intergenerational teaching of ethnobotanical knowledge, to assure that it persists as a living practice and tradition.

Found on six continents across the world, turquoise forms in arid regions through the process of water seeping through rock and interacting with copper, aluminum, and iron deposits. In the Southwest, used decoratively for millennia, this iconic art form has a compelling story all its own.

What is the healing power of turquoise? It aids in the absorption of nutrients, enhances the immune system, stimulates the regeneration of tissue, and heals the whole body. It contains anti-inflammatory and detoxifying effects, and alleviates cramps and pain. Turquoise is said to possess many powers. It is considered a healing and protective stone that enhances courage in the wearer. It is also said to attract love, friendship, money and luck ... A proverb states, “Given by a loving hand it brings with it happiness and good fortune.”

What is the rarest turquoise? Lander Blue Spiderweb Turquoise is some of the rarest turquoise on earth and in high demand. Turquoise has a long standing tradition among Native cultures of the Southwest, holding special significance and profound meanings to specific individual tribes. Even before the more contemporary tradition of combining silver with turquoise, cultures throughout the southwest used turquoise in necklaces, earrings, mosaics, fetishes, medicine pouches, and made bracelets of basketry stems lacquered with piñon resin and inlaid turquoise. Found on six continents across the world, turquoise forms in arid regions through the process of water seeping through rock and interacting with copper, aluminum, and iron deposits. In the southwest, used decoratively for millennia, this iconic art form has a compelling story all its own. For the 11th lecture of our 2020 Thursday Lecture Series, Carrie Cannon explores a long tradition of distinctive cultural styles, history, and transition of this wondrous stone.

Carrie Cannon is a member of the Kiowa Tribe of Oklahoma and is also of Oglala Lakota descent. She has a B.S. in Wildlife Biology, and an M.S. in Resource Management. She began working for the Hualapai Tribe of Peach Springs, Arizona in 2005 where she began the creation of an intergenerational ethnobotany program for the Hualapai community. She is currently employed as an Ethnobotanist for the Hualapai Department of Cultural Resources. She administers a number of projects promoting the intergenerational teaching of Hualapai ethnobotanical knowledge working towards preservation and revitalization to ensure tribal ethnobotanical knowledge persists as a living practice and tradition.

CONSERVATION GROUPS APPLAUD SENATE LAUNCH OF GRAND CANYON PROTECTION BILL

WASHINGTON— Sen. Kyrsten Sinema (D-Ariz.) yesterday introduced the Grand Canyon Centennial Protection Act. The bill will make permanent a ban on new uranium mining on about 1 million acres of public land adjacent to Grand Canyon National Park. A companion bill has already passed the House with bipartisan support, following an effort led by tribal members and leaders, particularly the Havasupai Tribe with the support of the Hualapai, Hopi Tribe, Navajo Nation, National Congress of American Indians and Intertribal Council of Arizona. A broad coalition of business owners, local government leaders, conservation groups and others who oppose uranium mining in the Grand Canyon region also endorsed the House bill. Conservation groups issued the following statements in response to Sinema's bill:

"Thank you to Senator Sinema for the introduction of legislation to protect one of the country's greatest treasures, the Grand Canyon," said Laura Dent, executive director of Chispa Arizona. "This legislation ensures that our nation will protect and respect the sacred lands and watersheds surrounding the Canyon, the preservation of our state's rich cultural heritage, and the wellbeing of our communities. We thank the indigenous leaders that have protected and fought for the preservation of this region for generations, and we look forward to the Senate bill moving forward so that the protection of the Grand Canyon can become law." "Sen. Sinema understands that toxic uranium mining and the Trump administration pose tremendous threats to the Grand Canyon region," said Randi Spivak, public lands director at the Center for Biological Diversity. "Sinema's important bill respects the magnificence and fragility of this remarkable place. This bill will permanently protect the region, its wildlife and the indigenous communities and others who rely on its life-giving waters. Overwhelming bipartisan support should be a slam dunk."

"Senator Sinema's dedication to a priceless Arizona treasure — one that's inspired generations upon generations of people from across the globe — deserves our praise. Her legislation would help to protect the Grand Canyon area's air, water and soil and preserve biodiversity," said Blaine Miller-McFeeley, senior legislative representative for policy and legislation at Earthjustice. "It would strengthen protections for ancestral lands long occupied and held sacred by the first people to inhabit them. It would ensure that the next hundred years of Grand Canyon National Park are filled with the same recreational opportunities as the first hundred. We are proud to support her efforts." "There is no reality in which it is worthwhile to endanger the Grand Canyon, the lives and cultures of Indigenous communities, and millions of people and the economies that support them," said Amber Reimondo, energy program director for the Grand Canyon Trust. "For those reasons, the Grand Canyon region is, and forever will be, too precious to mine and today we are grateful to Senator Sinema for her leadership in advancing a permanent mining ban around the Grand Canyon."

"We applaud Senator Sinema for her leadership to protect the Grand Canyon, one of our country's greatest national treasures and the ancestral home to indigenous communities who have cherished and protected these sacred lands for generations and continue to rely on them for sustenance and safe drinking water," said Laura Forero, legislative representative for the League of Conservation Voters. "This bill is necessary to protect the communities, lands, waters, and ecosystems that have been impacted by harmful extractive pollution. We urge Senator McCally to protect tribal nations and their sacred places, and stop the further desecration of our public lands by supporting this bill."

"The National Parks Conservation Association applauds Senator Sinema for her leadership and support for advancing the call to permanently protect the Grand Canyon from uranium mining," said Kevin Dahl, senior Arizona program manager for the National Parks Conservation Association. "The iconic and enduring Grand Canyon is also home to vibrant and vital resources that we must support, for ours and future generations. Uranium mining threatens the entire water supply of the Havasupai people, whose homeland is in the Grand Canyon, and the limited underground sources that feeds the Canyon's important springs, seeps, and side creeks. Nearly identical legislation passed the House in a bipartisan vote that demonstrated overwhelming support, proving that Americans share a common goal in defending and preserving the Grand Canyon's fragile and limited water supply. The Senate now has the unique opportunity to create a lasting conservation legacy for this beloved national treasure and World Heritage Site by passing the Grand Canyon Centennial Protection Act."

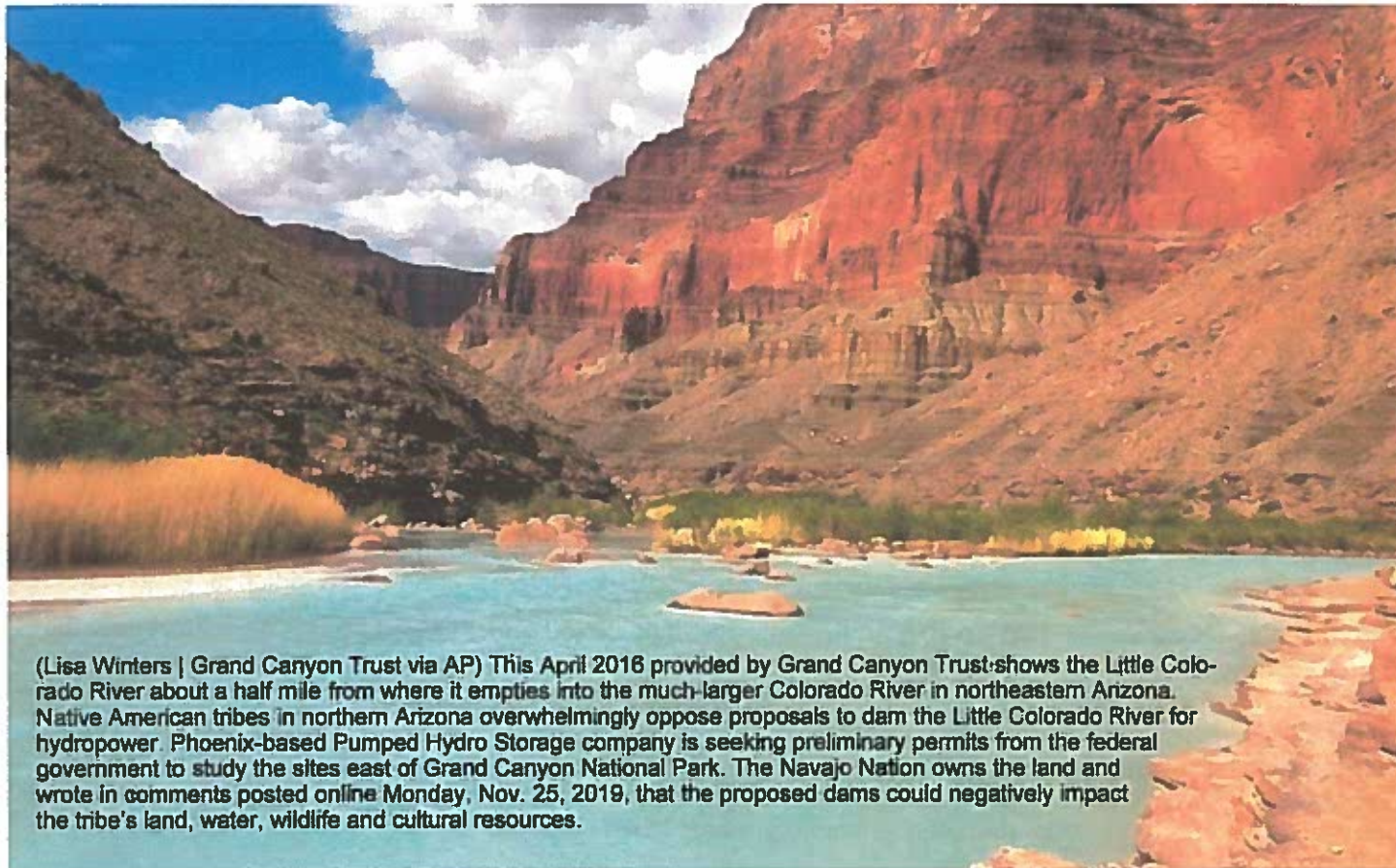
"This is a bold and important move by Senator Sinema," said Kabir Green, director of federal affairs for the Natural Resources Defense Council. "We cannot afford to leave the Grand Canyon — America's greatest monument — vulnerable to mining. This would protect a vast swath of lands—and all the biodiversity they foster and recreational opportunities they afford—from encroachment. In addition to preserving our lands, this safeguards our water and air, and does so in a way that respects tribal interests." "The Grand Canyon Centennial Protection Act is key to preventing more toxic pollution that has already harmed public, Navajo, Havasupai, and Hopi lands — there are more than 500 abandoned uranium mines on the Navajo Nation alone, contaminating water and harming the health of Diné people," said Sandy Bahr, chapter director for Sierra Club's Grand Canyon Chapter. "Introduction and passage of this important legislation is important to protecting the waters, wildlife and people who live and work in the Grand Canyon region." "We are thrilled that Senator Sinema has stepped up to lead on behalf of Arizonans and all who love the Grand Canyon, by introducing legislation to permanently protect this place from the dangers of uranium mining," said Mike Quigley, Arizona state director at The Wilderness Society. "There is enormous support in Arizona and across the country to conserve this treasured landscape. We urge Senator McCally and the rest of the Senate to support this bill."

Arizona Tribes Oppose Plan to Dam Colorado River Tributary

Native American tribes in northern Arizona overwhelmingly oppose proposals to dam the Little Colorado River for hydropower. Phoenix-based Pumped Hydro Storage company is seeking preliminary permits from the federal government to study the sites east of Grand Canyon National Park. The Navajo Nation owns the land and wrote in comments posted online Monday, Nov. 25, 2019, that the proposed dams could negatively impact the tribe's land, water, wildlife and cultural resources.

Flagstaff, Ariz. • Native American tribes, environmentalists, state and federal agencies, river rafters and others say they have significant concerns about proposals to dam a Colorado River tributary in northern Arizona for hydropower.

Phoenix-based Pumped Hydro Storage company is seeking preliminary permits from the Federal Energy Regulatory Commission to study sites on the Navajo Nation, east of Grand Canyon National Park. The company's manager, Steve Irwin, has touted the potential economic benefits of damming the Little Colorado River in four locations, including paved roads, tourism and jobs.

The Navajo Nation owns the land, and the projects won't move forward without the tribe's OK. The tribe wrote in comments posted online Monday that the dams could negatively impact its land, water, wildlife and cultural resources. Cameron, the Navajo community closest to the proposed projects, already has asked the Federal Energy Regulatory Commission to deny the permits.

The Hopi, Hualapai and Havasupai tribes also said they are concerned about possible impacts to sacred and historical sites and want to ensure the federal government keeps them in the loop on the proposals. "A project such as this would forever disturb a traditional cultural landscape that maintains historic and sacred value and that is part of the cultural identity of the Hualapai people and other neighboring tribes," Hualapai Chairman Damon Clarke and Peter Bungart, the tribe's historic preservation officer, wrote in their comments.

The Federal Energy Regulatory Commission has no hard deadline to act on the request for the preliminary permits. Construction would not start on the dams for at least a decade if they ultimately are licensed. The projects would create power by moving water between upper and lower reservoirs, known as pumped storage. Such projects are seeing renewed interest as a way to supplement the electric grid. Irwin said the Navajo Nation is an ideal location because of the steep canyon walls and the water source. But he said he is willing to tweak the proposals in response to comments. He also has said it's unlikely both proposed projects will be built.

"I'm sure it will change," he told the Arizona Daily Sun. "No battle plan survives the first day of battle." More than 100 comments were filed on each of the two proposals. People across the country urged the federal government to consider the impacts to recreation, an endangered fish, the Grand Canyon and the Colorado River downstream, the solitude of the region and water rights. The Little Colorado River is the subject of a long-running water rights case in Arizona.

The river flows intermittently and can carry heavy sediment during the spring runoff and monsoon season. It's also the primary spawning habitat for the endangered humpback chub in the lower Colorado River basin. Two-thirds of that habitat could be destroyed if the dams are built, the Interior Department wrote in its comments.

MEASURE AIMED AT PRESERVING NATIVE LANGUAGES CLEARS CONGRESS

ALBUQUERQUE, N.M. — Federal grant programs aimed at preserving indigenous languages would be extended for a few more years and expanded to allow more American Indian tribes to participate under legislation that has cleared its final congressional hurdle. The U.S. House approved the measure Monday, sending it to the president's desk. The Senate gave its approval earlier this year. The measure is named after Esther Martinez, a traditional storyteller and Tewa language advocate from northern New Mexico's Ohkay Owingeh Pueblo who died in 2006. Her family and members of the state's congressional delegation say reauthorization of the programs through 2024 would mark the federal government's commitment to keeping Alaska Native and American Indian languages alive.

The goal of the programs has been to prevent the languages that are still spoken today from going extinct over the next 50 to 100 years. Evaluations by the U.S. Health and Human Services Department show the programs have increased fluency for thousands of speakers and have resulted in the training of between 170 and 280 Native language teachers each year. "Esther Martinez was a champion for Native languages who spent her life teaching others and promoting the growth of indigenous languages and culture," said U.S. Rep. Ben Ray Lujan, a New Mexico Democrat. "With the passage of this bipartisan legislation, Congress has taken a major step to deliver results on this top priority for Native communities that are working to preserve their languages."

Dozens of tribes from Alaska to Hawaii, Arizona, New Mexico, Montana and Massachusetts have benefited from the programs over the years. Currently, there are over 40 active grants totaling more than \$11 million that are being used for language preservation and immersion efforts. Martinez's own pueblo was awarded a grant earlier this year after seeing a decline in fluent Tewa speakers and the increase of English as the primary language in the homes of tribal members.

Ohkay Owingeh also has reported a shortage of resources in the community, such as language classes, youth programs and Tewa teachers. With its grant, the pueblo plans to establish a summer program to increase fluency among students between the ages of 12 and 16. The effort also calls for certifying more Tewa teachers and forming partnerships with schools. In Montana, the Crow Language Consortium has been using its funding to increase community access to learning materials such as digital and mobile app dictionaries. The Hualapai Tribe in Arizona received a grant earlier this year to establish a "language nest" to provide services for children enrolled in Head Start and for their parents or guardians.

The legislation has the support of the Congressional Native American Caucus, the National Congress of American Indians and the National Indian Education Association. U.S. Rep. Deb Haaland, a New Mexico Democrat and Laguna Pueblo member who co-chairs the Congressional Native American Caucus, said programs that support language preservation are underfunded and often lack funding altogether.

E. Paul Torres, chairman of the All Pueblo Council of Governors in New Mexico, said the legislation is key to providing more support for immersion programs. That, he said, "will help ensure the cultural practices vital to the traditional well-being of our indigenous nations stays alive with our stories, songs and prayers being passed on for future generations." National Indian Education Association President Marita Hinds said the legislation represents a milestone in expanding tribal flexibility to develop and implement Native language programs to serve the unique academic and cultural needs of Native students. "Native language preservation is central to advancing culturally responsive education. Our children thrive inside and outside of the classroom when learning their own language," Hinds said.
