Subj: Administrative Leave due to Coronavirus (COVID-19) Cont., Directors & Program Managers Return to Work, and Potential Furlough

(3) Tribal Council Meeting, DTD 4/29/2020

1. **Leave Period:** As per Hualapai Tribal Council Resolution No. 19-2020, 23-2020 and Tribal Administration; non-essential Tribal Employees will be on continued **Paid Administrative Leave from 5/3/2020 up through 5/9/2020.** This period covers 7 calendar days. However, the paid number of days will coincide with the number of days that would have been normally worked had this leave period not been granted. This period of administrative leave is an effort to limit the potential spread of and exposure to the Coronavirus (COVID-19).

2. **Paid Administrative Leave is limited to non-essential personnel only:** It is up to each Department Director to determine exactly who in the department is considered non-essential. It is the intent of the resolution to limit employees coming in to the normal work place to the maximum extent possible.

3. **Directors and Program Managers:** As per Tribal Council Meeting held 4/29/2020 and Hualapai ICT recommendations, Directors and Program Managers are to return to work as normal starting **5/4/2020.** Once at work you will receive further guidance on how develop a "Return to Work" plan for the rest of your employees.

4. **Working from home & Recalled while on Admin Leave:** During this period any employee who is on paid administrative leave is subject to working from home and subject to being called to come in to the workplace on a limited basis. **Employees that refuse to comply with a Director's request to work face potential disciplinary measures.** It is up to the Director to determine whether an employee can work from home or not. Directors must work with employees to come up with schedules etc. to manage the department as effectively as possible.

Schedules do not need to be sent to HR for approval. Ensure that actions and plans fall in line with limiting the potential spread of and exposure to the Coronavirus (COVID-19).

5. **Travel:** It is the intent of the Paid Administrative Leave period and the resolution to limit the potential spread of and exposure to the Coronavirus (COVID-19). During this period, any personal travel that is beyond a reasonable distance which goes against the intent of the resolution may be charged as personal leave and may be accompanied by disciplinary measures.

6. **Pay Period 10:** If an employee has worked or will work in the normal setting for any amount of time, a signed timesheet is required for that employee showing their hours worked and the amount of Admin Leave taken. Turn those timesheets in as normally scheduled to the payroll office. If you have any questions regarding how to fill out said timesheets for those employees, please refer those questions to the payroll office as well. Timesheets are not required if the employee was on Admin Leave only during this period of time.

7. **Potential Furloughs:** If Furloughs are required they will not start until the beginning of Pay Period 11, 5/10/2020. If you are an employee that will be affected by a Furlough you can expect to receive a Personal Furlough Letter from HR and to be notified in advance of the Furlough.

APRIL 13, 2020 — The 2020 Census is underway and more households across America are responding every day. Over 70 million households have responded to date, representing over 48% of all households in America. In light of the COVID-19 outbreak, the U.S. Census Bureau is adjusting 2020 Census operations in order to:

- Protect the health and safety of the American public and Census Bureau employees.
- Implement guidance from federal, state and local authorities.
- Ensure a complete and accurate count of all communities.

The Census Bureau temporarily suspended 2020 Census field data collection activities in March. Steps are already being taken to reactivate field offices beginning June 1, 2020, in preparation for the resumption of field data collection operations as quickly as possible following June 1.

In-person activities, including all interaction with the public, enumeration, office work and processing activities, will incorporate the most current guidance to promote the health and safety of staff and the public. This will include recommended personal protective equipment (PPE) and social distancing practices.

Once 2020 Census data collection is complete, the Census Bureau begins a lengthy, thorough and scientifically rigorous process to produce the apportionment counts, redistricting information and other statistical data products that help guide hundreds of billions of dollars in public and private sector spending per year.

In order to ensure the completeness and accuracy of the 2020 Census, the Census Bureau is seeking statutory relief from Congress of 120 additional calendar days to deliver final apportionment counts.

Under this plan, the Census Bureau would extend the window for field data collection and self-response to October 31, 2020, which will allow for apportionment counts to be delivered to the President by April 30, 2021, and redistricting data to be delivered to the states no later than July 31, 2021.

MEC extends its temporary suspension of residential disconnects until May 15, 2020

BULLHEAD CITY, Ariz. – MEC has extended the time for temporarily suspending disconnects for residential service locations until May 15, 2020, due to the COVID-19 situation.

“If you are facing financial difficulties and are unable to make your MEC electric bill payment, we encourage members to call MEC,” said Rick Campos, MEC chief operating officer. “Our member services team will work with members to arrange a payment plan that will help get them through this emergency.”

“Call us first, before coming to the office. We want to promote staying healthy by helping you stay-at-home, and you’ll be helping us limit in-person contact for our employees.”

MEC’s member service office can be reached at (928) 763-1100.

The temporary disconnect suspension is not a bill waiver. Members are encouraged to pay at least a portion of their electric bill, when possible, to help avoid a large multi-month balance in the future.

INCIDENT MANAGEMENT



A Public Reminder!

If you are traveling to Kingman, Bullhead or Lake Havasu or any hot spot area which is considered to have an increased number of positive COVID19 cases, we ask that you follow these guidelines to prevent the spread of COVID19.

- Wash hands often with soap and water for at least 20 seconds or use hand sanitizer;
- Avoid touching your eyes, nose and mouth with unwashed hands;
- Avoid people who are sick;
- Clean and disinfect objects and surfaces;
- WEAR a face masks when around others and or sick;
- WEAR any type of gloves when going into a public area.



Remember, The “Stay At Home Order” is in effect 24 hours a day, 7 days a week. You must stay within the boundary of your property and limit direct communication with others. The only exceptions to the stay home order, during the hours not covered by curfew are:

- Medical Care
- Food
- Financial Obligations

INCIDENT MANAGEMENT

CLARITY ON THE STAY AT HOME ORDER PER RESOLUTION 29-2020

ATTENTION: The Stay at Home Order is in effect 24 hours a day.

The Stay at Home order states: *"Stay within the boundary of your property and limit direct communication with the public to avoid potential contact with COVID-19."*

Exceptions to the Order;

- Medical Care
- Food
- Financial obligations
- Essential employees
- Tribal officials

It is important to understand the reasoning behind this order. The Stay at Home Order is to prevent exposure to others and to protect you and your family. If the Stay at Home Order is not followed, you put the community at risk of virus spread.

CURFEW HOURS of 8:00 PM to 5:00 AM are meant for all members to remain indoors between those hours to prevent the spread of COVID-19.

Offense 1	Written/Verbal
Offense 2	Shall be fined \$300 to be deducted from pay roll or per cap and non-members removed from the Hualapai reservation for 1-year
Offense 3	Shall be imprisoned for 30-days and an additional \$300 fine shall be imposed, deducted from payroll or per cap.

Isolation: separates sick people with a contagious disease from people who are not sick.

Quarantine: separates and restricts the movement of people who were exposed to a contagious disease to see if they become sick.

For those who are under quarantine and violate the curfew the offenses will increase.

Offense 1	\$300 fine deducted from payroll or per cap and non-members removed from the Hualapai Reservation for 1-year
Offense 2	30-days of imprisonment and an additional \$300 fine deducted from payroll or Hualapai Distribution
Offense 3	30-days imprisonment and one (1) year loss of Hualapai Distribution

Isolation and quarantine help protect the public by preventing exposure to people who have or may have a contagious disease. Let's work together to protect our families. Be safe Hualapai.

Health Officials confirm there are thirteen (13) positive COVID19 cases among Tribal members residing in the Peach Springs community. Three (3) remain hospitalized and the others remain under self-isolation, along with other community members identified as having contact with them. A Tribal member residing in the Kingman area has tested positive and is hospitalized. There are now 116 positive confirmed cases in Mohave County with 29 in the Lake Havasu City area, including the three deaths, 76 in Kingman, with a total of six deaths and 11 in Bullhead City and one death.

We encourage the community to remain calm, but to take this matter seriously. Be aware these positive cases may be the result of "community spread." This means people have been infected in a given area, but some do not know how or where they became infected. It is important we do not relax but continue to follow all CDC guidelines for personal hygiene, social distancing and sanitizing our homes to prevent further spread of COVID19.

COVID19 spreads through mucus droplets through coughs and sneezes. Symptoms appear 2 to 14 days after exposure and include high fever, dry cough and difficulty breathing.

At this time, the CDC says the best way to prevent the spread of COVID 19 is to:

- Wash hands often with soap and water for at least 20 seconds or use hand sanitizer;
- Avoid touching your eyes, nose and mouth with unwashed hands;
- Avoid people who are sick;
- Clean and disinfect objects and surfaces that may have come in contact with the COVID 19 virus;
- Wear face masks if you are or may be sick when around others.

To further help prevent the spread of COVID 19 in our community, Hualapai Tribal Council has enacted Resolution 27-2020, which includes a Stay at Home Order and a community-wide curfew. To clarify these for the community members:

The stay at home order is in effect 24 hours a day, 7 days a week. You must stay within the boundary of your property and limit direct communication with others. The only exceptions to the stay at home order, during the hours not covered by curfew are:

- Medical care
- Food
- Financial obligations
- Cattle association members and Tribal Contractors displaying authorization Placards from the Tribal Game and Fish Dept.,

- Essential employees
- Tribal officials

The stay at home order extends to being in vehicles within the community for reasons other than allowed exceptions.

The curfew is in place from 8:00p.m. until 5:00a.m. During the curfew you must stay indoors. The only exceptions to curfew are:

- medical care,
- essential employees.

Penalties are in place for those who violate the stay at home order and curfew:

1st offense: written warning

2nd offense: \$300.00 fine to be deducted from payroll or Tribal distributions.

Non-Tribal members will be removed from the Reservation for one year

3rd offense: 30 days' imprisonment and an additional \$300.00 fine to be deducted from payroll or Tribal distribution

At this time the Hualapai Tribe is not quarantined or isolated. The Tribe is on a Stay at Home Order, with some individual members now being quarantined. It is important to understand the difference between isolation and quarantine. Isolation separates 3 people who are well, from those who are, or who might be sick, in order to keep them well. Quarantine separates those people who are, or who are suspected to be sick, (due to contact with sick people,) to a confined location, and restricts their movement to prevent them from getting other people sick.

Those who are under quarantine **will** be punished for violating the quarantine:

1st offense: \$300.00 fine to be deducted from payroll or Tribal distribution. Non-tribal members will be removed from the Reservation for a year.

2nd offense: 30 days' imprisonment and an additional \$300.00 fine to be deducted from payroll or Tribal distribution.

3rd offense: 30 days' imprisonment and the loss of one year of Tribal distribution

These penalties are being imposed to ensure COVID 19 is taken seriously and to protect the health of the Hualapai Community.

Also, to protect the community from the spread of the coronavirus, Council has directed the Hualapai Police Department to have three traffic control points throughout the community. This will begin Friday April 17, 2020 at 6:00p.m. and continue until further notice. Security is in place to assist with traffic control.

Remember, we must all work together to keep Peach Springs safe. If you see someone violating the Stay at Home Order or Curfew or suspect someone is violating quarantine, PLEASE say something. Call Dispatch at 769-2205. If you are concerned you may be sick or suspect someone else is suspect or have had contact with a community member positive with COVID19, please say something. Seek care from IHS or EMS if needed!

***2 Deaths from Previous Cases &
11 New Positive Cases in County
Total Now 116
10 Total Deaths in County***

MOHAVE COUNTY, AZ (April 29 2020) The Mohave County Health Department (MCDPH) Nursing staff was notified late this afternoon of eleven new COVID-19 positive cases, as well as two COVID-19 related deaths in Mohave County. Both of the deaths were in previously identified confirmed cases. All of these cases, including the two newly reported deaths are in the Kingman service area.

The two deceased are 65+ and linked to another confirmed case. Besides these two, there are another 8 deaths in the county.

Four of the 11 new positive cases are hospitalized. One is in the 20-44 age range and is not linked to another confirmed case and is not travel-related; one is in the 55-64 age range and is linked to another case; and two of those are 65+ with one linked to another case and the other is not.

Of the remaining seven, one is in the 20-44 year age range, in isolation and recovering at home and is not linked to another case or travel-related; one is in the 45-54 age range, is in isolation and recovering at home, and is not linked to another confirmed case/not travel-related; two are in the 55-64 year age range, and both are in isolation and recovering at home and is linked to another confirmed case; the final three are all 65+, in isolation and recovering at home, and linked to another confirmed case.

There are now 29 positive confirmed cases in the Lake Havasu City area, including three deaths, 76 in Kingman, with a total of six deaths there (including the two latest) and 11 in Bullhead City, including one death. There are a total of 10 deaths in the county from the disease.

Please keep in mind that the best ways to prevent the spread of COVID-19 are:

To keep your Social Distancing – At least 6 Feet apart! Stay at home if at all possible.

- o Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, use an alcohol-based hand sanitizer.

- o Avoid touching your eyes, nose, and mouth with unwashed hands.
- o Avoid close contact with people who are sick.
- o Stay home when you are sick, or if you are a not an essential employee.
- o Cover your cough or sneeze with a tissue, then immediately throw the tissue in the trash.
- o Clean and disinfect frequently touched objects and surfaces.

COVID-19 spreads through the air when an infected person coughs or sneezes. Symptoms are thought to appear within two to 14 days after exposure and consist of fever, cough, runny nose, and difficulty breathing. For people with mild illness, individuals are asked to stay home, drink plenty of fluids, and get rest. For people with more severe symptoms, such as shortness of breath, individuals are advised to seek healthcare, using telemedicine where available.

SECTION VII. POLICIES AND RULES APPLICABLE TO HOMEOWNERSHIP AND RENTAL PROGRAMS

A. USE OF HOME - PAGE 46

1. The Homebuyer/Tenant must use the home as his/her primary residence, and for occupancy by members of his/her household listed in the family composition.

B. UNLAWFUL ACTIVITIES

1. The Homebuyer or Tenant is responsible for all actions of residents, guests, and visitors of the home. Homebuyers, Tenants, household members, and their guests and visitors shall not engage in any unlawful activities including but not limited to bootlegging, alcohol or drug related activities, disorderly conduct, threatening or intimidation, or other activities which are hazardous to the health or safety of other Homebuyers or Tenants, or disturb other Homebuyers or Tenants in the quiet enjoyment of the premises.
2. No loud music is allowed on the premises.
3. Homebuyers, Tenants, guests and visitors shall not destroy, deface or damage any HHD property.
4. Homebuyers and Tenants shall report all unlawful and suspected criminal activities, including bootlegging and drug sales occurring in their neighborhoods to lawful authorities and to HHD no later than the next business day following the unlawful or suspected criminal activity. Homebuyers and Tenants should cooperate with law enforcement agencies and HHD in evicting such persons from their home and grounds.
5. No firearms shall be discharged in or around the housing premises.

C. DRUG & ALCOHOL-FREE HOUSING POLICY

The sale, use, possession, purchase, manufacture, or transfer of illegal drugs or other controlled substances or drug related paraphernalia on or off any HHD managed housing premises, by a Homebuyer/Tenant, any member of his/her family, or any guest or other person under Homebuyer's/Tenant's control, is a breach of the Homebuyer's/Tenant's obligations under his/her Lease Agreement/Rental Lease. A Homebuyer/Tenant must notify HHD of any federal, state or tribal drug conviction of any person residing in Homebuyer's/Tenant's unit no later than five (5) days after such conviction. Selling and consumption of alcohol in the homes is a breach of the Homebuyer's/Tenant's obligations under his/her Lease Agreement/Rental Lease. Any violation of this Section may subject a Homebuyer/Tenant to termination of his/her Lease Agreement/Rental Lease.

This is Juliana Nez a Hualapai Teen who gets it! COVID 19 is a bummer! It changed everything so fast? Suddenly there it is: no more going to school, no more hanging out with friends, and no more sports.

For Seniors wondering about prom, graduation and visit to college, summer job and proper farewells. I get it! Everything we are missing and losing just because of this new virus is not okay.

What is okay is to feel frustrated, sad, angry, anxious, lonely any feelings you are having about the coronavirus and how it impacts your life are real and are all okay.



As teens, is there anything we can do to make it better for us? Yes! We can.

- Keep a normal routine, wake up do your school work, exercise, have meals, have chill time and sleep,
- Set aside time for friends, just connect differently. We can't hang out in person, but we can still hang out on social media, video chat, blog, watch movies together!
- Help stay connected, we know about FaceTime, but maybe our parents and grandparents don't! We can teach them.

STEPS OF A CONTACT INVESTIGATION

Step #1—Start with the Source Case:

- Candie tested positive for COVID 19 on 3/28/20
- Candie will be put in isolation in a separate room away from family until she has tested negative two times

Step #2—Create an investigation circle:

- Find out who Candie has been in contact with two weeks prior to when she started to feel sick
- It is important for Candie to let the Public Health Workers know who she has been in contact with to prevent further spreading of the virus.

Step #3—Identify Contacts (household, close contacts, and high risk contacts)

- Household contacts are: people residing in the same household or overnight guests.
- Close contacts: people who have spent more than 30 minutes and who have had contact less than 6 feet.

Example: people riding in the same car, visiting your house and or having dinner or sharing beverages.

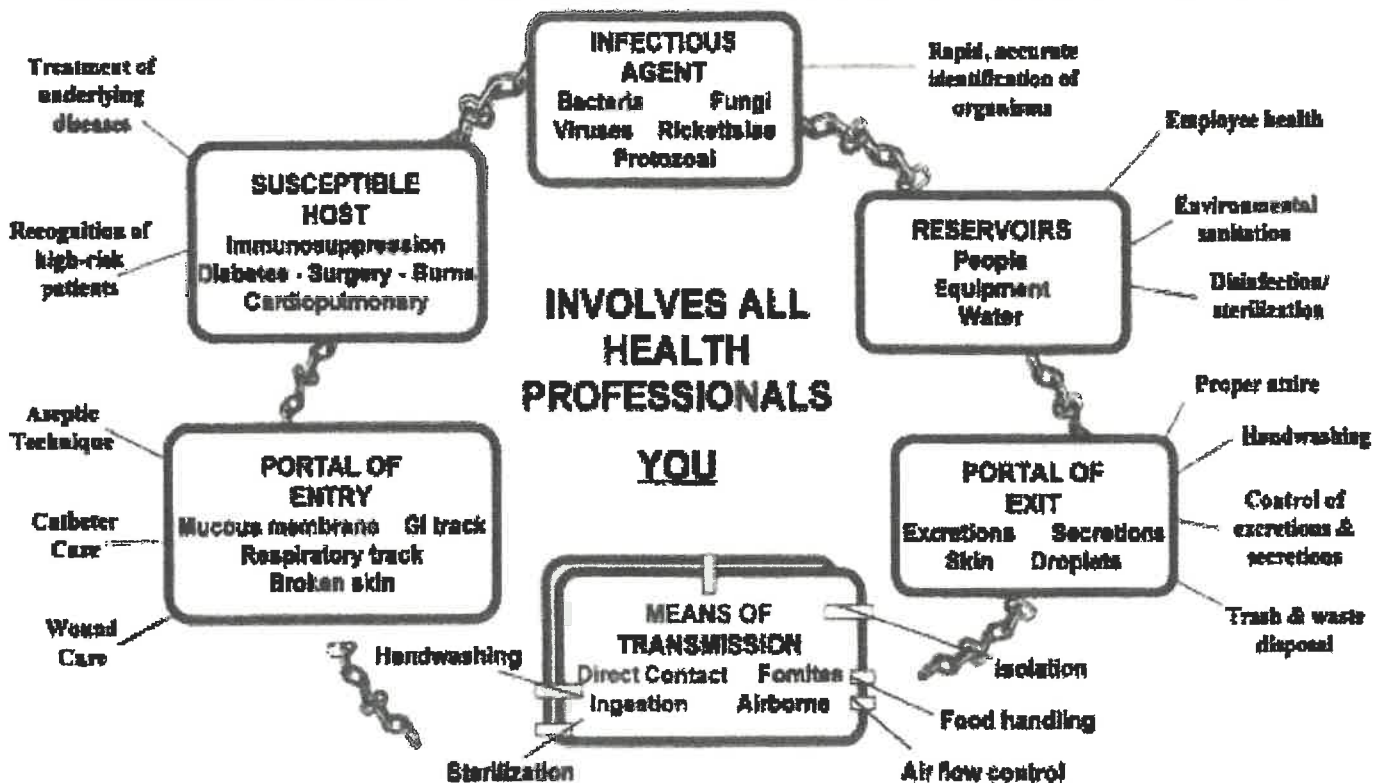
Step #4—Monitoring of Contacts: Public Health Nurse will contact the source case and all of the identified contacts. This information is kept confidential.

Step #5—RECOVERY: When the Source Case is asymptomatic (no sign or symptoms) for three days in a row they will be test. The source case must have two negative tests 24 hours apart.

- The household contacts will remain in home isolation for 14 days after the source case tests negative twice as long as they remain asymptomatic.
- Close contacts will remain in home isolation for 14 days from the last time they had contact with the source case (Candie).

Candie COVID tested positive on 3/28/2020.

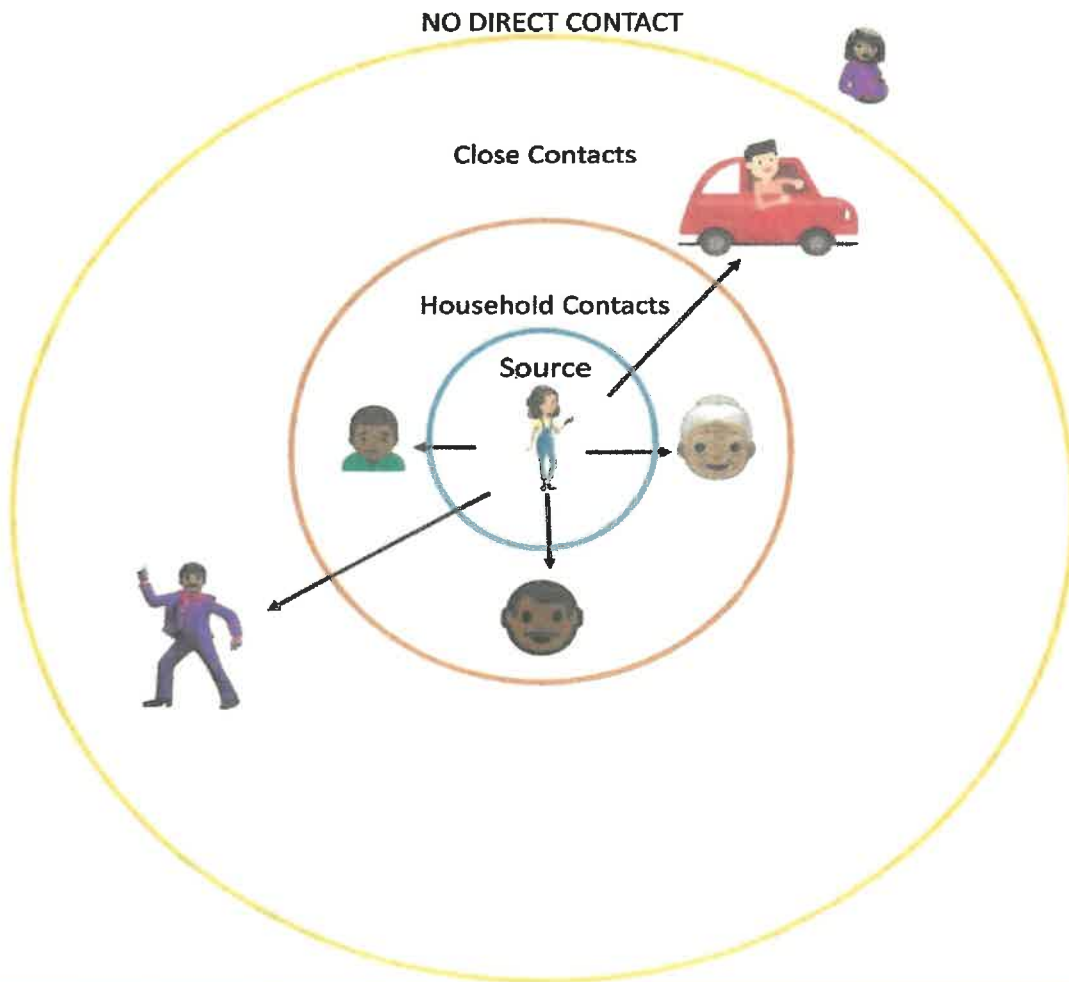
- * Isolation in separate room from family until has tested negative twice

 - * Home isolation for 14 days after last contact (3/27/2020) in own room away from Tonya Truxton

When is it safe for me to return to the community

PRIORITIES FOR COVID-19 TESTING



COVID-19 Symptoms: Fever, Cough, Shortness of Breath, Sore Throat, Headache, Myalgias, Chills, Repeating Shaking with Chills, and New Loss of Taste or Smell

1

- Hospitalized patients
- Healthcare facility workers, workers in congregate living settings, and first responders with symptoms
- Residents in long-term care facilities or other congregate living settings, including prisons and shelters, with symptoms • Persons identified through public health cluster and selected contact investigations

PRIORITY

2

- Persons with symptoms of potential COVID-19 infection, including: fever, cough, shortness of breath, chills, muscle pain, new loss of taste or smell, vomiting or diarrhea and/or sore throat
- Persons without symptoms who are prioritized by health departments or clinicians, for any reason, including but not limited to: public health monitoring, sentinel surveillance, or screening of other asymptomatic individuals according to state and local plans.

GUIDANCE FOR LARGE OR EXTENDED FAMILIES LIVING IN THE SAME HOUSEHOLD



Public Information and Awareness

1. Protect the household when you leave for errands
2. Protect household members at high risk for severe illness
3. Protect children and others from getting sick
4. Care for a household member who is sick
5. Eat meals together and feed a sick household member

How to protect the household when you leave the house

- Don't leave the household unless absolutely necessary, if you must leave follow these tips:
- Avoid crowds, including social gatherings of any size
- Keep at least 6 feet away from other people
- Wash your hands often
- Don't touch frequently touched surfaces in public areas, such as elevator buttons and
- Handrails
- Don't use public transportation, such as the train or bus, if possible. If you must use public
- Transportation: maintain 6 feet of distance from other passengers as much as possible, avoid touching surfaces such as handrails, wash your hands or use hand sanitizer after leaving transportation
- Don't ride in a car with members of different households
- Wear a cloth face covering to help slow the spread of COVID-19
- Wash your hands immediately when you return home
- Maintain a physical distance between you and those at higher risk in your household

HOW TO PROTECT MEMBERS OF THE HOUSEHOLD WHO ARE A HIGHER RISK

If your household includes people who are considered higher risk, then all family members should act as if they, themselves, are at higher risk. Here are seven ways to protect your household members.

1. Stay home as much as possible
2. Wash your hands often
3. Use an alcohol-based hand sanitizer that contains at least 60% alcohol if you can't wash with soap and water
4. Don't touch your eyes, nose, and mouth with unwashed hands
5. Cover your coughs and sneezes
6. Clean and then disinfect your home
7. Don't have visitors unless they need to be in your home



How to protect children and others from getting sick? Follow these five tips to help protect children and others from getting sick.

1. Teach children the same things everyone should do to stay healthy
2. Don't let children have in person playdates with children from other households
3. Teach children who are playing outside to stay 6 feet away from anyone who is not in their own household

Wet your hands with clean, running water and apply soap

Lather your hands by rubbing them together with the soap. Lather the backs of your hands, between your fingers, and under your nails

Scrub your hands for at least 20 seconds

Rinse your hands well under clean, running water

Dry your hands using a clean towel or air dry them

Hualapai Incident Command Team Differential Pay

- WHEREAS. the Hualapai Tribe is a federally recognized Indian Tribe located on the Hualapai Indian Reservation in Northwestern Arizona; and
- WHEREAS. the Hualapai Tribal Council has the power to represent the Tribe and act in all matters that concern the welfare of the Tribe pursuant to Article V(r) of the Hualapai Constitution; and
- WHEREAS. the current Incident Command Team (ICT) and future Hualapai ICT's will be authorized to implement the Incident Command System and includes an organization chart to improve efficiency. Based on the organizational chart a pay band will apply to each position. ICT Differential Pay, as defined in this Resolution is considered a discretionary bonus and is not considered 401(k) Plan compensation, but is part of the regular wage for the purposes of overtime calculations; see attached Appendix A;
- WHEREAS. on activation of the ICT by Council the IC will be designated by Council. Council, in coordination with the IC and HR Director, will fill the ICT positions giving first consideration to current RIF List, maintained by HR. ICT positions and vacancies are not required to be announced. Applications and interviews are also not requirement, but may be viewed as a best practice on a case by case basis;
- WHEREAS. all Hualapai ICT employees will be "Non-Exempt" and differential pay's will apply to all positions within the ICT which are listed below:

Hazard Pay, is authorized for employee risk of exposure to "virulent biologicals," defined as work with or in close proximity to materials of a micro-organic nature which when introduced into the body are likely to cause serious disease or fatality. Other types of hazard environments include floods, hurricanes, drought, communicable disease, or other Tribal Council deemed hazardous emergencies. Hazard Pay is 25% of ICT position hourly rate when performing duties specific to emergencies. Hazard Pay is on a 24-hour day from 0001 to 2400 hours and when authorized shall be paid for all hours within that day. Hazard Pay is in addition to other premium or differential pays.

Sunday Premium. is 25% and only applies if the employee's normal work schedule does not include working Sunday's. Sunday Premium only cover's tour of duty schedule hours and is in addition to other differential pays.

Night Differential. is 25% of hourly rate when an employee is working from 10PM – 6AM. Night differential is in addition to other premium pays.


Holiday Pay. includes "holiday worked" resulting in double pay for employee's scheduled tour of duty.



A Resolution Authorizing the Nation to Add the Aid to Tribal Government Program to the Nation's Master Contract No. A09AV00207 with the Bureau of Indian Affairs under P.L. 93-638

WHEREAS: The Hualapai Tribal Council ("Council") is authorized to represent the Hualapai Nation ("Nation") and act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Hualapai Tribe ("Constitution") as provided under Article V of the Constitution; and

WHEREAS: The Council, as the legislative body of the Nation, is authorized to enact laws, ordinances and resolutions incidental to the exercise of its legislative powers as provided under Article V of the Constitution; and

WHEREAS: The Council is authorized to negotiate, enter, and perform contracts and agreements with Federal, State and local governments and to accept grants and donations from any person, organization, state, or the United States as provided under Article V, respectively, of the Constitution; and

WHEREAS: The Nation currently has a Master Contract No. A09AV00207 with the Bureau of Indian Affairs (BIA), in accordance with the authorizations and requirements of P.L. 93-638, which includes the following programs administered by the Nation: (1) Social Services (including General Assistance), (2) Tribal Court, (3) Indian Child Welfare Act ("ICWA"), and (4) Roads Maintenance; and

WHEREAS: In response to the COVID-19 public health emergency, Congress adopted the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), P.L. No. 116-136, which authorizes \$453 million in additional direct appropriations resources for COVID-19 response activities through the BIA, of which \$380 million will be distributed to tribes based on enrollment data through the Aid to Tribal Government Program; and

WHEREAS: The CARES Act funding is one-time, non-recurring, non-base funds to be used for the purposes of prevention, preparedness, and response to COVID-19 and must be used within the allowable confines of the program, function, service, or activity (PFSA) in which they are received; and

WHEREAS: The Nation is facing extremely serious and detrimental financial impacts from the COVID-19 public health emergency, including ongoing closure of Grand Canyon Resort Corporation, and impacts to the Nation's governmental operations; and

WHEREAS: The Council has determined it to be in the Nation's best interest to add the Aid to Tribal Government Program to the Nation's Master Contract No. A09AV00207 with the BIA in order to access the \$843,965.00 in CARES Act funding allocated to the Nation through the BIA.

NOW THEREFORE BE IT RESOLVED that the Hualapai Tribal Council, in Council assembled, at which a quorum is present, hereby authorizes the Nation to request BIA to add the Aid to Tribal Government Program to the Nation's Master Contract No. A09AV00207 with the BIA under P.L. 93-638 in order to access the \$843,965.00 in CARES Act funding allocated to the Nation through the BIA.


BE IT FURTHER RESOLVED that the Nation will operate the Aid to Tribal Government Program by utilizing its allocation of the CARES Act funding for the purposes of prevention, preparedness, and response to COVID-19.

BE IT FURTHER RESOLVED that the Council authorizes the Nation to receive and expend the funds in accordance with the funding requirements and the Nation's financial policies.

BE IT FINALLY RESOLVED that the Chairman and Vice-Chairman, or either of them, are hereby authorized to take such further action as deemed necessary to carry out the purposes and intent of this Resolution.

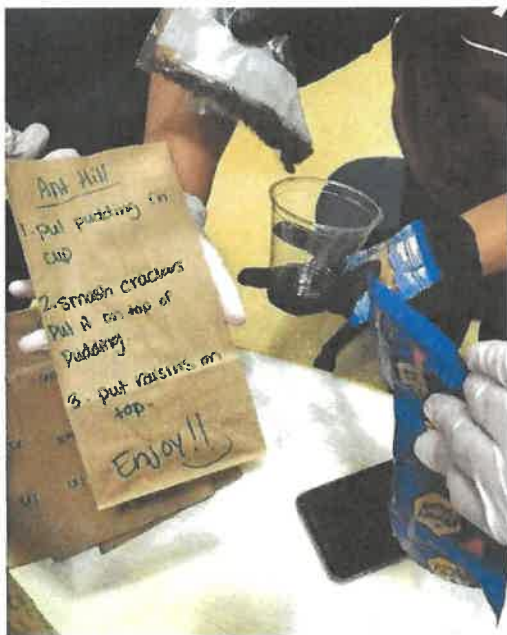

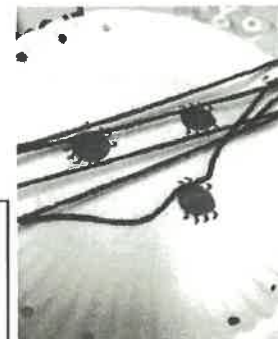

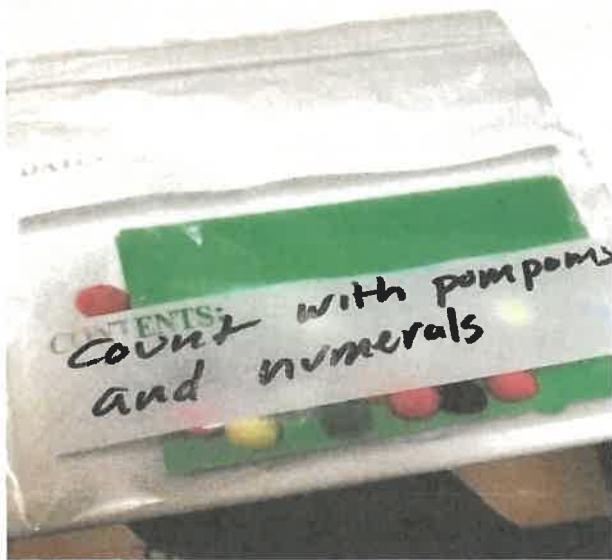

HUALAPAI HIGHER EDUCATION FUNDING PROGRAM POLICIES

I. Purpose

- A. The purpose of the Hualapai Higher Education Funding Program (HHEFP) is to provide financial assistance for enrolled members of the Hualapai Tribe seeking an Associate of Arts or Associates of Science or Associates of General Studies, Bachelors, Masters, or Post-Graduate degree or Certification at an accredited college/university/vocational institution.

II. Definitions

- A. Academic Term: means the duration of one semester, one quarter, or one trimester, as determined by the specific higher education institution.
- B. Academic Year: means the duration of two semesters, two trimesters, or three quarters as determined by the specific higher education institution.
- C. Accreditation: means the process of meeting and maintaining certain educational delivery methods and standards as prescribed by a nationally and regionally recognized accrediting association.
- D. Applicant: means any person who has applied for financial assistance through this Program pursuant to the Program's policies.
- E. Award: means upon eligibility and availability of funds, to confer upon an Applicant a specified amount of money in financial assistance for an Academic Term.
- F. Certificate of Indian Blood (CIB): means a certified document issued by the Hualapai Tribe Enrollment Office verifying that an Applicant is an enrolled tribal member.
- G. Credit Hour: means a unit of measurement referring to the amount of credit a student receives for completion of one or more courses per Academic Term. Credit hours are measured differently according to whether the institution the student is attending is on the semester, quarter or trimester system.
- H. Financial Aid Office: means the office of an institution of higher education that has responsibility for administering financial aid
- I. Financial Needs Analysis (FNA): means a determination of financial need based on the projected cost of education for one academic year minus financial assistance, scholarships, grants. (Family contribution & loans will not be considered).
- J. Financial Assistance: means specific financial assistance funds awarded by the Program to an eligible tribal member based on the Financial Needs Analysis (FNA) and availability of funds for an Academic Term or Academic Year.
- K. Full-Time Student: means and Applicant pursuing a degree and carrying the minimum amount of Credit Hours to be classified as "full time" during an Academic Term as determined by the institution.
- L. Higher Education: means a post-secondary education received at an accredited educational institution.
- M. Official Transcript: means a transcript received directly from an educational institution in a sealed envelope and appropriately stamped or indented as an official copy.
- N. Part-Time Student: means an Applicant pursuing a degree and carrying less than the minimum amount of Credit Hours to be classified as "full-time" during an Academic Term as determined by the institution.

- O. Pledge of service: a service can include but is not limited to counseling sessions, presentation in the field of study, mentorship, power point, seek employment, program development, complete a family tree with lineage. Other pledges of services will be determined on a case by case basis.
- P. Probation: means the failure to comply with the academic standards as prescribed by these Program policies, resulting in possible disqualification within the Academic Term funded.
- Q. Student: means an Applicant who has been officially and fully admitted to an accredited post-secondary institution.

III. Eligibility

- A. The Applicant shall be legally enrolled member of the Hualapai Tribe.
- B. Applicants must have a high school diploma or equivalency certificate prior to applying to the Program for an Award
- C. Applicants shall be officially and fully admitted to an accredited educational institution before obtaining an Award.
- D. Applicants shall have a complete Higher Education application in accordance with established policies.

IV. Application Deadline

- A. For the Fall/Spring and Fall Academic Terms Only: Applicants shall complete an application and provide their supporting documents by August 1st (if deadline falls on a holiday or weekend, deadline will be the following business day) of each year.
- B. For the Spring Academic Term Only: Applicants shall complete an application and provide their supporting documents by January 1st (if deadline falls on a holiday or weekend, deadline will be the following business day) of each year.
- C. For the Summer Academic Term Only: Applicants shall complete an application and provide their supporting documents by May 1st (if deadline falls on a holiday or weekend, deadline will be the following business day) of each year.

V. Applicant's Responsibilities

- A. The Applicant shall complete a higher education application for each Academic Year, including all supporting documents. The Applicant is also responsible for completing the financial aid requirements of the institution to which they are seeking admission.
- B. The Applicant must submit the application in a timely manner. ***Applications will not be accepted after the deadline. Incomplete applications will not be processed.***
- C. The Applicant shall immediately notify the Program and report in writing any change in name, enrollment, course load, and withdrawal and transfer status.
- D. The Applicant is responsible for submitting all documentation as required by the Program and other documents relative to financial aid, grades and standing at their school. Official transcripts must be submitted no later than 30 working days after completion of each Academic Term.
- E. A Full-Time Student shall be responsible for adhering to the following time lines:
Associate Degree-equivalent to 6 full-time semesters or 80 credit hours
Bachelor's Degree-equivalent to 10 full-time semesters or 150 credit hours
Graduate Degree-equivalent to 6 full-time semesters or 54 credit hours
Vocational degree/cert-determined by school
- F. The Applicant ***must apply*** to other available financial aid programs with the federal and state government, i.e. FAFSA, Pell Grant, each academic year. Applicants fully funded by other

Hualapai Tribe entities are **NOT** eligible for HHEFP funding.

- G. The HHEFP is provided as a **privilege**, with the requirement that the Applicant, within one year of the graduation date, be expected to return to the Hualapai Tribe to fulfill their Pledge of Service.

VI. Application Procedures

- A. All Applicants shall complete and submit all required documentation as described in the Higher Education Application and herein, including those documents from the institution.
- B. All Applicants shall submit a certificate of Indian blood (CIB), letter of admission, graduation check list, and a current class schedule from the institution.
- C. All the Applicants shall submit official transcripts at the time of application and after each academic term.

VII. Student Probation/Suspension

- A. A review of Student records will take place monthly to identify Students who have failed to meet the Program requirements.
- B. Any Student who does not maintain a 2.0 grade point average will be subject to academic probation. If the Student is attending an institution that does not rate academic progress through grade point averages, then the Student must be achieving satisfactory progress as defined by the institution that Student is attending.
- C. A Student on probation will receive funding but will be notified that he/she has one Academic Term to bring his or her grade point average up to 2.0 or better, or to achieve satisfactory progress as defined by the institution the Student is attending. The Student will be recommended to seek tutoring at his or her own expense.
- D. If the probationary Student fails to bring his or her grade point average up to at least 2.0 or to achieve satisfactory progress as defined by the institution the Student is attending, the student will be placed on academic suspension. The Student will need to attend school at his/her own expense until the deficiencies are corrected.
- E. Any Student whose course load drops below the awarded minimum will be placed on academic probation.
- F. Any Student who withdraws from all registered courses or fails to complete the Academic Term will be placed on academic suspension. The Student must retake the equivalent credit hours at their own expense to be eligible for future funding.
- G. Any Student who fails to complete a vocational/technical program will be immediately placed on academic suspension. The Student may be responsible for monies owned to the institution.

VIII. Financial Awards

- A. The Program's Awards are based according to information the Program receives on the 'Financial Needs Analysis', completed by the financial aid office at each institution and submitted to the Program.
- B. All undergraduate and vocational Students are eligible to receive up to \$24,000 per academic year for all educational expenses. The amount of the award is dependent on the availability of funds for awards by the Program as determined by the Tribal Council on an annual basis during the Tribe's budgeting process.
- C. Students seeking a Master's Degree or Doctorate Degree are eligible to receive \$34,000 per academic year. The amount of the award is dependent on the availability of funds for award by the Program, as determined by the Tribal Council on an annual basis during the Tribe's

- annual budgeting process.
- D. Students who are enrolled *full-time in on-line classes and/or programs will receive funding for direct costs such as tuition and fees, textbooks and supplies.*
 - E. Students who are enrolled *part-time will receive funding for direct costs such as tuition and fees, textbooks and supplies.*
 - F. Awards will be paid to the school for tuition/fees and on campus room and board. Awards will not be disbursed until the higher education application is complete. Payments made by the Student for educational expenses and which Awards are meant to cover, may be eligible for reimbursement by the Program.
 - G. Students who are having serious financial difficulties may request a one-time emergency award. Supporting documentation must accompany the request and the awarded amount is dependent on available funds.
 - H. Any misuse, non-use or other defaults will result in the Program being authorized to recover the monies from any payment made to the Student from the Hualapai Tribe. This includes filing a claim with the Hualapai Tribal Court for repayment.

IX. Appeal Process

The applicant has the right to appeal a denial *within 14 days* after postmarked date of the award/denial letter. The written appeal shall contain the following information:

1. The full name, address and student identification number of the applicant making the appeal.
2. A clear concise statement of the facts, pertinent dates of complaint to be considered and supported documents with a phone number or email address for Department of Higher Education to contact appellant.
3. The letter of email requesting appeal shall be directed to:

X. Other

- A. Classes not required for a degree/certificate will not be paid for by the Program. These classes do not count towards Full-Time Student status as well.
- B. Vocational and technical training applications will not be accepted between August 1st and December 31st of each year.
- C. Students who complete a vocational program, of any type, will be ineligible for further funding for one year.
- D. Vocational and technical Applicants must allow for at least four weeks for application approval and funding.
- E. All Students must have a declared major or emphasis of study. A Student cannot be classified as an “undeclared” major.
- F. Students who are full-time employees of the Hualapai Tribe and are classified as Full-Time Students, will be eligible to receive tuition, textbook and transportation expenses.
- G. The following expenses will not be covered by the Program: application fees, childcare, moving expenses, student’s health insurance, graduation expenses and parking fees.

All students just submit an Academic Plan that specifies their course of study or declared major, lists specifically all classes required for their program, and indicates an expected graduation date. It is recommended that the student obtain this plan directly from a student advisor at their chosen school. The Academic Plan may be a 'Degree Requirement Checklist' printed at their school or in their school's general catalog.

Full-time students are required to complete the Free Application for Federal Student Aid (FAFSA) each academic year and refer to the Financial Aid Office at their school. The Financial Needs Analysis (FNA) Form is completed by the Financial Aid office at the school. Scholarship awards will be based on information provided to the Higher Education Office on the FNA form.

Part-time students are eligible to receive tuition, fees, textbooks, and supplies. The supplies allowance will be \$10.00 per class. Students will also receive a transportation allowance in the amount of \$100 per three credits.

PLEASE NOTE THAT ONLY COMPLETE APPLICATIONS WILL BE PROCESSED.

Students will be advised by letter as the status of their application. Students are responsible for reviewing and becoming familiar with the Hualapai Higher Education Funding Program guidelines contained in this application.

RESPONSIBILITIES OF THE APPLICANT

The Applicant must:

- A. Complete a new application form for each academic year, including all supporting documents.
- B. Submit the application in a timely manner. Applications will not be accepted after the deadline, NO EXCEPTION. INCOMPLETE APPLICATIONS WILL NOT BE PROCESSED.
- C. Notify the Higher Education Office and report in writing any change in course enrollment, course load, and withdrawal.
- D. Request official transcripts at the end of each semester or grading period. Official transcripts are mailed directly to the Higher Education Office.
- E. Adhere to the following time lines.
 Associate’s degree = 6 full-time semesters Master’s degree= 9 full-time semesters
 Bachelor’s degree = 10 full-time semesters Doctorate degree= 9 full-time semesters
 Vocational deg./cert = determined by school
- F. Be responsible for meeting other additional conditions for any of the scholarships or services received from Higher Education Program. These conditions may be provided to the student individually.

STUDENT PROBATION/SUSPENSION

- A. A review of student records will take place monthly to identify students who did not meet the Higher Education Program requirements.
- B. Any student who does not maintain a 2.0 grade point average will be placed on academic probation. The student will then have one semester to bring GPA up to 2.0 or better. If the student does not correct the deficiencies, the student will be placed on academic suspension. The student would then need to attend school at his/her own expense as a full time student and until the deficiencies are corrected.
- C. Any student whose course load drops below the awarded minimum must pay back the difference in award. The student will then be placed on academic suspension until the award amount is paid back. The student may be responsible for monies owed to the institution. Repeat courses are also the responsibility of the student.
- D. Any student who fails to complete the semester/program will be immediately placed on academic suspension. The student may be responsible for monies owed to the institution.

OTHER

- A. Classes not required for a degree/certificate will not be paid for by the Program. These classes do not count towards Full-Time Student status as well.
- B. Students who attend vocational/technical programs will not be eligible for funding for one year after completion of their program.

Today I am going to tell you something about hope. It is something that we all need. Maybe now more than ever. The news is filled with lots of scary stuff. You have heard about it every day for weeks now. We all know more than we care to and that toilet paper is a very difficult thing to find these days.

But for today I want to share with you how we can become more centered, feel more in control and even more at peace with yourselves.

When I was a little boy I was instructed by my father upon my awakening to say thank you to my Creator for returning my soul to my body and letting me see the light of day. I did not fully understand the importance of doing this at the time but did so because my father had told me to do this and often asked me if I had remembered his instructions. Sometimes I forgot but I admitted this as he had also taught me that to lie was a very bad thing. A few years later my father began to share stories about when he was a soldier back in World War II and many of the very big battles he was in like D-Day and The Battle of The Bulge. Sometimes he told me things that maybe a dad should not tell his child. Too much detail about death of comrades and terrible things he had to do. Only years later did I connect these things. For those of you who are interested these are my personal view points on some questions that have been presented to me. Understand that any proposed changes takes a majority of vote before it can be considered and implemented.

It is my understanding that all Tribal Members are afforded the opportunity to develop and create their own business. A “Small Business” office needs to be established to promote and assist individuals interested in establishing their own business. This office should focus on working with those individuals in creating a criteria that would include a solid business plan with marketing strategies that would include a Pro Forma.

3. Am I in favor of making changes to the Tribal Constitution?

Our tribal constitution is in the process of being revised and updated. I believe that the proposed changes to the constitution are necessary to protect the interest of “the Hualapai People.” In this day and age our Tribal Government is challenged, in which the interpretation and language of the constitution can be misconstrued compromising the Hualapai Tribe’s position.

4. My views on the separation of powers; Legislation, Judicial, GCRC, and Tribal Administration?

The separation of powers is necessary when it comes the Judicial System to maintain the Courts integrity. Legislation is proposed and approved by Tribal Council, in which the Law Enforcement Committee and the Hualapai Tribal Court Board can be more effective by being more of working committee to measure the legitimacy of proposed changes, amendments and or rulings.

My mother was the late Malinda Majenty Powskey who we recently lost this past August 2019. My grandparents and mother had a big influence in my work ambition and determination to face Life and its Challenges. My Grandfather was from Big Sandy and my Grandmother who was the daughter of Kate Crozier was from Chloride. The biggest lesson, I learned from my grandparents and mother was our Hualapai Tribal language and understanding of our culture.

I am running for Hualapai Tribal Council Chairperson because I want to make a difference for our Tribe. For the last 20 years, I have learned first-hand about the important issues currently facing our tribe and I have worked hard to make a significant contribution. Our tribe has outside people, cities and state governments today that threaten our tribal sovereignty. The challenges we face in our tribal government, from nearby communities, outside businesses, infrastructure and the environment are affecting the quality of life of every Hualapai Tribal member. Today, we must balance our tribal government thru understanding of our tribal enterprises, tribal departments and tribal members. Each enrolled tribal member should have the right to tribal employment, tribal housing and tribal benefits.

My experience as the past executive officer with Grand Canyon Resort Corporation and past Board of Directors Chairman is very important knowledge in our Tourism Industry. Visitors from around the World come to Grand Canyon West to see the Grand Canyon and experience our Hualapai Tribal Culture. The Hualapai Tribe generates all their revenue from Tourism Operations. I have over 20 years in the Tourism and Business Management Industry. I have experience in Strategic Planning and Marketing Development. I have developed short- & long-term goals to maximize revenue and increase product development. I have experience in people development, tribal and community planning and infrastructure project management. I have experience working with Arizona State Government, Bureau of Indian Affairs, National Parks, Federal Aviation Administration and Mohave County Government. I gained a lot of experience in the Tourism Industry with the Arizona American Indian Tourism Association, where I served for over 15 years as a Board of Directors and past President. We have many challenges — and opportunities — but we need to get things done for our tribal members and tribal business.

My greatest experience came from growing up in Valentine, AZ and listening to the Hualapai Elders and their challenges in keeping our language and culture alive. I served in United States Army where I learned a lot about Leadership and teamwork, but my most accomplished life experience was attending the Bureau Indian Affairs Boarding School where I learned to be independent & developed an understanding of our Tribal and Federal Government Affairs. Our Hualapai Tribe can become a great tourism attraction again, if we work together for the benefit of the entire tribe and build bridges.

We know you have received numerous communications about COVID-19. We have been reading them as well – and know more than we ever thought we would about social distancing and procedures for shutting our offices and lives down. We are in unknown territory and it is hard to calibrate our thoughts and actions. But as time moves forward, so must we, and we need to do so in a way not to disrupt our behaviors and thoughts with one another.

About 8 years ago, our grandson was only a couple of weeks old and he was near death. He was taken to the Children’s hospital in Phoenix for TBI (Traumatic Brain Injury), our hearts were held in an agonizing pain – we didn’t know how to calibrate our thoughts or actions.

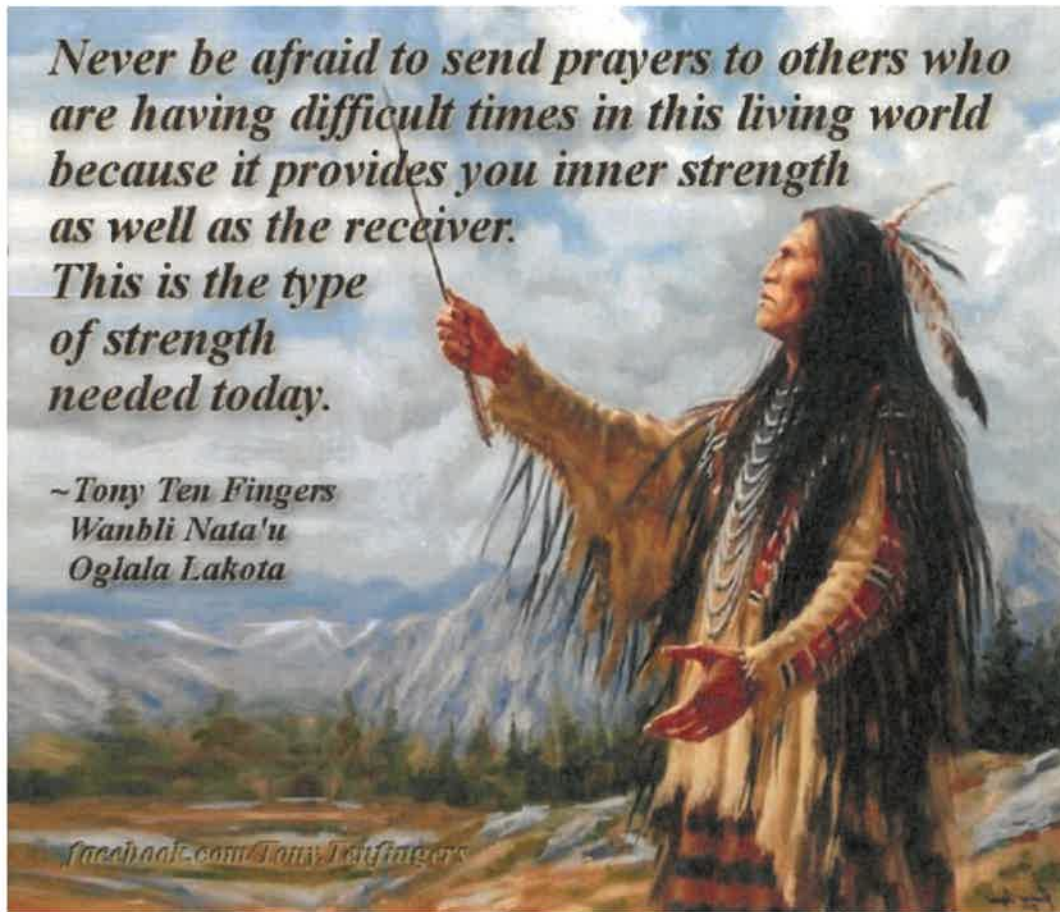

At the heart of our message is perpetuation of our cultures – not just for sharing with visitors – but for our children, our families and our communities and we will need to calibrate our thoughts and actions toward rebuilding our world, that you may see your sign of blessings.

We want to continue by giving our condolence to the many Native American people who had their loved ones taken by this virus, we all are experiencing instability and stress, and know that we are going through an irrevocably changed. We are sending our very best to those who are struggling, we are looking for the helpers as the beacon of hope.



The helpers, the ones who are willing to serve, the reliable are our amazing Alliance and beyond. From our small town of Peach Springs, our state of Arizona, and government leaders who are showing courage and compassion in a time of tumult. To our healthcare workers working to keep us all healthy, including the custodial staff who keeps our buildings clean, the workings in the hospitals and drivers of ambulances, and our scientists who are working on tests and vaccines.

To the people who are providing access to food and water all along the supply chain.
