The Hualapai Tribal Government and the Incident Command Team will be enforcing a community-wide lockdown to prevent exposure. Protect your families from the spread of coronavirus. Be responsible. Stay home. No movement within the community will be allowed.

SEVERE FINES and JAIL TIME will be imposed on all violators.

RESOLUTION 36-2020
OF THE GOVERNING BODY
OF THE HUALAPAI TRIBE OF THE HUALAPAI RESERVATION

Amendment to Resolution 29-2020 Temporary Declaration of Emergency Measure Order for COVID-19

WHEREAS, the Hualapai Tribe is a federally recognized Indian Tribe located on the Hualapai Indian Reservation in Northwestern Arizona; and

WHEREAS, the Hualapai Tribal Council has the power to represent the Tribe and act in all matters that concern the welfare of the Tribe pursuant to Article V(r) of the Hualapai Constitution; and

WHEREAS, the Hualapai Tribe declared a State of Emergency in connection with COVID-19 on March 17, 2020; and

WHEREAS, the Tribal Incident Command Team (ICT) has prepared an Emergency Measure Order's listed below to protect the Hualapai community by limiting exposure to COVID -19 and to limit community movement;

WHEREAS, the Hualapai Tribal Police Department, and authorized commissioned officer are to issue citations and implement Section 6.92 "endangerment" (Tribal Resolution 26-2020) shall be as a civil sanction;

WHEREAS, the intent of the orders listed below are to limit COVID-19 spread and protect the Hualapai community. This resolution is necessary and compelling. All offenses are consecutive, beyond the 3rd offense the 3rd offense will continue to apply. The orders are listed below which coincide with offenses

Stay at Home Order – Applies 24 hours/ 7 days a week for all community members to stay within the boundary of their property and limit direct communication with the public to avoid potential contact with COVID-19 which offenses below apply 24/7. *The exception is medical care, food, financial obligations, essential employees, emergency services, and tribal officials. All program director's will provide their essential employees a letter with official letterhead that includes the employee's name, director signature, phone number for verification, and duration (30-day increment). No riding in vehicles without essential reason, during the day limitations 2 adults or parents with minors. Traffic control points will only limit 2 entrances (roundtrip) per day. Cattle associations and tribal contractors are to stop by Tribal Game & Fish to receive a placard to*

conduct official business. If the Stay at Home Order is not followed you put the community at risk of virus spread.

Curfew Hours: 8:00PM – 5:00AM (All community members to be indoors)

Offense 1: Written Warning

Offense 2: Shall be fined \$3,000.00 to be deducted from payroll or Hualapai Distribution and non-members removed from the Hualapai reservation for 1-year.

Offense 3: Shall be imprisoned for 30-days and an additional \$3,000.00 fine shall be imposed, deducted from payroll or Hualapai Distribution

Isolation or Quarantine Orders – Applies to individuals that are COVID-19 positive or person under investigation (close contact) of COVID-19. Indian Health Services (IHS) will advise on positive, negative, or recovered case(s). IHS will provide guidance regarding the duration for quarantined individual(s). Failure to abide by (*self*) Isolation or Quarantine Orders penalties apply below.

Offense 1: Shall be \$5,000.00 fine deducted from payroll or Hualapai Distribution and non-members removed from the Hualapai reservation for 1-year.

Offense 2: Shall be 30-days of imprisonment and additional \$5,000.00 fine deducted from payroll or Hualapai Distribution.

Offense 3: Shall be imprisoned for 90-days

Center for Disease Control and Prevention Definitions:

Isolation - Separates sick people with a contagious disease from people who are not sick.

Quarantine – Separates and restricts the movement of people who were exposed to a contagious disease to see if they become sick.

Hualapai Reservation Quarantine (Lockdown)

The intent of a reservation lockdown is to continue limiting community movement, increase restrictions, and eliminate access to/from the Hualapai reservation for the health and safety of the people. The lockdown will be imposed within a minimal 12-hour notification from the Incident Command Team and will include the duration, curfew hours, reminded rules, and penalties.

NOW THEREFORE, BE IT RESOLVED, the Chairman or the delegation of authority to the ICT is authorized to implement such measures.

OF THE GOVERNING BODY
OF THE HUALAPAI TRIBE OF THE HUALAPAI RESERVATION

Hualapai Quarantine (Lockdown)

WHEREAS, the Hualapai Tribe is a federally recognized Indian Tribe located on the Hualapai Indian Reservation in Northwestern Arizona; and

WHEREAS, the Hualapai Tribal Council has the power to represent the Tribe and act in all matters that concern the welfare of the Tribe pursuant to Article V(r) of the Hualapai Constitution; and

WHEREAS, the Hualapai Tribe declared a State of Emergency in connection with COVID-19 on March 17, 2020; and

WHEREAS, the Tribal Incident Command Team (ICT) has prepared an Emergency Measure Order's listed below to protect the Hualapai community by limiting exposure to COVID -19 and to limit community movement;

WHEREAS, the Hualapai Tribal Police Department, and authorized commissioned officer are to issue citations and implement Section 6.92 "endangerment" (Tribal Resolution 26-2020) shall be as a civil sanction;

WHEREAS, the intent of the orders listed below are to limit COVID-19 spread and protect the Hualapai community. This resolution is necessary and compelling. All offenses are consecutive, beyond the 3rd offense the 3rd offense will continue to apply. The orders are listed below which coincide with offenses.

NOW THEREFORE BE IT RESOLVED; the Hualapai Tribal Council enacts Hualapai Reservation Quarantine (Lockdown) in response to the COVID-19 and shall remain effect until further notice;

BE IT FURTHER RESOLVED, The intent of a reservation lockdown is to continue limiting community movement, increase restrictions and eliminate access to/from the Hualapai reservation for the health and safety of the people. The lockdown will be imposed within a minimal 12-hour notification from the Incident Command Team and will include the duration, curfew hours, reminded rules, and penalties below.

Rules**Exempt**

- Tribal Officials
- Medical (dialysis, doctor appointments, etc.) require clinical note/letter
- All essential employees, require a letter with official letterhead that includes the employees name, director signature, phone number for verification, and duration (Ex. May 10th – 14th). Employees are on call at Directors discretion.
- Elementary, Elderly, and Head Start meals
- Emergency Services (Hualapai Nation Emergency Services, Forestry Wildland Fire Interagency, Hualapai Tribal Police/County/DPS, Hualapai Game & Fish)
- Hualapai Tribal Courts
 - Prosecutors & Public Defender
- Hualapai Adult/Juvenile Detention Center
- Walapai Market, open through ICT discretion
- Bureau of Indian Affairs
- Indian Health Services
- Mohave Electric
- Indian Energy & Ferrell Gas
- Commercial Fuel (Walapai Market)
- BNSF
- Lhoist North America (Chem. Star)
- Burial Service, collaborate with the ICT
- Deliveries: Postal services (FedEx, UPS, etc.), St. Mary's Food Bank, Shamrock, donations for the families impacted by COVID-19, etc.
- Rt. 18 access for Havasupai and Boquias Ranch
- Diamond Bar, Buck & Doe, Indian 18, and Diamond Creek limited access for essential & emergency personnel only
- Incident Command Team – General Staff
- Cattle Districts will be closed, except to feed and water necessary livestock every other day. (Ex. 4-H, corralled livestock)
- Tribal contractors and permit holders (Ex. Wood cutters) will stop for the lockdown duration.
- Rt. 66 will remain open for non-local traffic (public pass through only)

Non-Exempt

- Current contractors
- Hualapai Transportation

- Education packets will not be delivered or picked up
- Holiday gatherings closed until further notice

Other

- Due to this crisis, it is necessary for Tribally Commissioned Officers to search vehicles due to the necessity and compelling impacts of COVID-19.
- All Hualapai community members are required to stay within their property boundary during the lockdown, except in the event of an emergency

Failure to abide by the Hualapai Reservation Lockdown penalties will apply below.

Offense 1: Shall be subjected to a mandatory 30-days of imprisonment

Offense 2: Shall be subjected to a mandatory 60-days of imprisonment


Offense 3: Shall be subjected to a mandatory 90-days of imprisonment

All community members are required to wear protective barrier in public to help prevent further spread of COVID-19.

NOW THEREFORE, BE IT RESOLVED, the Chairman or the delegation of authority to the ICT is authorized to implement such measures.

Referring to rules for exemptions...

Tribal Resolution 37-2020



Emergency Measure Order: Hualapai Quarantine (LOCKDOWN) DECLARES:

- *Cattle Districts will be closed, except to feed and water necessary livestock every other day. (Ex. 4-H, corralled livestock)*

This does include domestic horses since legally horses are livestock.

The care of your animals is allowed **“every other day”**.

This means that if you water & feed your animal on Saturday, it should provide enough through Monday.

You will NOT be allowed to tend to them everyday.

Please be clear and specific and sensible in your limited movement for this exception. Several violators have already been incarcerated.

Health Officials Confirm that the number of positive COVID-19 cases are now at **(60)** among local Tribal members and other community members. This includes; **four (4)** commuting staff, **three (3)** Tribal members residing in the Kingman area, **one (1)** Tribal member residing in the Bullhead City area, **seventeen (17)** hospitalized, **one (1)** positive/recovered, and we have **one (1)** positive/deaths.

Family members and other community members who have been in close contact with the positive cases are in self-quarantined/self-isolated lodging or recovering at home as investigations continue and tests are pending results.

The **LOCKDOWN** will be in effect beginning Friday May 15th @6:00 PM and ending Friday May 29th @ 6:00 AM, but the **STAY AT HOME ORDER** does apply continually **24 hours / 7 days a week** for all community members to stay within the boundary of their property and limit direct communication with the public to avoid potential contact with COVID-19. Some exceptions are allowed under the Tribal Resolutions 36 & 37; medical care, tending to livestock, essential employees, and tribal officials during the day.

The **CURFEW HOURS** are: **8:00 PM to 5:00 AM nightly.**

There are **217** positive confirmed cases and **24** deaths in Mohave County: with **47** in the Lake Havasu City area including **4** deaths, **147** in the Kingman area including **19** deaths, **4** in “North Country” and **19** in Bullhead City area including **1** death.

We encourage community members to stay at home, remain calm, and take this matter seriously. Please continue following CDC recommendations as you confine yourselves at home. **DO NOT** expose the elderly to “**community spread**” through your outside to home activities.

As defined by the CDC, community spread means people have been infected with the virus in an area, including some who are not sure how or where they became infected.

The best ways to prevent the spread of COVID-19:

- **Wash hands often with soap and water for at least 20 seconds, or use sanitizer**
- **Avoid touching eyes, nose, and mouth with unwashed hands. Avoid people who are sick.**
- **Be responsible: stay home if sick, or get checked by a medical professional.**
- **Clean and disinfect objects and surfaces. COVID-19 spreads through mucus droplets through coughs or sneezes. Symptoms appear within 2 to 14 days after exposure and consist of fever, cough, runny nose, and difficulty breathing.**

For people with mild illness, individuals are asked to stay home, drink plenty of fluids, and get rest. For people with more severe symptoms, such as shortness of breath, individuals are advised to seek healthcare at IHS or EMS

Tell me what I need to know about COVID 19—Self Check

If you have been in close contact with someone who tested positive with COVID 19 in the past 2 weeks and develop symptoms, contact the Peach Springs Clinic at 928-769-2900.



Your health matters, you are responsible for you own personal health and you know your body. Keep safe and stay well Hualapai!

People with COVID-19 have had a wide range of symptoms reported – ranging from mild symptoms to severe illness.

Symptoms may appear 2-14 days after exposure to the virus. People with these symptoms or combinations of symptoms may have COVID-19:



- Headache
- Sore throat
- New loss of taste or smell
- Cough
- Shortness of breath or difficulty breathing or at least two of these symptoms
- Fever
- Chills
- Repeated shaking with chills
- Muscle pain

What can you do to protect yourself and family?

1. **Avoid close contact with people who are sick.**
2. **Avoid touching your eyes, nose, and mouth**
3. **Cover your cough or sneeze with a tissue, then throw the tissue in trash.**
4. **Clean & disinfect frequently touched objects and surfaces**
5. **Wash your hands often with soap and water for at least 20 seconds.**

***Eight New COVID-19 Cases
7 in Kingman Area; 1 in Bullhead City Area
Total Positives Now 217
Total Deaths in County 24***

MOHAVE COUNTY, AZ (May 13, 2020) Late this afternoon, the Mohave County Health Department (MCDPH) Nursing staff was notified of eight COVID-19 positive cases in Mohave County. Seven of them are in the Kingman area and 1 is in the Bullhead City area.

Of the 7 Kingman service area cases, one is under 20 years of age, in isolation and recovering at home. Four of the cases are in the 20-44 age range: one of those is hospitalized and the other three are in isolation and recovering at home. The remaining two Kingman service area persons are in the 55-64 year age range, in isolation and recovering at home. All seven of the Kingman area individuals have an investigation pending.

The sole remaining positive is a 65+ Bullhead City service area person, who is hospitalized, not linked to a confirmed case and not travel related.

There are now 47 positive confirmed cases in the Lake Havasu City area, including four deaths, 147 in Kingman, with a total of 19 deaths there, 4 cases in "North County," formerly referred to as "Other" (composed of a number of smaller Mohave County communities,) and 19 in Bullhead City, including one death. There are a total of -- 24 deaths in the county from the disease. Total positive cases --217. Total of 24 deaths.

ALSO: The Arizona testing blitz continues with free testing taking place Saturday, May 16 from 6am to 11am at Lake Havasu City's Aquatic Center, 100 Park Avenue. Meanwhile, please keep in mind that the best ways to prevent the spread of COVID-19 are:

Maintain your Social Distancing – At least 6 Feet apart! Stay at home if at all possible.

- * **Wash your hands often with soap and water for at least 20 seconds. If soap and water are not available, use an alcohol-based hand sanitizer.**
- * **Avoid touching your eyes, nose, and mouth with unwashed hands.**
- * **Avoid close contact with people who are sick.**
- * **Stay home when you are sick, or if you are a not an essential employee.**
- * **Cover your cough or sneeze with a tissue, then immediately throw the tissue in the trash.**
- * **Clean and disinfect frequently touched objects and surfaces.**

COVID-19 spreads through the air when an infected person coughs or sneezes. Symptoms are thought to appear within two to 14 days after exposure and consist of fever, cough, runny nose, and difficulty breathing. For people with mild illness, individuals are asked to stay home, drink plenty of fluids, and get rest. For people with more severe symptoms, such as shortness of breath, individuals are advised to seek healthcare, using telemedicine where available.

A Public Reminder!

If you are traveling to Kingman, Bullhead or Lake Havasu or any hot spot area which is considered to have an increased number of positive COVID-19 cases, we ask that you follow these guidelines to prevent the spread of COVID-19.

- Wash hands often with soap and water for at least 20 seconds or use hand sanitizer.
- Avoid touching your eyes, nose and mouth with unwashed hands;
- Avoid people who are sick;
- Clean and disinfect objects and surfaces;
- WEAR a face mask when around others who are sick;
- WEAR any type of gloves when going into a public area.



Remember, the “Stay At Home Order” is in effect 24 hours a day, 7 days a week. You must stay within the boundary of your property and limit direct communication with others. The only exceptions to the Stay at Home Order, during the hours not covered by curfew are:

- Medical Care
- Food
- Financial Obligations
- Cattle association members and Tribal Contractors displaying authorization Placards from the Hualapai Game & Fish
- Essential Employees
- Tribal Officials

It has come to Hualapai Housing attention that we are getting more and more large gatherings in the rental/homeowner homes we are under Hualapai Tribal resolutions for self-isolation. The covid-19 positive numbers are climbing higher, for the safety of our community we need to stop and think about our relatives and family members. For the safety and well-being of Hualapai Tribal community please see the following Hualapai Housing policy sections below.

REMOVAL HAS BEGUN/CONTINUE FOR THE HOMES THAT ARE NOT FOLLOWING HHD POLICIES.
SECTION VII. POLICIES AND RULES APPLICABLE TO HOMEOWNERSHIP AND RENTAL PROGRAMS

A. USE OF HOME - PAGE 46

1. The Homebuyer/Tenant must use the home as his/her primary residence, and for occupancy by members of his/her household listed in the family composition.

B. UNLAWFUL ACTIVITIES

1. The Homebuyer or Tenant is responsible for all actions of residents, guests, and visitors of the home. Homebuyers, Tenants, household members, and their guests and visitors shall not engage in any unlawful activities, disorderly conduct, threatening or intimidation, or other activities which are hazardous to the health or safety of other Homebuyers or Tenants, or disturb other Homebuyers or Tenants in the quest enjoyment of the premises.
2. No loud music is allowed on the premises.
3. Homebuyers, Tenants, guests and visitors shall not destroy, deface or damage any HHD property.
4. Homebuyers and Tenants shall report all unlawful and suspected criminal activities, including bootlegging and drug sales occurring in their neighborhoods to lawful authorities and to HHD no later than the next business day following the unlawful or suspected criminal activity. Homebuyers and Tenants should cooperate with law enforcement agencies and HHD in evicting such persons from their home and grounds.
5. No firearms shall be discharged in or around the housing premises.

C. DRUG & ALCOHOL-FREE HOUSING POLICY

The sale, use, possession, purchase, manufacture, or transfer of illegal drugs or other controlled substances or drug related paraphernalia on or off any HHD managed housing premises, by a Homebuyer/Tenant, any member of his/her family, or any guest or other person under Homebuyer's/Tenant's control, is a breach of the Homebuyer's/Tenant's obligations under his/her Lease Agreement/Rental Lease. A Homebuyer/Tenant must notify HHD of any federal, state or tribal drug conviction of any person residing in Homebuyer's/Tenant's unit no later than five (5) days after such conviction. Selling and consumption of alcohol in the homes is a breach of the Homebuyer's/Tenant's obligations under his/her Lease Agreement/Rental Lease. Any violation of this Section may subject a Homebuyer/Tenant to termination of his/her Lease Agreement/Rental Lease.

Effective immediately, the distribution and pick-up dates are changing for the following:

WEDNESDAY, May 13th – MEALS FOR WEDNESDAY AND THURSDAY ARE BEING COMBINED. Please note there are not meals being distributed on Thursday May 14th.

Gum yu je?

Greetings, it has been a while since time has been afforded to give you an update on the issues council has been involved with. First and foremost..., we send out our condolences with the recent death of Sylvia Jackson, (AKA- "Sugar Bear") former Vice-Chairperson, Councilwoman. She was one of the Board of Directors when Hwa:l Bay Ba:J first was started; and other areas of work in Head Start and the Housing Department.

The past few months since the end of February have been very tough, especially when the Epidemic of the COVID-19 came into our lives all around us, and now with us. As the virus moved into Arizona, many cities and towns did not take it seriously. When we look back at the last eight weeks, many people have lost their lives; many lost jobs and we have a change in our economy. The stores are changing the way we shop. You couldn't find toilet paper, paper towels, beans, rice, and the essentials for your family.

This small but deadly virus has caused a change in our ways of living. We are limited to what we can do, but the best thing is to take care of yourself, and one another. Schools have closed, GCW is not in operation, and the Tribal departments are minimal in their services. Las Vegas is shut down, and Native American Gaming has halted. Here at Hualapai, we have had from one (1) case to four to seven to 13, and as of Friday, (5/08/2020), we are at 36 Positive with one death, sad to say. As of today, 5/14, we are at 60.

1. Effective April 1st, 2020, Hualapai Tribal Council expanded its definition of Paid Sick Leave to include leave for **Emergency COVID-19** related reasons.
2. Emergency COVID-19 Leave, entitles certain employees to take up to two weeks (80 hours) of Emergency COVID-19 Leave.
3. Once an employee exhausts all 80 hours of **Emergency COVID-19 Leave** the employee must do one of the following:
 - a. **Return to work** through coordination with their Department Director/Program Manager.
 - b. Use their own earned **Sick Leave** if they are still sick, or for any of the reasons listed in Ref. (1) under "Sick Leave."
 - c. Use their own earned **Annual Leave**.
 - d. Use **Leave without Pay** through coordination with their Department Director/Program Manager and Human Resources. If an employee has exhausted the Emergency COVID-19 Leave and all of their own earned leave they will need to take Leave without Pay if they still cannot return to work or aren't going to be recallable while on Paid Admin Leave.
 - e. Be placed on **Paid Admin Leave**. If an employee is a non-essential employee, was on Paid Admin Leave prior to taking any leave and is requesting to be put back on Paid Admin Leave they must understand that they are recallable to work at any time during what would be their normal working hours. **An employee on Paid Admin Leave who does not respond to a phone call etc. during what would be normal working hours is subject to disciplinary measures due to being considered AWOL (Absent Without Official Leave.)**

4. Director and Program Manager Responsibilities:

- a. Ensure each employee on Paid Admin Leave is accounted for.
- b. Submit the proper paperwork, timesheets and leave forms, to put an employee on Emergency COVID-19 Leave if they qualify.
- c. Track all employees time while on Emergency COVID-19 Leave so that when it is exhausted the employee is taken care of in one of the ways noted in (3) above.
- d. It is the responsibility of Directors and Program Managers to account for employee time. Losing track of an employee's time that results in paid time where not authorized may result in disciplinary measures against the Director and Program Manager. It is your duty to ensure each of your employees are taken care of and accounted for in the proper manner.

PROTECTING YOUR FAMILIES MENTAL HEALTH

Many parents throughout the United States have expressed concerns regarding the impact that the coronavirus pandemic is having on their mental health and the emotion wellbeing of their family. Kids and teens have also expressed concerns about increased anxiety, depression and stress from COVID-19. Parents have been asking how can I protect my own mental health as well as the emotional well-being of my family.

The good news is there are steps that parents can take to help protect their family's mental health during this difficult period.

Knowing this will end

It may feel as though this will never end so remind yourself and your kids that these changes are not permanent. This in and of itself can make it much easier to cope.

Make Social distancing and Self-Quarantining manageable

Staying as close to your normal daily routine as possible. Normalcy is one way to help reduce the stress and worrying that may result for social isolation and self-quarantine. For example, if your family is use to waking up at 7:00 a.m. every morning, setting down for breakfast, and then getting dressed for your day, then keep this schedule. Having as much normalcy as possible can reduce the anxiety and worries that you and your family may be experiencing and make the transitioning back to regular life easier. Because most kids are doing school at home make sure to schedule a time for school work

Physical Activity

Isolation can trigger depression and anxiety or increase symptom in people who may have already had preexisting mental health problems. Making sure your family is getting plenty of physical activity may be difficult due to restrictions. However, families can do activities that will keep their minds and bodies physically fit during this time.

Here are some fun ideas to stay physically fit right in your own home.

Dance: Turn up your favorite music and dance around. Feel free to sing along as you and your family dance. Turn it into a dance contest, older generation against the younger generation or play freeze dance. Learn some new moves from each other.

Balloon Volley Ball: If you have a balloon setting around play some balloon volley ball, practice your serving skills and head-bumping.

Create your own exercise routine: take turns instruction the class to your favorite music.

Activities

Schedule a family activity time to enjoy activities such as arts and crafts and reading. Use materials around the house make new items to decorate a room. For example, turn old picture frames into serving trays.

Put on a family play: Assign roles and even design and make props. Stress is reduced when you are enjoying life.

Staying connected: It is important to our mental health to stay connected to our love ones. SKYPE, Face Time or Call a friend or relative. Write a letter to a friend or family member, make up a secret code to make it more fun.

Going outside is important. The sun helps activate the part of your brain that promotes happiness. Walking is something that the family can do together, walk a couple times around the yard. Focus on sights, sound smells and see who has the keenest sense. Jumping rope is another fun way to stay fit and get some outside time in.

Limit your family's exposure to news

Many people find themselves listening to the news and it may be tempting to listen 24/7. However, this can increase anxiety and depression in both kids and adults. Limiting how often you listen to the news to a couple hours a day. Try to focus on the positive news. Make sure that the news is not playing in the background.

Alcohol and Drugs

Substances such as alcohol and drugs can increase anxiety and depression and make being together as a family difficult and even dangerous. Eliminating alcohol and drug use during isolation can reduce anxiety, depression and stressful situations. If you find that you are having difficulty reach out to a counselor for help.



Individuals who received an Absentee Ballot may vote at the polling site on election day, however, the Election Board will take steps to ensure that no one is allowed to vote more than once.

For the last 20 years, I have learned first-hand about the important issues currently facing our tribe and I have worked hard to make a significant contribution. Our tribe has outside people, cities and state governments today that threaten our tribal sovereignty. The challenges we face in our tribal government, from nearby communities, outside businesses, infrastructure and the environment are affecting the quality of life of every Hualapai Tribal member. Today, we must balance our tribal government thru understanding of our tribal enterprises, tribal departments and tribal members. Each enrolled tribal member should have the right to tribal employment, tribal housing and tribal benefits.

My experience as the past executive officer with Grand Canyon Resort Corporation and past Board of Directors Chairman is very important knowledge in our Tourism Industry. Visitors from around the World come to Grand Canyon West to see the Grand Canyon and experience our Hualapai Tribal Culture. The Hualapai Tribe generates all their revenue from Tourism Operations. 3. Am I in favor of making changes to the Tribal Constitution?

Our tribal constitution is in the process of being revised and updated. I believe that the proposed changes to the constitution are necessary to protect the interest of “the Hualapai People.” In this day and age our Tribal Government is challenged, in which the interpretation and language of the constitution can be misconstrued compromising the Hualapai Tribe’s position.

4. My views on the separation of powers; Legislation, Judicial, GCRC, and Tribal Administration?

The separation of powers is necessary when it comes the Judicial System to maintain the Courts integrity. Legislation is proposed and approved by Tribal Council, in which the Law Enforcement Committee and the Hualapai Tribal Court Board can be more effective by being more of working committee to measure the legitimacy of proposed changes, amendments and or rulings.
