The following shall apply:

<u>Hualapai Constitution</u>, <u>Article VIII</u>, <u>Elections</u>, <u>Section 4</u>. <u>Nominations</u>. Any tribal member may submit his name to the Election Board as a candidate for tribal office in accordance with this article and the procedures outlined in the election ordinance.

Hualapai Constitution, Article VIII, Elections, Section 5. Qualification for Office.

- (a) Any member of the Hualapai Tribe shall be eligible to run for tribal office if he:
 - 1. is at least twenty-five (25) years of age, and
 - 2. is a resident of the reservation for at least one (1) year, and
 - 3. has never been convicted of a felony or been convicted of three (3) misdemeanors within the last twelve (12) months, whether by Tribal, Federal, or State Court.

Hualapai Tribe Election Ordinance, Article IV, Qualifications, Section 1, Part C, Subpart 1. For residency, candidates shall sign a statement that they have maintained and lived in the primary residence on the reservation for at least on year immediately prior to the general or special election, and if elected, they shall maintain and live in a primary residence on the reservation through the duration of their term.

IT - Question from Robert Bravo - How can you say they are outdated when you haven't visited the lab or done more research?

Acting Administrator Marshall informed Mr. Bravo that Brook follow up with him in regards to the test kits.

Member - in regards to the COVID 19 guidelines, is the team able to work with HR to make amendments to it. Yes, they have been working with HR on behalf of the employees.

Member Havatone excused at this time.

For the record: 6 present, 3 excused.

Patricia Imus via zoom. Commented that has been on-going since March and haven't figured it out yet. This is another opportunity for another test lab, hears Ms. Marshall wanting to hear the presentation. Plus other concerns not on the agenda at which time a point of order by a council member.

Acting Administrator Marshall responded to some of her concerns.

Pankow reported at last three funerals about 80% wear their mask, the spread by contact not the air. It is the individual's responsibility as the guidelines are already mandated.

Consensus of the council for the ERT to implement and follow the SOP for the burial services.

Road block recommendations was discussed and per Rosemary this will not move forward.

Further discussion:

Regarding the Guide and may compile into one for community and employee, extra home kits with concerns of tracking and monitoring. Some resistance from positives to go to IHS. Suggestion to get EMS to do test by their medical staff, mainly weekends.

Curfew for minors, enforcement if parents don't do their part.

Life is a gamble, no matter what is established still the people will do their own thing.

ASSESSEMENT CALENDAR UPDATE

Due to technical difficulties, we have had to modify our testing schedule. Both parts of the Arizona Science test (AzSCI) were administered to 5th and 8th grade students today. Since that has gone off relatively smoothly, we will continue with our testing as follows:

04/07 - Writing, Grades 3-8

04/12 - Oral Reading Fluency, Grade 3

04/13 - Math and Reading (Part 1). Grades 3-8

04/14 - Math and Reading (Part 2). Grades 3-8

Most test sessions will be completed during the morning when students are fresher and more likely to be successful. Please try to schedule any appointments for your students in the afternoon whenever possible.

Once a student begins a test session, they must complete it – they cannot leave school and then return to that test. If you know your student will miss a portion of a testing day, it will be better for them to not start the test session and make it up on another day, rather than rush through it.

STUDENT CONDUCT

For whatever reason, we have seen an increase of inappropriate behaviors recently. Here are just a few:

- Medication (both over-the-counter and prescription) being brought to school without being checked in to the office by a parent/guardian;
- Other inappropriate items being brought to school expensive toys, pocketknives, gum, cash;
- Dangerous behavior and damage on buses changing seats, yelling, throwing things, writing on and poking holes in the bus seats;
- General meanness and classroom disruption bullying, name-calling, stepping on other's shoes, knocking things off other's desks, not following directions.

Please take a few moments to talk with your student about what is and is not appropriate for school. Everyone deserves the opportunity to learn without such issues.



HOW CAN I HELP MY STUDENT?

- Have them go to bed on time Especially during testing season, students will perform better when they are well-rested.
- Have them eat breakfast If there isn't time at home, remember they can always have breakfast here at the school.
- Discuss with them about doing their personal best—
 The state is expected to use our student achievement
 results to assign the school a letter grade. As part of
 the state funding formula, schools who achieve high
 letter grades are eligible for additional funding for
 their schools.



Putting Positive Parenting into Action with Young Children

Raising a young child comes with both joys and challenges, and no parent is perfect.

To help families do their best in guiding their children's healthy development, Arizona's early childhood agency, First Things First (FTF) has partnered with the national early childhood organization, ZERO TO THREE, to promote Positive Parenting, an approach that focuses on building loving relationships with children through everyday moments — even when those parenting moments aren't





"Parenting is a forever learning process, and all parents want to do the best they can," said Kat Willard, FTF's senior director for family support and literacy. "The latest research tells us that when parents make time to connect with their child through everyday moments it helps the child learn how important and cherished they are."

Research also shows that today's moms and dads turn to online content, especially videos, when looking for guidance on parenting. That's why FTF collaborated with ZERO TO THREE on a series of videos and online content that highlight nine elements of Positive Parenting, which include being able

to imagine your child's point of view; providing consistent, age-appropriate guidelines and limits; and recognizing and regulating your own feelings before responding to your child.

Parents and caregivers who visit FTF's <u>Positive Parenting</u> page at <u>FirstThingsFirst.org/resources/positive-parenting/</u> will find short videos, parent interviews and other information that will engage and encourage parents of babies, toddlers and preschoolers.

For example, one music video reminds parents that a child's perspective is a lot different so it's important for parents to try to imagine their child's point of view, especially during tough moments.

"One of my favorite things to do at meal times with my children is talk about the favorite parts of their day, as well as a part of our day they didn't like," Willard said. "It provides me with the opportunity to respond to my children with interest and sensitivity and to expand on their ideas or thoughts."

Parents should come to the realization that positive parenting isn't about being perfect," said Rebecca Parlakian, ZERO TO THREE's senior director of programs.



"It's about building loving connections with our children through everyday routines," she said. "When we make mistakes, as every parent does, it's important that we take the time to reconnect with our child and learn from those moments. The power of being a parent is that we get to choose how we build our own family — which patterns to continue from our own childhood and which to leave behind."



HOW TO BECOME A WILDLAND FIRE FIGHTER

Interested individuals that are looking to become a Wildland Fire Fighter for the Hualapai tribe, here is the information that will help you to become a fire fighter.

There are Wildland Fire Fighting agencies that operate nationally like the Bureau of Land Management, National Park Service, Forest Resources that provide a service to train and employ the public to be fire fighters in the efforts to combat the risk of unwanted wild Service, Bureau of Indian Affairs, US Fish and Wildlife Services and at the local level in the State of Dept. of Forestry and Natural and fires that endanger the public and can destroy community residences and property.

Federal agencies and state departments provide wildland fire training to interested individuals in being part of a team in supporting the suppression efforts in fighting wildland fires.

Here are the requirements.

- Introduction to ICS and L-180 Human Factors in Wildland Fire Service that must have an overall passing score of 70% or The second requirement is the basic firefighting courses S-130 Fire training, S-190 Introduction to Fire Behavior, I-100 •
- Third requirement is a Work Capacity Test that consist of physically walking 3 miles in 45 minutes with a 45 lb. pack to ensure that the individual is physically fit and can perform the capabilities as a wildland fire fighter

As you become qualified as a fire fighter, and become more experienced on the fire line, there are advance training courses available both online and schedule of trainings by your home unit. See below training schedule.







Elders Tell Their Story • Hualapai Heritage: Charlie Vaughn-McGee

HUALAPAI HERITAGE: CHARLIE VAUGHN-MCGEE

On my mother's side, my great grandfather was known as Cap or Indian McGee. You look around the community of Peach Springs, I am told that McGee or even my last name Vaughn is of Irish connection. Looking at our history, in the 1860's after the Civil war, many of the soldiers from the war joined the Cavalry and came west. A lot of them ended up here. They were charged with taking a census. My mother tells the story of how her grandfather, my great grandfather

received the name McGee. The Hualapai's were in line for the census. Back then everyone spoke Hualapai. When they came to my great great-grandmother, she was carrying her baby (my great grandfather). He was crying very loud. The census taker asked what the babies name was. My great great-grandmother simply replied dhu-me-gi-juh (the one who cries a lot). When she said that in Hualapai, the soldier census taker being of Irish decent said, "Oh, that sounds like McGee." and wrote McGee on the census. So that is how the name came to be and that was my mother's maiden name.


