# LA PAZ TRAIL OF TEARS RUN 2022

THURSDAY APRIL 21, 2022

Camp Beale Springs, Arizona to Peach Springs, Arizona

*In the 1830s, the US government passed the Indian Removal Act to remove Indigenous Peoples from their homelands. President Andrew Jackson signed the Indian Removal Act because they found gold in the mountains where the Cherokee People lived. This Act included all Indigenous Peoples in the US. The US government decided that white settlers should occupy the land by removing all Indigenous Peoples from their original homelands.*

*By the 1870s, white settlers began moving into Pai territory, which ultimately started the Hualapai Wars. The Pai leaders and warriors fought hard to protect the People and the land, but the white settler's diseases, viruses, and cruelty overcame them. From 1871-73 the Pai Peoples were removed from their homelands and force-marched to two locations, Fort Beale and Fort La Paz, also known as Beale Springs and La Paz.*

*The People endured abuse, neglect, and death. They did not give up and in due course escaped on April 21, 1874. They all went their different ways, including the Hualapai. The Pai People tried to return to their original Bands' homelands only to find that the white settlers occupied their lands. Our ancestors were homeless for almost nine years, but they did not give up. Our ancestors had strong leaders who were successful in negotiating an executive order for the land that we now occupy. Our ancestors were successful in passing down our history and the location of our original ancestral territories. We honor them through the La Paz Trail of Tears Run, each year on the day they escaped.*

On April 21, 2022, after a two-year hiatus, the La Paz Trail of Tears Run took place. Due to the COVID-19 pandemic, the Run did not happen in 2020 and 2021. 2019 was the last Run before the pandemic. 2020 would have marked the Run's fourth year, which would have been the run from Ehrenberg or Fort La Paz to Peach Springs. Instead of holding the four-year Run to make up for it, we decided to move forward and continue the cycle of the run. The four-year run is scheduled for the year 2024.

This year the run started in Camp Beale Springs and ended in Peach Springs, Arizona on the Hualapai reservation. There were forty-four runners, which included the Tribes eldest member, Grant Tapija, Jr., who is 93 years old. Mr. Tapija runs every year and does not drink water, so that he can feel what our ancestors felt during their encampment and escape. His two lovely granddaughters, Rondi Quasula and Calvina Putesoy, accompanied Mr. Tapija; and both women stayed true to their grandfather's tradition of no water.

Unlike other years, this year's Run was different, especially for the community members. Food was not served at the monuments on April 16 and on the day of the Run on April 21; and there was not a pre-run dinner for the runners and community. Many of the things that normally occur did not happen due to the pandemic. The goal of the Run was to do the Run and to complete the Run to mitigate a spike in COVID-19 cases. If cases do not spike, then we can say that we accomplished our goals and can look forward to a full schedule of events at next year's La Paz.

Therefore, I would like to thank all of those who ran, drove, policed, submitted art, ordered t-shirts, and hosted the story telling to make this Run happen in the best way possible. First, I would like to thank my amazing Staff at Cultural Resources:

Carrie Cannon (Ethnobotanist) for gathering the sage for the wreaths; Crystal Bender (Receptionist) for collecting and recording runner registrations; Jorigine Paya (Language Manager) for telling the La Paz story; Lyndee Hornell (Cultural Tech II) for handling all of the media, fliers, and outreach; and Marcie Craynon (Administrative Assistant) for all of the administrative duties such as requisitions, orders, reservations, and shopping for food and supplies.

Secondly, I would like to acknowledge the foundation of the Run this year. Their dedication to honor the ancestors and to help bring them home exemplifies who we are as a community. If I forgot anyone's name or department, please accept my apology.

## Hualapai Bird Dancer heals self, others through dance

For 80-year-old Ernestine Claw, dancing is a way to connect with her culture and heal herself and those around her.

As a Hualapai Tribe Bird Dancer at Grand Canyon West, Ernestine began dancing with her friends as an adult. From visitors at the Grand Canyon, to promotion commercials, Ernestine said she has danced in front of millions.

"And they all wanted to take me home with them," Ernestine said with a laugh.

Hualapai Bird Dancing celebrates and blesses the land around us, from the smallest rocks to the largest trees. Ernestine said she sings and dances for Mother Earth.

"We say she's the one who grew the plants on the land and fed us like a mother," Ernestine said. "Water, fish, rabbits ... that was Mother Earth."

The traditional attire worn during the dances also represent different aspects of nature. For example, the beaded capes represent a bird's chest and the shawls represent their wings. The ribbons sewn around the skirts represent different elements, such as water.

A descendant of Chief Hualapai Charlie, Ernestine recalled spending her early years in boarding school where she and other children

were punished for speaking their language and practicing their culture. It wasn't until Ernestine was middle-aged that her friend, Marlene Havatone, taught her Hualapai Bird Dancing.

After learning the basics, Ernestine began performing at the Grand Canyon West with her group, the Sugar Bears. They named their group the Sugar Bears since they all had diabetes.

Prior to being a mother, grandmother and dancer, Ernestine and the late Florence Hunter, also a member of the Hualapai Tribe, worked at KRMC, as laundresses. Besides being a maid at the hospital, Ernestine was the unofficial translator for Indigenous people who did not want to communicate their medical needs with doctors.

"They didn't really want to tell the nurse or doctor what's giving them problems," Ernestine said. "So they tell it to me in my language and then they don't know that I tell the doctor or nurses what's wrong with them."

Sonja Claw, one of Ernestine's eight children, said she and her siblings were not taught the language her parents grew up with. She recalled stories from her parents' childhood when they were both taken from their reservations and put into boarding schools.

"They were put in boarding school. They were told not to speak their language, to not practice their customs. It really hurt her," Sonja said.

Ernestine was punished for simply greeting her friends in her native language and being confused by her teacher's reaction. Sonja said her father also experienced a similar upbringing.

"It was really sad to hear that because they were only kids," Sonja said. "You hear those boarding school stories and they're true. My parents went through that."

Sonja said she is inspired by her mother's talent and kindness. She sees how she engages with people during performances and doesn't take no for an answer when she invites them up to dance.

"She has a sweet spirit about her," Sonja said. Ernestine said at first it was daunting to perform in front of so many people, but traditionally, they do not look at the audience while performing. Instead, they look down at the ground.

"That's one of the traditions," Ernestine said. "We just look at the ground or how we're dancing." Sonja doesn't dance, but said the intricate dancing comes naturally to her mother. Sonja used to drive Ernestine



to her performances and would sit at the Grand Canyon all day watching her mom dance and interact with people. "She likes to tell the children, 'come,' and she'll take their little hands and she'll show them simple little steps to do and they feel so happy because they're performing," Sonja said.

She said performing at the Grand Canyon West made her "blossom" and reconnect with her culture that was nearly taken from her at a young age. "She is one of the last few in our family that is still carrying our traditions," Sonja said.

Ernestine also credits her friend Sylvia Jackson, who recently passed away from COVID-19, for inspiring her to dance. Marlene also passed away several years ago, which made Ernestine reluctant to dance since she could no longer dance with her friends.

Due to COVID-19, Ernestine only recently started dancing again. Due to the lockdown and mourning the loss of friends, it was hard for her to start performing again.

"She wanted to carry on the tradition," Sonja said. As an 80-year-old, Ernestine is able to dance for hours at

a time. She said that dancing is what takes all of her pain and tension away.

"Mom's told me so many times, 'I get in that circle and all my aches and pains go away. I'm free to just fly.' And then she flies," Sonja said.

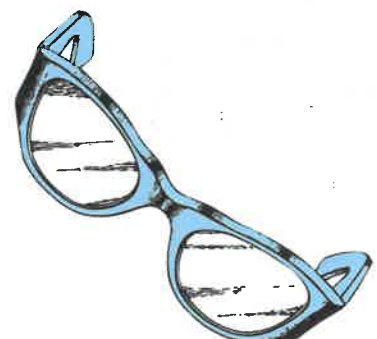
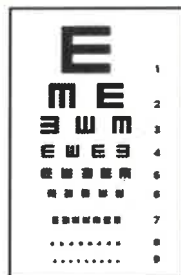
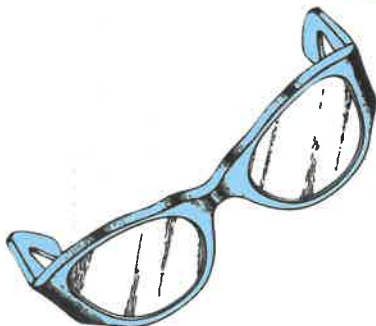

#### **The following shall apply:**

**Hualapai Constitution, Article VIII, Elections, Section 4. Nominations.** Any tribal member may submit his name to the Election Board as a candidate for tribal office in accordance with this article and the procedures outlined in the election ordinance.

**Hualapai Constitution, Article VIII, Elections, Section 5. Qualification for Office.**

(a) Any member of the Hualapai Tribe shall be eligible to run for tribal office if he:

1. is at least twenty-five (25) years of age, and
2. is a resident of the reservation for at least one (1) year, and
3. has never been convicted of a felony or been convicted of three (3) misdemeanors within the last twelve (12) months, whether by Tribal, Federal, or State Court.

**Hualapai Tribe Election Ordinance, Article IV, Qualifications, Section 1, Part C, Subpart 1.**

For residency, candidates shall sign a statement that they have maintained and lived in the primary residence on the reservation for at least one year immediately prior to the general or special election, and if elected, they shall maintain and live in a primary residence on the reservation through the duration of their term.

## VOTING AT THE POLLS KNOW YOUR RIGHTS

Voters may bring in someone to assist them in voting as long as they are not a candidate on the ballot, the voter's employer, or an agent of the voter's labor union.

Voters may also bring in guide animals or assistive devices.

Language assistance is available at many polling places. Navajo language assistance is available on the Navajo Nation, Apache language assistance is available on the San Carlos Apache reservation, and Spanish is available in Yuma, Maricopa, Pima, and Santa Cruz counties.

Alternative formats are available from many counties. These formats include large print, Braille, and audio recordings.

Each polling place is equipped with a touch screen machine capable of large print and an audio representation of the ballot.

Special Election Boards are available in some counties for homebound voters.

The polls officially close at 7:00 PM and no new voters may get in line after that time. Everyone in line at 7:00 PM will be given the chance to vote.

Children are allowed into the polling place with you but should not be allowed to disrupt other voters.

## PROOF OF IDENTIFICATION

- THE VOTER SHALL PRESENT ACCEPTABLE IDENTIFICATION WHEN VOTING IN PERSON:
- BEARS THE NAME, ADDRESS, AND PHOTOGRAPH OF THE VOTER (SEE LIST 1), OR
- TWO DIFFERENT FORMS OF IDENTIFICATION THAT BEAR THE NAME AND ADDRESS OF THE ELECTOR (SEE LIST 2), OR
- ONE FORM OF ACCEPTABLE PHOTO IDENTIFICATION WITH ONE FORM OF NON-PHOTO IDENTIFICATION THAT BEARS THE NAME AND ADDRESS OF THE ELECTOR (SEE LIST 3)

### ID List 01

- Valid Arizona driver license
- Valid Arizona non-operating identification license
- Tribal enrollment card or other form of tribal identification
- Valid United States federal, state, or local government issued identification
- An identification is "valid" unless it can be determined on its face that it has expired.

**NOTE:** As of 2019, Arizona voters are now required to bring identification to vote in person at an early voting location. The only ID you need to vote by mail is your signature.

### ID List 02

- Utility bill of the elector that is dated within 90 days of the date of the election. A utility bill may be for electric, gas, water, solid waste, sewer, telephone, cellular phone, or cable television
- Bank or credit union statement that is dated within 90 days of the date of the election
- Valid Arizona Vehicle Registration
- Indian census card
- Property tax statement of the elector's residence
- Tribal enrollment card or other form of tribal identification
- Arizona vehicle insurance card
- Recorder's Certificate
- Valid United States federal, state, or local government issued identification, including a voter registration card issued by the County Recorder
- Any mailing to the elector marked "Official Election Material"
- An identification is "valid" unless it can be determined on its face that it has expired.

- Any valid photo identification from List 1 in which the address does not reasonably match the precinct register accompanied by a non-photo identification from List 2 in which the address does reasonably match the precinct register
- U.S. Passport without address and one valid item from List 2
- U.S. Military identification without address and one valid item from List 2
- An identification is "valid" unless it can be determined on its face that it has expired.



### Other tips when voting

- "Rush hour" at the polls occurs the first hour that the polls are open at lunchtime, and after 5 PM, if you are able to vote mid-morning or mid-afternoon there will be less congestion.
- Be sure you are at the correct polling place so that you don't stand in line unnecessarily.
- Use your sample ballot to pre-mark your choices; bring it with you to the polls and simply transfer your selections to the official ballot once you are in the polling place.
- Update your registration whenever you move so that your information will be correct in the Signature Roster.

## ID PROVISIONS FOR AMERICAN INDIANS

Tribal IDs are an acceptable form of ID to vote at the polls. Depending on the type of tribal ID, another form of ID may be needed. Check with your Tribe or tribal subdivision to see if other forms of ID, other than your tribal enrollment ID, are acceptable to use when voting at the polls. These could include a voter registration card for tribal elections, or a home site assignment lease.

"Rush hour" at the polls is typically the first hour that the polls are open, lunchtime, and after 5:00 pm. If you are able to vote in person midmorning or midafternoon, there will be less congestion.

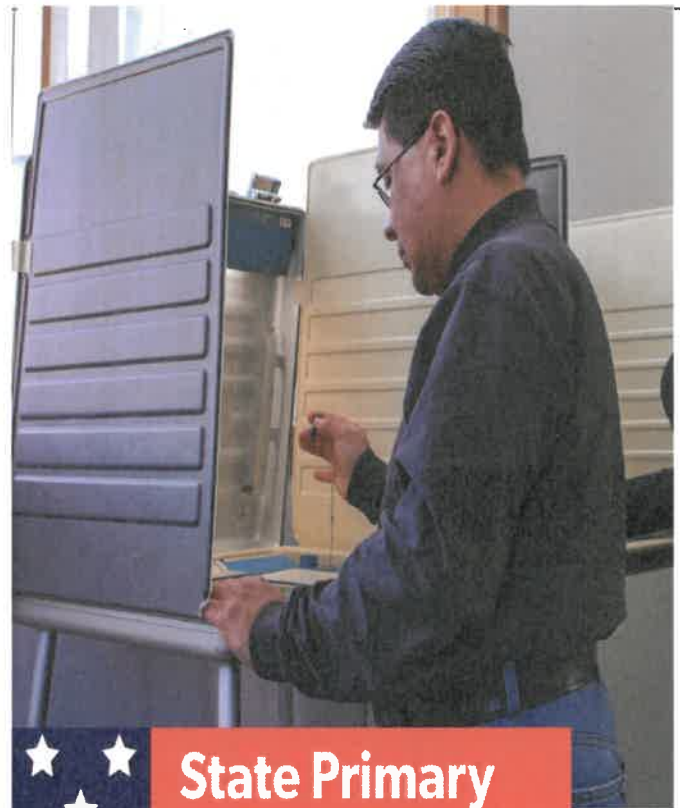



Team Update:

COVID Stats—Cheyenne Majenty

Cheyenne reports that the community has de-escalated to Code Orange; this alert went into effect last night at 5 pm and is due to less community spread of COVID-19. Notifications have been issued out to the community via social media, and the radio station. Cheyenne provides a breakdown of Code Orange for community awareness.

Rosemary and Brook submitted their resignations from the Hualapai Emergency Response Team and the Hualapai Health Advisory Board. Their concerns with recent issues with funeral arrangements in the community, and their thought that Tribal

Council does not support their efforts, and to their resignation.

Tribal Council express their support for the team. There was a lengthy discussion in regards to the team's role and their authority.

Brook reports there have been several tribal members who have been asked to have the vaccine payout deadline to be extended, as there have been vaccine pods in the community. This will support the team's effort to increase the community's herd immunity.

Employee Guidance will be transferred to Tribal HR so they may oversee the portion of the team's role, in addition Tribal HR will work closely with GCRC to ensure they are following the tribe's direction.

Test Kits have been ordered from the Federal Government, by April the latest.

Community Guidance encourages gathering, it just provides direction on how to safely host meetings and gatherings. The funeral protocol can be amended. There have been issues with majority of funerals in the community when it comes to enforcing the funeral protocol.

HR will decide if employees will be tested weekly.

Brook states himself and Rosemary will remain active until next Tuesday (February 15, 2022). The council will have to seek alternates to fill their roles.

**Motion: to accept resignations from Rosemary Sullivan and Brook Bender, from the Hualapai Advisory Health Board and the Hualapai Emergency Response Team, effective February 15<sup>th</sup>. Second. Discussion: Clarify that the effective date will be February 15, 2022. Vote: 6 approve, 3 opposed. Motion carried.**

**Motion: to amend due date for the Vaccine Incentive Pay out from February 28<sup>th</sup> to April 1, 2022. Second. Vote: All in favor. Motion carried.**

He has applied for the CEO position and was informed that he was not accepted to apply for the position; while the position still remains advertised as open.

The GCRC Board is here, and will be looking into Mr. Fox's concerns.

### HOW TO BECOME A WILDLAND FIRE FIGHTER

Interested individuals that are looking to become a Wildland Fire Fighter for the Hualapai tribe, here is the information that will help you to become a fire fighter.

There are Wildland Fire Fighting agencies that operate nationally like the Bureau of Land Management, National Park Service, Forest Service, Bureau of Indian Affairs, US Fish and Wildlife Services and at the local level in the State of Dept. of Forestry and Natural Resources that provide a service to train and employ the public to be fire fighters in the efforts to combat the risk of unwanted wild land fires that endanger the public and can destroy community residences and property.

Federal agencies and state departments provide wildland fire training to interested individuals in being part of a team in supporting the suppression efforts in fighting wildland fires.

Here are the requirements.

- The first requirement is taking a Physical that must be done through Medical Standards and must be completed prior to being certified wildland fire fighter. The tribes fire management and participant will be notified and provided a schedule for the physical examination that is to be completed.
- The second requirement is the basic firefighting courses S-130 Fire training, S-190 Introduction to Fire Behavior, I-100 Introduction to ICS and L-180 Human Factors in Wildland Fire Service that must have an overall passing score of 70% or higher.
- Third requirement is a Work Capacity Test that consist of physically walking 3 miles in 45 minutes with a 45 lb. pack to ensure that the individual is physically fit and can perform the capabilities as a wildland fire fighter.

As you become qualified as a fire fighter, and become more experienced on the fire line, there are advance training courses available both online and schedule of trainings by your home unit. See below training schedule.
