The Chair and Vice-chair oversee the Hualapai tribal departments as the tribal administrators.

The Hualapai council oversees the Grand Canyon Resort Cooperation Board members.

Therefore, for any reason by petition, can a Hualapai tribal member over the age of 18 years can recall any council member at any time during their term.

The Hualapai council through the code of ethics can hold chair and vice-chairperson or any other council members if proper documents are filed against them, accountable with the code of ethics.

Chair and vice-chair person work with tribal department director has to oversee their programs but the council as a whole, make motion to approve and remove directors at any time.

The Hualapai council motions to approve and remove GCRC board members at any time.

The reason I bring this chart to your attention is for your understanding of who can hold whom accountable at any time during their term or position. Remember it takes majority (5) members out of a nine member's to approve or deny a motion or action.

I believe it is time to start the dialogue to hold people accountable for how the tribe, tribal departments and the GCRC is functioning at this time. Accountability is what Hualapai needs and wants.

On January 14, 2023, you will have a choice to make while you vote for your next Chairperson of the Hualapai Tribe and I say this with confidence, I am willing and able to take on the job and duties this position entails. I am one vote on a nine-membership council but my votes and decisions will continue to be on behalf of the Hualapai membership and the future generation.

- Use survey to learn about success to food in the community

- Collected from Trunk-or-Treat event, Tribal Departments, Elderly Center participants, SDPI participants, and from going door-to-door.
- Almost 50% of Hualapai Community members face food insecurity
- Ages 70+ are much more likely to face hunger
- Hualapai community members are 4x more likely to have a hard time getting food than the population of the state of Arizona.

 Those who are employed, make under \$14k, rely on food assistance and those who buy food monthly are less likely to be able to afford enough food.

- Grandparents and extended family member who are raising children are more likely to face hunger
- Household with more children and people face higher levels of hunger
- Those with gardens are more likely to get all the food they need. Over 50% of the community is interested in gardening.
- People often learn purchasing and eating habit from family members.

Hualapai Tribal Forestry—Melvin Hunter Jr.

Melvin is here to receive authorization to request additional funding for P.L. 93-638 Indian Self-Determination and Education Assistance to train staff on specific procedures such as updating Annual Funding Agreements and the relation to Budget Formulation. The Program Coordination Specialist will work extensively with the Hualapai Tribe Region and the La Paz/Mohave Region and follow the implementation plan that will apply to La Paz and Mohave Counties. The Program Coordination Specialist will carry out the strategic service coordination plan that will connect families to appropriate resources (including the development and ongoing update of region-specific resource guides); sustain the coordinated referral system in place so that families receive services from the program that best meets their needs; increase collaboration between agencies; and educate health care, child care and family support providers on community resources so that referrals are made to the most appropriate service providers.

Distinguishing Characteristics

The ideal candidate will enthusiastically support the vision and mission of First Things First and possess the personal qualities of integrity and credibility. They will have the proven ability to work within teams to accomplish multiple tasks and keep various projects organized and progressing.

The ideal candidate will enthusiastically support the vision and mission of First Things First and possess the personal qualities of integrity and credibility. They will have the proven ability to work within teams to accomplish multiple tasks and keep various projects organized and progressing.



Professionals implementing service coordination strategies have knowledge of and experience in the following:

- Human services systems and community development.
- Facilitation, working effectively with groups, coalition building, community organizing or systems development and change.
- Using tools and resources to assess systems coordination.
- Demonstrate culturally responsive practices in working with diverse families and children, including the impact of regional and cultural factors related to tribal communities and at-risk populations of people; however, this is not a direct service provider position.
- Familiarity with appropriately handling sensitive and/or confidential sharing of information.
- Have an understanding of early care and education.

Typical Duties and Responsibilities

Under the guidance of the La Paz Mohave Regional Director, the Program Coordination Specialist will be responsible for executing the following:

- The position requires substantial effort to coordinate and work with stakeholders, including local providers, governments, the volunteer Regional Council members and internal First Things First staff.
- Work extensively with the Mohave/Hualapai Program Coordination Specialist.
- Gain a strong familiarity of the regional needs and assets reports to identify community assets, needs and service gaps as it relates to the service delivery system in the identified service area(s).
- Identify, engage and convene partners and key stakeholders, including participants with diverse
 perspectives, who share an interest and commitment to improve service coordination and
 represent a wide array of services. Build the interest and support for the formation of local service
 coordination groups; conduct and facilitate stakeholder meetings.
- Promote and assist with facilitation of the ongoing work of the Early Childhood System Coordination group and other stakeholders regarding service delivery.
- Implement the strategic plan for coordination of services through convening of partners to continue the work in systems change. Document progress and barriers to achieving progress.
 Update the plan as needed.
- Establish agreements, including the roles, responsibilities and shared commitments, with community partners to further enhance the early childhood service delivery system.
- Develop and maintain an early childhood resource database.
- Implement evaluation activities to assess impact, change and progress toward the coordinated service system envisioned, including quarterly and end of year progress reports. Report regularly to Regional Directors and Regional Partnership Councils.
- Research and identify resources to leverage services and funding to help support services within the communities.
- Travel to meetings located throughout La Paz and Mohave Counties, and occasionally throughout the state of Arizona to develop collaborative efforts, make presentations and meet with stakeholders. Some overnight travel is required.
- Work closely with the other program coordination specialists throughout the state, attend quarterly meetings.
- Other duties as assigned.

Qualifications:

- A minimum of a bachelor's degree in a field related to the purpose of the service coordination effort (i.e. children's health, early learning, family support, social work, organizational development or project management).
- Have a strong familiarity with the La Paz/Mohave Region.
- Knowledge of and experience in the following:
 - o Public presentations and facilitating coordination and collaboration efforts.
 - o Graphics development, production of print products, and the use of websites, social media and other forms of media to share written information.
 - Computer skills in Google Suite, Microsoft Outlook, Word, Excel and PowerPoint, as well as, database, internet proficiency and other communication devices.
 - o Researching and analyzing complex data and concepts with the ability to communicate information so it is easily understood.

The ideal candidate will:

- Have strong familiarity with the early childhood, education and health systems, including tribal education and health systems and the Indian Health Service.
- Have strong facilitation skills in leading various coalitions within the early childhood providers system.
- o Experience in coordinating efforts with providers of different programs/agencies with a focus on meeting the needs of families and children.
- o Be able to become a trainer in early childhood tools, assessments and resources in order to train community partners first hand.
- Be self-motivated, proactive and able to take responsibility for initiating and following through on tasks. Be organized, detail-oriented, and have the ability to handle multiple projects under a deadline.
- Be able to work in a fast-paced environment.
- Be able to work effectively in a team environment to meet goals.

What is WIC?

WIC is a nutrition program that helps families feed their children healthy foods. WIC provides nutrition information, healthy foods, and help accessing health care to moderate to low-income families. The program is available to families with pregnant women, new mothers, and children under the age of five.

What Can WIC Offer My Family?

Benefits that can be used at the grocery store to buy healthy foods like milk, yogurt, whole grains, beans, juice, eggs, cheese, cereal, peanut butter and fruit and vegetables. Information about nutrition and health to help you and your family eat well and be healthy. Help with breastfeeding your baby, Help in finding health care and other community services, and Breast pumps to help you breastfeed even when you return to work

Can My Family Enroll In WIC?

WIC is for all kinds of families – families with married or single parents and those who are working or not working. WIC has different requirements than SNAP (Food Stamps) so even if you don't qualify for SNAP, you may still qualify for WIC. If you are a father, mother, grandparent, foster parent or other legal guardian of a child under 5 years of age, you can apply for your child.

If you are a woman who is pregnant, breastfeeding, or has a baby up to six months old, you can apply for yourself.

REQUIRED Documents:

- 1. Identification for all clients
- 2. Proof of residency
- 3. Proof of income

Examples of proof of identification are:

Driver's License or state issued identification card Birth certificate Immunization record

Social security card AHCCCS card

Tribal enrollment card

Hospital card for newborn baby

Examples of proof of residency are:

Driver's License or State issued ID Card

Bank statement Utility bill

Payroll stub

Rent/lease agreement

Tribal enrollment card (if address is on card)

If you are pregnant, you may count your unborn child

as a family member.

Examples of proof of income are:

Current pay stub including the pay time frame

Most recent year's income tax return

Letter from employer stating your current pay

Tribal per capita check stub.

TANF benefit letter

Social security/DES benefit letter or check stub

* You are automatically income eligible for WIC services if you currently receive TANF, SNAP (Food Stamps) or Medicaid (AHCCCS).
