

**HUALAPAI TRIBAL COUNCIL
RESOLUTION NO. 13-2023
OF THE GOVERNING BODY OF THE
HUALAPAI TRIBE OF THE HUALAPAI RESERVATION**

(Master Plan Update Committee & Public Participation Plan)

WHEREAS, the Hualapai Tribe is a federally recognized Indian Tribe located on the Hualapai Indian Reservation in northwestern Arizona with authority vested in the Hualapai Tribal Council by the Constitution approved March 31, 1991; and

WHEREAS, the tribal council, as the legislative body of the Hualapai Tribe, is authorized to take any and all actions necessary and proper for the exercise of its Constitutional powers and duties, including the regulation of the use and disposition of all land within the jurisdiction of the Tribe in accordance with Article V, Section (j) of the Constitution; and

WHEREAS, the creation of the Master Plan is authorized under Article XI, Section 3, of the Constitution as follows: “A comprehensive land use ordinance shall be adopted as soon as possible after adoption of the Constitution. The ordinance shall include sections on timber management and fuel wood cutting, zoning, wildlife management, cattle management, and other natural resources management;” and

WHEREAS, the tribal council directed the Hualapai Planning and Economic Development Department in November of 2021 to update and adopt the existing draft Hualapai Master Plan; and

WHEREAS, the Planning and Economic Development Department received both private sector and tribal funding in 2022 to carry out the planning effort in 2023; and

WHEREAS, to ensure the widest possible level of participation in the effort, the Planning and Economic Development has prepared a public participation plan which begins with the formation of a Master Plan Update Committee made up of tribal council appointees, selection of meeting times and locations, ways to notify people of these meetings, ways to solicit peoples’ comments and concerns, and then the formal review of the Master Plan by the Interdisciplinary Team/Tribal Environmental Review Commission followed by review and adoption of the Master Plan by tribal council; and

WHEREAS, the Planning and Economic Development has advertised for volunteers to serve on the Master Plan Update Committee which included direct solicitation of persons serving on 15 tribal committees and boards as well from the community of Peach Springs via the Gamyu newsletter, four sign-up sheets located at: 1) Elderly Center, 2) Health Education & Wellness, 3) Tribal Administration Office, and 4) Walapai Market plus radio announcements on KWLP FM 100.9; and

WHEREAS, to help the Master Plan Update Committee with the explanation and update of the technical aspects of the background information contained in the Master Plan, the Planning and Economic Development Department requests various tribal departments namely: Natural Resources, Forestry, EMS/Fire, Police, Cultural Resources, Housing, Recreation, Health Education & Wellness, Information Technology, Tribal Utility Authority and Public Services as well as Grand Canyon Resort Corporation provide such support when requested to so by the Master Plan Update Committee; and

NOW, THEREFORE BE IT RESOLVED that the Hualapai Tribal Council does hereby adopt the Hualapai Master Plan Public Participation Plan.


BE IT FURTHER RESOLVED that the Hualapai Tribe appoints 18 members to Master Plan Update Committee as follows:
