



# **PUBLIC NOTICE**

Starting November 9, 2023 through November 14, 2023, The Hualapai Tribal Forestry & Wildland Fire Management will be conducting a broadcast burn within Compartment 13 (C-13), and misc. pile prescribed burns on the Hualapai Forest, once environmental conditions are suitable. A general area of the burn units is described below which we ask the public to avoid the areas for your own safety.

- C-13, located east of Indian 18, south of Alber's Tank, and within the general vicinity of Sage, Buck, and Hog tank, see map attached.
- Misc. Pile Burns (forest wide), no map attached.


The purpose of the burns is to reduce the hazardous fuel accumulation in Ponderosa pine stands, improve forage for wildlife, and return fire to a fire adapted ecosystem. The burns will reduce the potential of catastrophic wildfires and restore the fire regime.

In the interest of public safety, roads accessing C-13 may be closed at times and will remain closed until the roadways are safe for public travel. Smoke plumes will be visible from Peach Springs and the surrounding area. Smoke may be present and possibly heavy at times on Indian 18 and other secondary roadways. Motorists are asked to please slow down and use caution if smoke is encountered. The duration of heavy smoke should end shortly after the burn is complete. However, light smoke may be visible for up to 3 weeks after the burn.

# **Meeting Notes**

Meeting Date: August 9, 2023, 5:15 PM

Multi-Purpose Building, 470 Hualapai Way, Peach Springs, AZ

#### 1. DINNER at 5:15 PM

2. CALL TO ORDER - Chairman Robert Bravo called the meeting to order at 5:40 PM.

#### 3. ROLL CALL at 5:40 PM:

#### Present:

Andrea Nieto, Cheryle Beecher, Clay Bravo (Zoom), Heather Nieto (Zoom), Joyce Powskey, Longfeather Fox (Zoom), Manny Siyuja, Martina Dawley, Nick Hunter, Shana Talieje and Robert Bravo

Camille Nighthorse (excused), Deborah Saganitso, Gensean Havatone-Putesoy, Loretta Jackson-Kelly (excused), Marilyn Vaughn (excused), Raelene Havatone (excused) & Sharon Wilder.

Chairman Bravo asked Mr. Davidson to review the Committee's bylaws in light of those who have missed three consecutive meetings.<sup>1</sup>

#### 4. MINUTES:

Chairman Bravo requested Committee review of the July 11, 2023, meeting minutes, with a modification to say Mr. Clay Bravo was excused. Motion to approve by Nick Hunter and second by Andrea Nieto. Meeting minutes were approved by unanimous vote.

#### 5. PROJECT SCHEDULE:

Mr. Davidson noted that at tonight's meeting the Committee is transitioning from the "Education" stage to the "Analysis of Options" stage and will begin reviewing the goals, strategies and actions in the existing Master Plan with an eye on making revisions based on what it has learned in the first three meetings and what they heard at last night's community meeting. To begin with Community Health, Mr. Davidson provided a recap as follows:

#### 6. Community Health

- a. Do we have enough access to recreation & other healthy activities? We need a sports facility (new gym, pool, skate park, tennis court), trails for walking, hiking, horseback riding, e-bikes; the Recreation Department should be open 7 days per week and not cancel planned activities.
- b. Do we have places for mental health, such as open areas where people can gather so they are not isolated? Generally, "no." Need a gathering area for community events, movie day for seniors; counseling services in Peach Springs are limited, need more mental health professionals.

- c. Do our places reflect our culture and pride in the community? Not really. Build a museum to display Hualapai history, old photographs, etc.; need a safe space to teach Hualapai language and tradition; Cultural Department should have Youth Program activities year-round.
- d. Are there healthy activities for all age groups? Somewhat. Activities are mostly focused on youth with some activities for seniors; need to have activities for those 18 to 55 years of age; prefer to have some non-competitive sports activities.
- e. What about access to healthy foods? No access: need community garden that grows traditional foods and warehouse to store them in.
- f. A question we missed and your answer. Build a cry house. Using the Multi-Purpose Building after a wake has been held there is not respectful; need a better relationship with Indian Health Services.

# 7. Cultural and Natural Resources

- a. What types of protection do you envision for any sensitive areas? Need monitors from Game & Fish, Rangers, better policing, warning signs, water protection, and better maintenance of Solid Waste Transfer Station.
- Picking up on the need for tribal monitors, Ms. Dawley noted the trespass issues and trash found at National Canyon and other places along the Colorado River she observed during the tribe's annual monitoring river trip which concluded last week. Andrea Nieto, having worked for Hualapai River Runners for over a decade, said that trash and graffiti are not uncommon and can also be found at Travertine Falls, Pumpkin Springs and other sacred sites. Trespass is becoming more common with the popularity of geocaching made possible by an application that can be carried on a cell phone.<sup>2</sup> Trespassers also cut wood and otherwise poach off the land. Chairman Bravo advised these activities to be reported to tribal council and asked if the Colorado River Management Plan (CRMP) could help the tribe in these situations. Ms. Dawley said the CRMP has not been updated but will discuss it with the Core Team (National Park Service, Grand Canyon Resort Corporation). Ms. Talieje asked if the tribe could update its own regulations and ordinances to make them less vague and more precise to empower the tribe's rangers. Andrea Nieto mentioned a 30-year-old tribal council resolution that was designed to protect the tribe's assets, such as setting the boundary of the reservation at the middle of the river vs. on the high-watermark as NPS would have us believe is their jurisdictional boundary.
- b. With discussion concluded, Mr. Davidson reviewed the second question Are there areas that should not be developed? Do not develop sacred sites, east side and pine forest areas, in flood prone areas, on hill sides, no non-recreational uses within five miles of Grand Canyon Rim; have ample land; develop on lands outside of the reservation.
- c. Moving onto the third question Are there types of development that are not appropriate to the community and reservation? Development that negatively impacts wildlife, livestock; however, tribal council may still allow this type of development; stop building around Transfer Station or relocate Transfer Station; No mining, high-rise (2+ story) buildings, bars/nightclubs, large-scale industry, power plants (large solar arrays and wind farms too), fast-food restaurants, trailer parks, large apartment buildings, pawn shops; development that generates noise, light, air and water pollution.
- d. Ms. Dawley noted that renewable energy developments such as solar and wind farms take up a considerable amount of land and, as in the case of the White Hills Wind Farm, disrupt the tribe's traditional practices such as salt gathering used for tribal ceremonies. Also, decommissioning of the facilities can be an issue. Mr. Davidson advised that regulatory agencies require energy developers post a decommissioning bond to remove the structures so they will not be abandoned in-place.
- e. Are there areas of the community where visitors are not welcome? Yes, unpaved roadways off of Route 66, Route 18, residential homes along Diamond Creek Road and other housing areas, Youth Camp

- area/east side of reservation, side canyons, north of the Walapai Market, south of the train tracks, burial grounds, cemeteries, springs, petroglyphs, need to define these areas; seems visitors are welcome everywhere.
- f. Chairman Bravo said that once hunters are issued a permit to hunt javelina, for example, they can go about anywhere on the reservation to do so. The tribe should have more rangers to keep an eye on the hunters that operate without guides. Andrea Nieto said that guides may take hunters to areas where they may not belong. In addition, staff at the Lodge will advise guests on where to walk or hike, which includes Honaga Hill Drive and Diamond Creek Road, both of which go beyond the commercial center of downtown and lead into residential areas. Furthermore, RVr's seem to park anywhere along the roadway and in tribal parking areas. Joyce Powskey advised the tribe to create rules to control these activities and otherwise corral tourists. As a counterpoint, Manny Siyuja said limiting tourism limits economic development and consequently tribal sovereignty. Clay Bravo agreed on the crucial need for economic development and noted the tribe seems to be self-restrictive. Ideally, the tribe can hire experienced cultural monitors.
- g. A question we missed and your answer. Need to update wording in various ordinances (24-70) and tribal council resolutions, must educate non-tribal members on the need to obtain trespass permits; develop disturbed areas and old/abandoned homes, new gathering places. Mr. Davidson noted three of these answers were addressed in the above discussion.

#### 8. COMMUNITY HOUSING:

Looking next at Community Housing, Mr. Davidson reviewed the four questions as follows:

- a. What types of housing does our community need? Elderly-friendly (elderly village), tiny-homes, duplexes, family homes on larger lots to avoid crowding, shelters, transitional, emergency housing, scattered housing, mobile home park/village, apartments with storage units, home-buyer housing, mutual help and more worker housing at GCW, well-built structures; better homes raise self-esteem and improve mental health.
- b. Where should new housing be located? Bull pasture area, Truxton Triangle, Milkweed, Buck & Doe Road, Valentine, on flat land adjoining Route 66, west side of reservation, GCW, along Route 18, Limestone airstrip area, and Frazier Wells (family band areas), on allotments (Big Sandy); Allow homes to be spread apart, demolish abandoned homes and re-build.
- c. Michelle Zephier, Planner I, advised that new home sites be placed east of the Buck & Doe community given the number of "infill" leases that are beginning to bump up to each other. Andrea Nieto said she would like to expand her one-acre home site vs. having more neighbors and that is why she selected a home site along Buck and Doe Road. The home site ordinance has changed over the years going from 1-acre to 5-acres to 1.5-acre maximum lot size today with the rule being that the lessee's lot size is limited to the size allowed by the ordinance in place at the time the lease was approved by tribal council. Andrea Nieto said she would like to have more garden space, possibly for tomatoes. Ms. Talieje asked if she would be pursuing commercial use.
- d. To help the discussion along in regard to how much impact new home sites would have on the existing grazing districts' ability to raise cattle, Clay Bravo advised Planning ask the Hualapai Department of Natural Resources how many acres are needed to support an AUM.<sup>3</sup> This information, in addition to the home

- site's impact on the districts' water lines and fence lines should be about the extent of their comments. Chairman Bravo asked how many acres a typical grazing district contains. Clay said the size varies; however, District 1 runs 381 AUMs (on about 187,000 acres).
- e. Assessing the overall feel of the comments gathered at the community meeting, Mr. Siyuja said they are restricting new development and otherwise holding the tribe back. Andrea Nieto said these are the comments from one community meeting and are designed to help the Committee to think about these questions. Ms. Talieje said some people at her table during the community meeting are looking at bringing manufacturing to Peach Springs. Ms. Dawley noted that the best real estate in downtown Peach Springs, along Route 66 and Diamond Creek Road, is occupied by tribal government offices, namely Planning and Information Technology, and also the public park. The highway brings nostalgia tourism so these areas should be developed to their highest and best use. However, tribal entrepreneurs and others competing with GCRC for the tourist trade will likely be squelched by tribal council so GCRC can maintain a monopoly on business on the reservation. Mr. Siyuja noted that the current business license ordinance allows people to set up shop anywhere on the reservation.<sup>4</sup> Chairman Bravo would prefer to see more tribal entrepreneurs on the reservation. Clay Bravo advised individual tribal members apply for business start-up grants on their own with tribal council providing support and endorsement as needed. Mr. Davidson reviewed the last two housing questions:
- f. Is housing rehabilitation important? Yes. Many homes are not maintained, not safe or sanitary; may pay for improvements with tribal loans, always denied by HIP; however, rehab may just be a "Band Aid" solution.
- g. A question we missed and your answer. How can we teach people to care about their homes? What lands did the tribe purchase? Communal living, sober homes; better leadership at Housing Department; educate potential home buyers on loan programs.
- h. Mr. Siyuja told the Committee he is talking to a company about setting up a sober living home in Peach Springs.

# 9. LAND USE AND DEVELOPMENT:

GAMYU

- a. Mr. Davidson turned next to the questions on Land Use and Development:
- b. Where should new tribal employment be located? New tribal Admin Building near Clinic, Buck & Doe area, central location, downtown, other suitable locations, area with enough parking, along Route 66, across from Music Mountain High School/GCRC.
- c. Where should new tribal housing be located? Buck & Doe Road, Limestone airstrip, Frazier Wells, east side of reservation, Route 18, Truxton Triangle, within community boundary, not around other homes, renovate existing homes, across from stock yard; why do we keep building new homes when people are in arrears?
- d. Clay Bravo noted that each grazing association can advise Planning on the best locations to place new homes within their districts.
- e. Do we need to expand areas identified for grazing? No. Reduce grazing areas. Yes. Expand on BLM lands.
- f. Are there areas that need new parks? In new developed areas, at Lodge for visitors, uptown area (Blue Mountain), downtown, Diamond Creek Circle, Day Care/Boys & Girls Club, Buck and Doe, near offices; let's maintain the parks we have.
- g. Do we need different types of parks? Yes. Dog Park, splash pad, swimming pool, BBQs, grassy areas, Veterans' Park needs revamping, dude ranch, and baseball field.
- h. Are there economic activities we should encourage on the reservation? & where? Need customer service training, beauty salon, coffee shop, horseback riding, bike riding, more stores, small restaurant, fast-food, dude ranch, museum, urgent care, legal aid, manufacturing, small businesses, grow and sale cannabis, job fairs, casino at Truxton Triangle.

- i. Chairman Bravo mentioned the bad reviews that the Lodge has received on Trip Advisor regarding customer service. Nick Hunter said GCRC's call center is "on it" but cannot cover for the rest of the employees at the Lodge. Chairman Bravo said the tribe should look at cannabis as a possible economic development activity. Ms. Dawley said cannabis is an organic product as compared to other modern, refined drugs and can be cultivated by those with indigenous knowledge. Mr. Siyuja recommended the tribe perform a cost-benefit analysis of having cannabis on the reservation. Andrea Nieto voiced her concerns of legalizing cannabis on the reservation. Ms. Talieje sought a middle ground with the tribe using cannabis for medicinal purposes and for export.
- j. Are there places, new places that should be developed for tourism? Welcome Center at old (Osterman) gas station, bird singing and dancing, Frazier Wells, Colorado River, Hualapai cultural restaurant, jeep & hiking tours, marathons, Quartermaster Canyon tour to the bottom; no areas.
- k. Are there places for community retail & services, like a grocery store? Along Route 66 and at Buck & Doe intersection, Family Dollar or Dollar General not a GCRC Enterprise, Buck & Doe Road (RV Park), laundromat, car wash, clothing store, art sales, tire shop, place for vendors.
- Chairman Bravo opined that the Walapai Market's goods are over-priced. Mr. Siyuja, a former manager of
  the Walapai Market, said the various CEOs hired by GCRC have had different philosophies on operating
  the market with some seeing it as a for-profit enterprise and others as a community benefit/non-profit
  charity.
- m. A question we missed and your answer. Can the tribe buy land in Kingman to build a gas station?
- n. After thinking about these questions and listening to the Committee's discussion, Cheryle Beecher said that Hualapai need to tap into their deeper spiritual beliefs. Ms. Dawley commented that Western religious traditions can be confusing to indigenous people who have not had it imprinted in their DNA over multiple generations. Mr. Hunter asked how other tribes are handling these difficult topics. Mr. Davidson said he will make inquiries with other tribes to get examples from their planning efforts. Clay Bravo said the tribe has to look at and balance law enforcement with potential revenue generation for its potential commercial endeavors.
- o. To conclude the discussion on the tribe's fee-simple land holdings off-reservation, Chairman Bravo said he was in favor of keeping the Truckee property and developing it. Ms. Talieje agreed and would like the tribe to pursue development. Mr. Davidson recounted the tribe's past attempts at rezoning which were met with opposition by the Truckee town council and the community as a whole.

#### 10. COMMITTEE MEMBERS ASSIGNMENT:

With time approaching 8:00 PM, Ms. Baheshone reviewed the next few slides on goal creation and strategy development. For homework, the Committee members will review the Master Plan's existing goals and objectives presented in the dozen-plus worksheets and report back with recommendations to "keep," "remove" or "modify" based on all they have learned since May.

#### 11. SET DATE AND TIME FOR NEXT MEETING:

The next Committee meeting will be on September 12<sup>th</sup> beginning with dinner at 5:00 PM at the Multi-Purpose Building. Ms. Dawley has graciously volunteered to provide the meal.

#### 12. ADJOURN:

# Housing Improvement Program (HIP) Applications

The Housing Improvement Program is a home repair, renovation and replacement grant program administered by the Bureau of Indian Affairs (BIA) and federally-recognized Indian Tribes for American Indians and Alaska Native individuals and families who have no immediate resource for standard housing. To be eligible for HIP assistance, you must be a member of a federally recognized American Indian tribe or be an Alaska Native; live in an approved tribal service area; have an income that does not exceed 125% of the U.S. Department of Health and Human Services Poverty Guidelines; have present housing that is substandard, as defined in the regulations 25 CFR, Part 256; have no other resource for housing assistance; have not received HIP assistance after October 1, 1986 for repairs, renovation, replacement or housing, or down payment assistance; and have not acquired your present housing through a federally sponsored housing program that includes such housing assistance. Interested applicants should contact Michelle Zephier for an Application Package containing the application, guidelines, and required supporting documentation necessary in order to qualify for eligibility. Complete applications and all supporting documentation is due by November 29, 2023.

# 2. Home Rehabilitation/Addition Assistance:

**Brief Description**: Provide funds to cover renovation, repairs or additions to the homeowner's primary residence as necessary to restore the property to habitable condition or to prevent overcrowding.

HAF funds may be used to pay the cost of renovation, repairs or additions to address property conditions or overcrowding, including pre-development costs, necessary architectural or engineering fees, construction oversight, or other costs incidental but necessary to the completion of the eligible scope of work.

Grantee may utilize HAF administrative funds to provide technical assistance to the homeowner (e.g. identifying necessary repair work).

Maximum amount of assistance per homeowner: Each Homeowner will be eligible for up to \$40,000 through this program, apply only to the homeowner's primary residence. (The maximum amount of all combined program assistance granted by HHD through the HAF program elements will not exceed \$72,300 per homeowner.)

**Homeowner eligibility criteria and documentation requirements:** Same as General Property Eligibility Criteria Across All Programs plus:

- Property will continue to be the applicant's owner-occupied primary residence once the repairs are made.
- Properties that have outstanding violations may receive assistance if corrections are addressed before funding or are included in the scope of work funded by the program.

# **Eligible Property Conditions:**

- Housing deficiencies or conditions exist which may be hazardous to occupants/residents,
- Property has a code violation or other citation, or is in danger of being cited or condemned,
   without the necessary repair,
- Property is uninhabitable or condemned and the repair is necessary to make the home habitable, OR
- Home improvements are necessary to improve accessibility and help senior residents age in place.

#### The following must apply:

- The HTM must be listed on the mortgage and deed, and copies of these documents must be submitted.
- The HTM must provide a Tribal ID or verification of Hualapai Tribal enrollment.
- The HTM Member must provide copies of documents showing household income for all household members.

Funds available, HHD will notify the Applicant in writing of this determination, the applicable policies which support the determination, and the process of appeal (if allowed).

- a. Process of Appeal. Any Applicant who is dissatisfied with a decision of HHD concerning eligibility of assistance, the level of benefit approved, or the type of services available, can appeal that decision to the Executive Director of HHD.
- b. No Appeal. If the reason for the denial of the Application is that there are no longer any HAF Program Funds remaining, such denial is not subject to appeal.

# **Program Services:**

1. Homeowners House Payment (Arrearages):

Brief Description: HAF will provide full or partial payment to homeowners unable to make full payments, owing to a continuing financial hardship resulting from the coronavirus pandemic. HAF funds may be used to reduce a homeowner's monthly loan payments for a period starting on 01-01-2020. HAF funds will only be used to supplement other loss-mitigation measures offered by the servicer or where HAF funds are necessary for the homeowner to qualify for other such loss-mitigation measures.

Maximum amount of assistance per homeowner: Each Homeowner will be eligible for up to \$2,000 through this program, apply only to the homeowner's primary residence. (The maximum amount of all combined program assistance granted by HHD through the HAF program elements will not exceed \$72,300 per homeowner.)

Homeowner eligibility criteria and documentation requirements: Same as General Eligibility Requirements, plus: HHD will make all funds for assistance available to households with annual household income that is at or below 150% of the Area Median Income, and 60% of these funds will be reserved and targeted for households that are at or below 100% of the Area Median Income. The following must apply:

- The HTM must be listed on the lease agreement/deed, and copies of these documents must be submitted.
- The HTM must provide a Tribal ID or verification of Hualapai Tribal enrollment.
- The HTM must provide copies of documents showing household income for all household members.
- The HTM must provide a statement of their present inability to resume homeownership payments, owing to unemployment, underemployment or other continuing hardship. Loan eligibility criteria specific to the program The HTM must provide a homeowner statement indicating delinquency and must be at least one month in arrearage.

## C. Falsification and Investigation

- 1. If it is discovered that an Applicant has falsified his or her Application, or otherwise abused the HAF Program, or if an Eligible Homeowner fails to notify HHD of changes to eligibility, the homeowner will be subject to penalties. Penalties will include ineligibility for continued participation in the HAF Program and repayment of the value of any benefit for which they were not eligible to receive. HHD shall have the right to seek such repayment through garnishment of the Recipient's per capita distribution or wages, if any.
- 2. HHO shall retain the right to conduct a follow-up investigation into any self-attestations submitted or regarding any other documentation, at its own discretion, if it determines that the reliability or accuracy of the information provided is in doubt.

## D. Application Review

- 1. The HHD staff member receiving the Application shall sign and date the Application when it is received at the HHD office.
- 2. Preferences and Priorities. Applications will be reviewed and processed as they are received. However, in anticipation of HHD receiving a substantial number of applications within a short period of time, with a finite amount of funding available, HHD shall review and process Applications for HAF Program Funds under this Policy according to the following order of preferences, and in accordance with the HAF Plan submitted to, and approved by, the Secretary.
  - A. Not less than 60% of amounts made available to HHD must be used for qualified expenses that assist Eligible Homeowners having incomes equal to or less than 100% of the area median income or equal to or less than 100% of the median income for the United States, whichever is greater, utilizing the following preferences:
  - 1. First preference will be given to socially disadvantaged Eligible Homeowners that have at least one family member (regardless of whether that member is an adult or head of household) who is a Tribal Member.
  - B. The remaining 40% of amounts made available to HHD will be prioritized to socially disadvantaged individuals utilizing the same preferences as set out in subsection (a), above.
- 3. Approval of Applications. HHD will notify Applicants in writing, within fourteen (14) days of HHD's receipt of the Application, of HHD's decision of whether the Applicant has been approved to receive HAF Program Funds.
- 4. Denial of Application. If upon initial review, HHD determines that the Applicant is not eligible or the request is outside of this Policy, or there are no longer any HAF Program

## SECTION V. APPLICATIONS FOR HAF PROGRAM

A. Participation Applications: To participate in the HAF Program, an Applicant must first submit a complete, written Application on the forms provided by HHD, which are attached as Exhibits to this Policy. All information required to be on the forms must be completed, or the Application will be returned. Applications for the HAF Program must be submitted to HHD by mailing or dropping off the Applications to the following address:

The Application must include the following information and supporting documentation:

- 1. Applicant and Household Information. Homeowners must submit applicant and household information as included in the Application Form. This form is attached as an Exhibit.
- 2. Financial Hardship. Homeowners must attest that they experienced financial hardship after January 21, 2020. The attestation must describe the nature of the financial hardship (for example, job loss, reduction in income, or increased costs due to healthcare or the need to care for a family member). This form is attached as an Exhibit.
- 3. Income. Homeowners must have incomes equal to or less than 150% of the area median income.
- 4. Release of Information. This form is attached as an Exhibit.
- B. Notification of Change of Eligibility. Applicants are required to notify HHD in writing immediately whenever any determining factor of eligibility changes. This includes, but is not limited to:
- 1. No longer experiencing a financial hardship; or
- Have an income that is equal to or less than 150% of the area median income.

#### SECTION IV. ELIGIBILITY

- A. Eligibility Requirements. In order to be eligible to apply for the HAF Program, at the time the Applicant applies to the HAF Program, the Applicant must meet the following eligibility requirements:
- 1. The Applicant is a homeowner who has experienced a financial hardship after January 21, 2020 and have an income equal to or less than 150% of the area median income.
- 2. The Applicant attests to the nature of the financial hardship experienced after January 21, 2020. The attestation must describe the nature of the financial hardship (for example, job loss, reduction in income, or increased costs due to healthcare or the need to care for a family member).
- 3. Hualapai Tribal members must be residing on or off the Hualapai Indian Reservation or off the reservation within the state of Arizona. A homeowners home must be primary home and occupied residence of Arizona.
- B. HAF Program Funds received by an Applicant must only be used for qualified expenses set forth in this Policy that are related to the Dwelling that is used as the homeowner's primary residence.
- C. Income Determination. In determining the Income of a household for purposes of determining such household's eligibility for assistance from the HAF Program Funds, HHD may use HUD's definition of "annual income" in 24 C.F.R. § 5.609 or use adjusted gross income as defined for purposes of reporting on Internal Revenue Service (IRS) Form 1040 series for individual federal annual income tax purposes.
- 1. Documentation of Income Determination: Applicant must provide sufficient information to HHD to enable HHD to have a reasonable basis under the circumstances for purposes of determining if the income eligibility requirements in (A) above are met. Two approaches for income verification are permissible: (1) the household may provide a written attestation as to household income together with supporting documentation such as paystubs, W-2s or other wage statements, IRS Form 1099s, tax filings, depository institution statements demonstrating regular income, or an attestation from an employer; or (2) the household may provide a written attestation as to household income and HHD may use a reasonable fact-specific proxy for household income, such as reliance on data regarding average incomes in the household's geographic area. In implementing the HAF Program, HHD will avoid establishing documentation requirements that are likely to be barriers to participation for eligible households, including those with irregular incomes such as from a small business.
- 2. Waiver or Exception to Documentation Requirement: HHD may provide a waiver or exception to documentation of income requirement as reasonably necessary to accommodate extenuating circumstances, such as disabilities, practical challenges related to the pandemic, or a lack of technological access by homeowners; in these cases, HHD is still responsible for making the required determination regarding household income and documenting that determination.

# **B. Qualified Expenses**

- 1. HAF Program Funds may only be used for the following types of qualified expenses that are for the purpose of Homeowners Rehabilitation/Addition to prevent overcrowding and Heating, Ventilation and Air Conditioning (HVAC) after January 21, 2020:
  - a. Payment assistance for:
  - 1. Homeowner's arrears
  - 2. Homeowner's Rehabilitation/Addition
  - 3. Heating, Ventilation and Air Conditioning (HVAC)
  - 4. Mortgage Payment Assistance.
    a)Homeowners insurance.
    b)Hoa Fees or Liens.
    c)Delinquent Property Taxes.
  - 5. Homeowner's Internet Payment Assistance
- b. Counseling or educational efforts by housing counseling agencies approved by HUD, or legal services, targeted to households eligible to be served with funding from the HAF Program related to foreclosure prevention or displacement, in an aggregate amount up to 5% of the funding from the HAF Program received by HHD;
- 2. Duplication of Assistance. An Eligible Homeowner that occupies a Dwelling for which that Homeowner is receiving or has already received other federal assistance may receive HAF Program assistance, provided that HAF Program Funds are not applied to costs that have been or will be reimbursed under any other federal assistance. To the extent feasible, HHD will ensure that any financial assistance provided to an Eligible Homeowner pursuant to the HAF Program Funds is not duplicative of any other Federally funded assistance provided to such Homeowner.
- a. If an Eligible Homeowner receives homeowner assistance other than through the HAF Program, the HAF Program Funds may only be used to pay for costs that are not paid for by the other homeowner assistance. When providing HAF Program Funds, HHD must review the Eligible Homeowner's income and sources of assistance to confirm that the HAF Program Funds do not duplicate any other assistance, including federal, state, and local assistance provided for the same costs.

- L. "Indian Tribe" means a tribe that is a federally recognized tribe or a "State recognized tribe" as those terms are defined in NAHASDA, 25 U.S.C. 4103(13).
- M. "NAHASDA" means the Native American Housing Assistance and Self-Determination Act passed by the U.S. Congress in 1996.
- N. "Secretary" means the Secretary of the U.S. Department of Treasury, except where otherwise indicated.
- O. "Socially Disadvantaged Individuals" means those who have been subject to racial or ethnic prejudice or cultural bias because of their identity as a member of a group without regard to their individual qualities. The social disadvantage must stem from circumstances beyond their control. There is a rebuttable presumption that the following individuals are socially disadvantaged: Black Americans, Hispanic Americans, Native Americans, and Asian Americans and Pacific Islanders. In addition, an individual may be determined to be a socially disadvantaged individual in accordance with the procedures set forth in 13 C.F.R. § 124.103(c) or (d).
- P. "Treasury" means the U.S. Department of Treasury.
- Q. "Tribal Member" means a member of the Hualapai Tribal member.
- R. "Tribe" means the Hualapai Tribe.

# SECTION III. HOMEOWNER ASSISTANCE OVERVIEW

A. HHD shall only use the HAF Program Funds to provide financial assistance to Eligible Homeowners to use for qualified expenses for the uses set forth herein and in accordance with the terms of this Policy.

- 1. Application. To participate in the HAF Program, a Homeowner must first submit a complete, written Application to HHD. This Application must include all information required by HHD, as described herein.
- 2. Participation. If an Applicant is approved for participation in the HAF Program, they must then submit information and supporting documentation each month for which they seek continued HAF Program Funds, unless such payments are to be provided for a 3-month period, for which the Applicant must provide such information for the 3-month period.

# SECTION II, DEFINITIONS

General: The following definitions shall apply to this HAF Program Policy.

- A. "100% of the area median income" for a household means two times the income limit for very low-income families, for the relevant household size, as published by the Department of Housing and Urban Development (HUD) in accordance with 42 U.S.C. 1437a(b)(2) for purposes of the HAF Program.
- B. "100% of the median income for the United States" means the median income of the United States, as published by HUD.
- C. "150% of the area median income" for a household means three times the income limit for very low-income families, for the relevant household size, as published by HUD in accordance with 42 U.S.C. 1437a(b)(2) for purposes of the HAF Program.
- D. "Applicant" means a homeowner who applies for financial assistance pursuant to this HAF Program Policy.
- E. "HHD" means the Hualapai Housing Department.
- F. "Conforming loan limit" means the applicable limitation governing the maximum original principal obligation of a mortgage secured by a single-family residence, a mortgage by a 2-family residence, a mortgage secured by a 3-family residence, or a mortgage secured by a 4-family residence, as determined and adjusted annually under section 302(b)(2) of the Federal Mortgage Association Charter Act (12 U.S.C. § 1717(b)(2) and section 305(a)(2) of the Federal Home Loan Mortgage Corporation Act (12 U.S.C. § 1454(a)(2)).
- G. "COVID-19" refers to the viral disease caused by the novel coronavirus known as SARSCoV-2.
- H. "Dwelling" means any building, structure, or portion thereof that is occupied as, or designed or intended for occupancy as, a residence by one or more individuals.
- I. "Eligibly entity" means (1) a state, (2), the Department of Hawalian Home Lands, (3) each Indian tribe (or, if applicable, the tribally designated housing entity of an Indian tribe) that was eligible for a grant under Title I of the Native American Housing Assistance and Self-Determination Act of 1996 (25 U.S.C. § 4111 et seq.) for fiscal year 2020, and (4) any Indian tribe that opted out of receiving a grant allocation under the Native American Housing Block Grants program formula in fiscal year 2020.
- J. "Eligible Homeowner" means a homeowner that meets the eligibility requirements provided for in this Policy.
- K. "Financial hardship" means a material reduction in income or material increase in living expenses associated with the coronavirus pandemic that has created or increased a risk of Homeowner delinquency or default, foreclosure, loss of utilities or home energy services or displacement for a homeowner.

# HUALAPAI HOUSING DEPARTMENT COVID-19 HOMEOWNER ASSISTANCE FUND POLICY

## **SECTION I. PURPOSE**

- A. This Homeowner Assistance Fund Policy ("Policy") shall govern the Hualapai Housing Department ("HHD") Homeowner Assistance Fund ("HAF Program") and the expenditure and management of the Homeowner Assistance Funds ("HAF Program Funds") received from the U.S. Treasury pursuant to Section 3206 of the American Rescue Plan Act of 2021, P.L. No. 117-2 (March 11, 2021).
- B. The first case of COVID-19 was detected in the United States on January 21, 2020. The Secretary of the U.S. Department of Health and Human Services declared the public health emergency for COVID-19 on January 31, 2020. An emergency declaration was issued on March 13, 2020, pursuant to section 501(b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5191(b).
- C. Notwithstanding any provision set forth in any other HHD Policy, receipt of assistance from the HAF Program established under this Policy shall not make the Recipient or Recipient family eligible or ineligible for assistance under any of the regular HHD policies.
- D. Nothing in this Policy shall be construed to invalidate any otherwise legitimate grounds for eviction.
- E. Assistance to be provided under the HAF Program is subject to availability of funds. No applicant or household determined to be eligible is entitled to or has a property right to receive funding under the HAF Program. When funding for the HAF Program is fully expended, the HAF Program will terminate. HHD may terminate this Program at any time.
- F. This Policy is based, and the HAF Program will be carried out, in reliance upon the April 14, 2021, guidance document from the Department of Treasury (entitled "Homeowner Assistance Fund Guidance"), along with any future modification, clarification, or supplementation which Treasury may provide. This Policy and the administration of the HAF Program will be subject to change if and when additional guidance is provided.

### What is WIC?

WIC is a nutrition program that helps families feed their children healthy foods. WIC provides nutrition information, healthy foods, and help accessing health care to moderate to low-income families. The program is available to families with pregnant women, new mothers, and children under the age of five.

### What Can WIC Offer My Family?

Benefits that can be used at the grocery store to buy healthy foods like milk, yogurt, whole grains, beans, juice, eggs, cheese, cereal, peanut butter and fruit and vegetables. Information about nutrition and health to help you and your family eat well and be healthy. Help with breastfeeding your baby, Help in finding health care and other community services, and Breast pumps to help you breastfeed even when you return to work

### Can My Family Enroll In WIC?

WIC is for all kinds of families – families with married or single parents and those who are working or not working. WIC has different requirements than SNAP (Food Stamps) so even if you don't qualify for SNAP, you may still qualify for WIC. If you are a father, mother, grandparent, foster parent or other legal guardian of a child under 5 years of age, you can apply for your child.

If you are a woman who is pregnant, breastfeeding, or has a baby up to six months old, you can apply

- 1. Identification for all clients
- 2. Proof of residency
- 3. Proof of income
- 4. Proof of pregnancy (if applicable)


