2024 Department of Energy Tribal Clean Energy Summit

With the gracious support of the Pechanga Payomkawichum People led by Chairman Mr. Mark Macarro, the Department of Energy hosted the Tribal Clean Energy Summit in Temecula, California. Some seven hundred attendees listened to inspirational speeches from Chairman Macarro, Secretary of Energy, Jennifer Granholm and Wahleah Johns, Director of DOE's Office of Indian Energy. The two-day session shared multiple success stories that tribes throughout the nation have had in the past few years designing, constructing, and operating various types of renewable energy projects funded by the DOE.

As part of the first day's presentations on the tribe's leading way in the clean energy transition, Chairwoman Ms. Sherry J. Parker was joined on stage by Ms. AlexAnna Salmon, Council President of the Igiugg Village in Alaska and Ms. Meryl Picard, Chairwoman of the Bishop Paiute Tribe. Each stressed the importance moving to a cleaner form of energy to save costs, reduce the use of fossil fuel and be self-sufficient.

Chairwoman Parker's presentation focused on the Hualapai Tribe's newly completed 885 kilowatt solar array and battery storage system which started producing power for the tribe's tourist destination at Grand Canyon West, Arizona, in mid-October of 2023. Since that time, the solar array has produced over one third of the energy needed to operate the micro-grid. As the days grow longer, the solar output will provide up to two thirds of GCW's power demand. The solar array is expected to save the tribe at least \$500,000 in diesel fuel expenses per year over the next few decades. In closing, Chairwoman Parker complimented the board and staff of the Hualapai Tribal Utility to bring the tribe's solar project to fruition and emphasized the challenge to tribes of being progressive in developing these new technologies and not destroying tribal lands and traditions.

2024 ELECTIONS

Let's get ready for 2024 Elections. If you have turned 18 years of age, you are eligible to register to vote in the state of Arizona, or if you need to make changes; we are here for you.

Your vote is your voice. For many years the voice of American Indians has been suppressed or silenced when it came to voting. The way we can ensure that our voice is heard loud and clear is to register to vote, and to exercise your right to vote in the upcoming 2024 primary and general elections and every election thereafter.

While voting is an essential right of all Americans over the age of 18, for American Indians the right to vote was only recently achieved through Congressional action, individual persistence, and years of litigation.

Historically, American Indians were not considered American citizens. They were not granted citizenship until 1924, after Congress enacted to grant, "All non-citizen Indians born within the territorial limits of the United States be, and they are hereby, declared to be citizens of the United States."

It took persistence from Native people to take a stand and fight for the right to vote. In 1948, Frank Harrison and Harry Austin from the Fort McDowell Yavapai Nation took a stand and fought for their voting rights all the way, to the Arizona State Supreme Court.

In a great victory the Supreme Court unanimously overruled previous opinions and recognized Indians right to vote. However, barriers were put in place after this victory which set back the voting privilege of American Indians. Barriers such as: literacy requirements, language requirements, access to the polls for those living on reservations and because American Indians were considered guardians of the federal government.

American Indians could fight in wars but could not register to have their voice heard in the voting process. It was not until the passage of the Voting Rights Act of 1965, which ensured everyone the right to vote.

Today, American Indians make up 1.4 percent of the population nationally, and make up approximately 5% of the population in Arizona. So if every eligible American Indian voter turned out the vote during any State or National election, the voice of American Indians would be heard loud and clear.

Historically your ancestors could not vote, but today you can. If you have a valid Arizona driver's license or state identification card, you can register to vote on-line at www.servicearizona.com. Or be sure to stop by your local post office, or county recorder's office to fill out a registration form. Contact myself (Addie) or Shanna at the Tribal Office and we will be glad to assist you.

Hualapai Master Plan Update Committee tenth meeting, part 2 on Wednesday, March 20th

The Hualapai Master Plan Update Committee is scheduled to complete its tenth meeting on Wednesday, March 20, 2024, beginning 5:00 PM at the Multi-Purpose Building, located at 470 Hualapai Drive in Peach Springs.

The 18-member Committee was formed by Hualapai Tribal Council on March 6, 2023, with the task of updating the tribe's existing draft Master Plan. The Master Plan is a statement of community values and aspirations, written as goals and policies, and shown on maps and diagrams. This will be the primary tool for managing community change to achieve the desired quality of life for tribal members living on the reservation, trust lands and private property owned by the tribe.

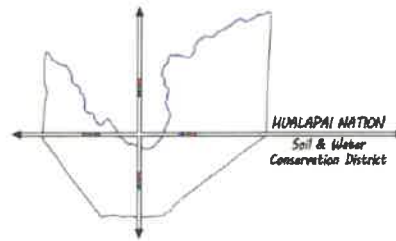

HUALAPAI MASTER PLAN MEETING #9

Meeting Notes

Meeting Date: February 6, 2024, 5:00 PM

Multi-Purpose Building, Peach Springs, AZ Peach Springs, AZ

1. DINNER at 5:00 PM
2. CALL TO ORDER: Chairman Robert Bravo called the meeting to order at 5:50 PM.
3. ROLL CALL:

Present:

Camille Nighthorse, Joyce Powskey, Longfeather Fox (Zoom), Marilyn Vaughn, Martina Dawley (Zoom), Nick Hunter, Raelene Havatone and Robert Bravo.

Also in attendance were Nona Baheshone, Facilitator (Zoom), Kevin Davidson of the Hualapai Planning & Economic Development Department and Hualapai Tribal members Randi Mahone, Aaron Gordon and Mac Gordon.

Absent:

Andrea Nieto (excused), Cheryle Beecher (excused), Clay Bravo (excused), Gensean Havatone-Putesoy, Heather Nieto (excused), Manny Siyuja, Loretta Jackson-Kelly (excused), and Shana Talieje (excused).

4. AGENDA AND MINUTES APPROVAL:

Chairman Robert Bravo requested a motion to approve the meeting agenda. Camille Nighthorse made a motion to approve the agenda and Nick Hunter seconded. The committee approved the agenda unanimously.

5. REVIEW OF THE MASTER PLAN LAND USE DIAGRAMS

Mr. Davidson began the presentation by noting this is the committee's ninth meeting where the committee will review the draft master plan land use diagrams, the results of the community survey, the outline and strategy for the upcoming community meeting and then tribal tourism plan survey that has just been released.

Highlights on Modifications to the Master Plan Land Use Diagrams

1. Central Peach Springs
 - a. Removed Commercial area east of Juvenile Detention
 - b. Removed Residential designation from High Rock to keep development away from this area.
2. Milkweed Springs to Music Mountain School
 - a. Reduced Commercial/Industrial area along southern border of reservation.
3. Southern Reservation
 - a. Removed Wind Farmland uses east of Peach Springs
 - b. Removed 598-acre utility-scale solar site at Plain Tank
4. Frazier Wells & Youth Camp
 - a. Removed residential subdivision along Frazier Wells Road
 - b. Reduced size of Commercial area along Route 18 at Frazier Wells Road
 - c. Recognized potential Commercial use at Youth Camp
5. Truxton Triangle
 - a. Expanded Commercial area along Route 66
6. Grand Canyon West
 - a. Removed Golf Course(s)
 - b. Removed mid-priced hotel
 - c. Reconsidered 2020 RV Park & Glamping proposal north of Hualapai Point.

Mr. Davidson said he will update the 2012 Master Plan land use diagram with those areas shown on the 2015 GCW Master Plan, minus the golf course and mid-priced hotel prior to the community meeting.

Ms. Havatone asked if the committee has reached out to Grazing District No. 2 on some 2,000 acres of residential land use west of the Music Mountain Subdivision bordered by Buck and Doe Road to the north and State Route 66 to the south. Mr. Davidson replied he will be presenting the draft land use diagrams to Hualapai Water and Soil Conservation District at their meeting on February 8, 2024, to receive input from the grazing districts. The western boundary line of the proposed residential expansion mimics a proposal by a member of District No. 2 made about seven years ago; however, this proposal did not come to fruition. Vice-Chairwoman Vaughn said the tribe needs more land to expand the supply of housing for tribal members instead of forcing them into small lots, such as those being built in the Box Canyon Subdivision. Ms. Nighthorse agreed with this statement and said tribal council has the ultimate say on how the tribe's land is developed. Mr. Davidson said the Master Plan is the policy document that guides council's land use decisions.

Review of Land Use Categories in the Master Plan

Residential Land Uses

Rural Density: 1 dwelling per one acre +

Low Density: 1-2 dwelling units per acre

Medium Density: 3-8 dwelling units per acre

Intermediate Density: 9 to 16 dwelling units per acre

The majority of housing on the Hualapai Reservation comprises single-family homes in residential densities primarily within the Rural, Low and Medium Density categories. The specific types of dwellings are determined by the uses permitted in each zoning district. However, the number of dwelling units per acre gives an indication of the type of residential development that may occur. Rural, Low and Medium Density Residential Areas are generally going to be characterized by single-family homes that are either site-built or manufactured. Intermediate Residential Areas are generally going to be characterized by duplexes, triplexes and larger apartment complexes, depending on the size of the individual property and the needs of the area that is served.

At present the land use diagrams depict all residential uses generically without sub-designations.

Commercial Land Uses

Commercial land uses serving the tribal community are found dispersed throughout Peach Springs and other residential communities on the reservation. Commercial land uses can usually be found along major roadways in order to manage projected increases in traffic flows.

Development criteria for the *Community Commercial* land uses demand that property development standards ensure compatibility with adjacent non-commercial land uses.

Regional tourist attractions include existing and future commercial development that is designated at specific central locations at Grand Canyon West, Peach Springs, and Frazier Wells. *Regional Commercial* uses shall be designated in areas that are in or near adequate infrastructure and are accessible to a large population base that would be necessary to support such commercial centers usually located along major arterials. Commercial services along Historic Route 66 and BIA Route 18 provide for traveler-oriented establishments such as truck stops, hotels, motels, RV Parks and full-service automotive gas stations.

Given the remote location of Peach Springs and about 2,000 vehicle trips per day along State Route 66, Mr. Davidson said the *Community Commercial* designation is realistic for this part of the reservation. Also, the regional commercial land use at Frazier Wells has been reduced in size to just include the abandoned school property.

Industrial Land Uses

Light Industrial - These areas will accommodate industrial business activities that are not offensive to nearby commercial and residential uses. Development of such designated lands would be limited to uses such as light manufacturing, assembly, research and development, wholesale distribution (warehousing), construction, other types of low-intensity industrial activities.

Manufacturing Industrial - These areas are characterized by industrial businesses and uses having more intensive types of industrial processes such as mechanical and/or chemical processing, extractive uses, materials transfer, multiple-shift operations, and large structures. However, development in regard to major source polluters which emit 100 tons or more of criteria pollutants such as sulfur dioxide should be discouraged.

At present, the Industrial land uses are designated east of Peach Springs along the north side of the railroad beginning in the vicinity of the shooting range and extending to Nelson and the lime plant. Mr. Davidson said they have yet been given a sub-designation of "Light" or "Heavy" Industrial.

Renewable Energy Land Uses

Wind Farm - These are areas that have been identified by the Tribal Council in association with various Tribal Departments as appropriate locations for the generation of electricity using wind power. The locations were selected based on topography, wind power generation potential, and proximity to Mohave Electric's existing 69kV radial line that feeds Peach Springs and residential uses.

Solar Field - These are areas that have been identified by the Tribal Council in association with various Tribal Departments as appropriate locations for solar power generation. The locations were selected based on topography, sunlight exposure time, and proximity to customers for both residential and commercial uses.

Given the tribe's recent negative experience with renewable energy projects in the region (White Hills), Mr. Davidson noted that the Committee is recommending the tribe remove these land use designations from the proposed land use diagrams.

Other Land Uses

Recreational Land Uses - include developed recreational areas such as public parks, as well as lands that are held for, or identified for, recreational use. These include recreational properties that will have public access (non-Tribal Members) on a fee-paid basis, due to the underlying nature of the land use.

Agricultural Land Uses - include land developed for forestry, ranching or farming purposes as well as lands that are held for, or identified for, ranching or farming purposes.

Historical Land Uses - includes land set aside for the preservation of land and buildings historically used by the Tribe for religious and/or cultural purposes. This includes but is not limited to the historical school facilities located in Valentine.

Undeveloped Open Space Land Uses - include lands that are held for, or identified for, preservation. This includes areas that are preserved due to cultural sensitivity or preservation of the natural environment. Open Spaces also include areas that are not likely to be developed due to topography, which may include hilltops, washes, and canyons, etc. Areas that are not accessible by vehicles or that cannot support infrastructure development are also included in this category.

In regard to Historical land uses in Valentine, Ms. Havatone asked which tribal department is taking care of the old Valentine School House. Mr. Davidson replied this should fall to Public Service's Facilities Division. Ms. Dawley clarified that no one department is responsible for the building's upkeep and is only worked on occasionally, for example when the tribe receives a grant. Mr. Davidson said this was the case some fifteen years ago when the Planning Department received a grant to replace the roofing.

Combination Land Uses

Agricultural/Residential - These areas will include large acreage residential lots zoned for small scale ranching and/or farming.

Agricultural Business - This will include the land in the vicinity of the Wildlife Fishery Facility and any other lands suited for similar agricultural business opportunities.

Tribal Government/Commercial - These areas will include existing and proposed Tribal Cultural and Government buildings where community commercial land uses would serve the needs of employees working in these buildings.

Commercial/Industrial - These areas will include portions of the Reservation isolated from residential and community developments through which major roadways run. In such locations a combination of traveler-oriented establishments such as truck stops, and full-service automotive gas stations along with light industrial land uses.

Agricultural/Renewable Energy - These areas allow traditional agricultural pursuits such as ranching to coexist with renewable energy projects. For example, the land used for a wind turbine tower is typically less than one acre after construction and comprises a small percent of the wind farm's total area. This small footprint on the land will allow animals to freely graze.

Mixed Use - Reserved for urbanizing areas where land uses have followed an organic pattern of urban development. Disparate land uses may be placed adjacent to one another provided they meet certain design and performance criteria so as not to be nuisance to one another.

With the review of the land use categories complete, Mr. Davidson noted that not all of the land uses that are listed in the Master Plan appear on the land use diagrams, namely the renewable energy designations. These definitions should be retained, however, for future amendments to the Master Plan.

6. Highlights from the Community Survey

Mr. Davidson introduced the results of the community survey which included 15 questions on land use, economic development, housing and infrastructure. The survey was published in Gamyu, on-line and placed at various points around town. Planning staff actively solicited surveys at the La Paz Run meeting on 1/17 (received 3), the Elder Center 1/23 (received 8) and did an interview with KWLP FM 100.9 on 1/19 which aired on 1/22. Planning received 14 surveys over the 14-day period. Ten of the responses came from tribal members and 10 responses were from people living locally (86434 ZIP code). Given the small number of responses, the results should be considered anecdotal in nature vs. being statistically robust.¹

Question No. 1 - Where would you like to see more housing development? Nearly one half of the respondents said housing should be placed in the triangular area bordered by Buck & Doe Road, Route 66 and Mud Tank Road. On third favored placing housing south of Route 66, west of Peach Springs

Question No. 2 - For the historic gas station in downtown Peach Springs, we should _____? One half of those surveyed requested a cultural activity center with space for tribal artisans to practice their craft; however, nearly one third would like to see the old building re-opened as a gas station.

Question No. 3 - In the downtown area, what other uses could be developed that could add to tribal revenues and support tribal self-sufficiency? Answers included: mini food cafes, coffee shop (Dutch Bros.), restaurant, shopping center, place for Hualapai vendors and dancers, marijuana dispensary, casino, RV park, bowling alley, movie theatre and capped off with an entrance archway over Route 66 saying "Welcome to Peach Springs, Arizona, Land of the Hualapai."

Question No. 4 - Is Grand Canyon West developing in the way that you envisioned it? Sixty-two percent said "Yes" to this question; however, people want to see new buildings since the old ones appear run down and suffering from a general lack of repair. One comment sought to replace the circulator buses with a set of open-air trolley/street cars (as you would see in a city).

Other comments for economic development included establishing a committee for advertising Hualapai's outdoor events, e.g. white-water rafting, Skywalk, Zip line, a new festival, a summer special get-away plus more advertisements on social media. The tribe should also consider operating a dispensary as well as a gas station and a shopping center in Kingman. For Cholla Ranch, the tribe should grow hemp and manufacture Hempcrete to build sustainable housing for the Tribe. This is a new and evolving industry and Hualapai should be part of it given its low investment costs with good revenue.²

Question No. 5 - What should be the minimum lot size for a single-family home? One half of those surveyed prefer 1-acre-plus size residential lots, with over one-third seeking at least a one-half acre lot. No one wanted to be on a one-quarter acre residential lot, which is the dominate lot size for HUD homes built in Peach Springs since the 1960s and also recently built in Box Canyon.

Question No. 6 - Is there a need for housing for single person households, elderly, or those without a large family to accommodate? Twelve of fourteen of those surveyed said "yes" to this question.

Question No. 7 - Where in Peach Springs should a senior housing project be located? Nearly two-thirds said new senior housing should be located in the Uptown area near the IHS Clinic, about one-fourth preferring the senior housing project be built along Diamond Creek Road which traverses the Uptown area.

Question No. 8 - Should the tribe look into building and operating a Nursing Home or Skilled Nursing Facility on the reservation to help elders recover from injury? Twelve of those surveyed said the tribe should consider building such a facility.

Additional comments on housing requested more homes for families, renovate existing homes, address elder abuse, provide better home maintenance with more home care classes, plus an apartment building with BBQ grills and garden seating areas.

Question No. 9 - What types of developments should the tribe pursue? The top ranked response to this question was large-scale solar arrays and/or wind turbine farms (typically over 100 acres) to sell power to buyers outside of the reservation. This is contrary to the draft Master Plan's land use diagrams which have removed locations for large-scale solar and wind farms. Ms. Powskey advised the Planning Department to educate the community on the issues of operating a large-scale solar or wind farm, namely, how to deal with decommissioning the facility once they reach the end of their useful life. The second highest ranking type of development was placing brand name commercial businesses along Route 66 and in the downtown area. Number three was uses that could increase the tribe's economic prosperity but negatively impact the appeal or environment of Grand Canyon West, Diamond Creek & Peach Springs Canyon, Youth Camp or other important locations on the reservation. This response seems to run counter to the Hualapai environmental ethos.

Additional comments on land use included encouraging economic development for Native American owned businesses, a Hualapai arts & craft website to help the artists directly, establish housing for Hualapai tribal members who live off the reservation and the "Great Race" through Grand Canyon West³ plus white-water rafting.

Question No. 10 - What type of land development should the tribe pursue on its 203-acre parcel in the City of Truckee, California? Most people would like to see the tribe pursue commercial uses such as an RV park, truck stop, etc. A recreation use such as a hunting lodge, equestrian center or a golf course ranked second.

For background, the tribe owns 203 Acres within the Town Truckee, California, that contains the historic airport site, a flat piece of land between Interstate-80 and the Truckee River. The town's General Plan assigns the property a Resource Conservation/Open Space land use designation which allows for outdoor recreational activities and open space uses. The tribe has not been successful in its attempt to rezone the land to a commercial use.

The Committee strongly advised the Planning Department to present the history of Truckee property and tribe's efforts to change the zoning designation at the next community meeting.

Question No. 11 - Are you satisfied with the community parks we have? Approximately two-thirds replied "No." The parks are not safe or clean and lack landscaping. Commenters requested more police or tribal staff presence, accommodations for multiple age groups and those with special needs.

Ms. Havatone said the parks are strewn with broken glass and graffiti. Ms. Powskey noted the need for better park maintenance in general. Those parks not built with Housing's HUD funds, are not the responsibility of Housing to maintain. For example, the new park next to the Elder Group Home was built with tribal funds so its maintenance should be the responsibility of either the Public Services Department or the Recreation Department.

Question No. 12 - Please prioritize the types of recreation activities for tribal members that you would like to have on the reservation. A splash pad was the number one request, followed closely by swings and play areas, basketball courts and volleyball courts. Skate parks, baseball/softball fields, soccer/football fields, climbing walls and BMX track ranked in the middle. Tot lots (mini parks), Frisbee golf and tennis/pickle ball courts brought up the rear with Colorado River recreation activities for tribal members-only ranking last. Walking, hiking and bicycle trails were popular among "Other Recreation Activities." One comment requested Recreation staff teach children how to play the various games.

Question No. 13 - Please prioritize these public improvements proposed by the tribe. Re-paving local roads in Peach Springs (2.7 miles) ranked the highest with constructing a BNSF Railroad overpass bridge with pedestrian crossing between Route 66 and Adult Detention Center and a bike/exercise path along Diamond Creek Road (1 mile) between downtown and the Health Department tying for second. Other projects in order of ranking included: Buck-N-Doe Road realignment and paving (40-plus miles), paving Nelson Road (0.75 miles) to Old Rodeo Grounds & Shooting Range, Diamond Bar Road guardrail (Installation of new guardrails and repair of existing guardrails), paving Youth Camp Road (3.8 miles of forest roadway), and paving roads in the Box Canyon Subdivision (0.7 miles). In addition, the foot bridge to the old laundry (Doll Factory) should be fixed and sidewalks built throughout Peach Springs.

Question No. 14 - Use of treated Wastewater? Nearly 47 percent said irrigation of crops and landscaping would be an appropriate use of treated wastewater. One fifth preferred the water be used to recharge the aquifer. Another 20 percent saw an "Other" use. About one-eighth did not want to use treated wastewater in any capacity.

Question No. 15 - Would you like to see more internet access on the reservation at these locations? All respondents requested more internet access in Peach Springs, Buck & Doe, Milkweed Springs & Box Canyon and Valentine. Most people would like more internet

access at Grand Canyon West. There was a mixed response for providing more internet access at Frazier Wells, Youth Camp and Range Cabin.

Mr. Hunter advised the Committee to focus on the top requests gleaned from the survey such as building an RV park at Grand Canyon West and establishing a nursing home/skilled nursing facility in Peach Springs. Mr. Davidson noted that even though the survey results are anecdotal, the Committee can use them as Mr. Hunter advised to shape the Master Plan's goals and policies.

7. Draft Outline for Community Meeting

Mr. Davidson reviewed the draft outline for the second community meeting as follows:

1. Miss Hualapai to do introduction and talk about why the Master Plan is important to the community.
2. Short presentation on what the Master Plan is about, the Plan's progress and how decisions were made.
3. Review survey findings and get feedback (at tables - 45 minutes) Nona will summarize for audience.
4. Review land use diagrams
 - a. Focus on big changes to the land use map (15 minutes)
 - b. Review goal and policy changes that affect Land Use (15 minutes).
5. Land use mapping exercise (45 minutes)
 - a. Grazing – Did we adequately address grazing on these diagrams?
 - b. Housing – Are these areas adequate/appropriate for housing? Do you have any thoughts on the specific types of housing that could occur where?
 - c. Economic Development – Are you comfortable with the changes to industrial, commercial and renewable energy lands?
6. "We heard you" – Present goals & objectives that were significantly changed based on community input (30 minutes)
 - a. Reference Committee meeting minutes
 - b. Reference Goals, Objectives and Policies from Master Plan on presentation boards.
7. What is the next step? – Review timeline through to Tribal Council hearing in May – June

Because no one holds the title of Miss Hualapai at this time, Ms. Nighthorse said she would approach a former Miss Hualapai to ask if she could make the introductory presentation.

The committee next discussed how to boost attendance at the upcoming community meeting. Mr. Hunter said the Music Mountain High School Gym is too distant a venue so the meeting should occur in town, ideally at the tribal gym. Ms. Havatone advised we start the meeting no earlier than 5:30 PM to allow people some time to get from work to the meeting. Can the meeting be held in the afternoon? To do so, the Committee should, via the Planning Department, request administrative leave be given to community members employed by the tribe to attend. This offer of administrative leave should also be extended to GCRC employees. Mr. Davidson will look into changing the venue and requesting administrative leave for a potential afternoon meeting. For the raffle, the Committee suggested the "Grandest Package" (Skywalk, helicopter flight to and from Colorado River, pontoon ride and a meal) be the grand prize, a Pendleton blanket be the second prize, then four gift cards of nominal value for a total of some \$600. Mr. Davidson will seek to procure these items before the February 21st meeting.

To evaluate the community input that will be given at the second community meeting, the Committee agreed to meet again the day after the public meeting, on February 22nd.

8. ADJOURNMENT

Chairman Bravo entertained a motion to adjourn the meeting. Ms. Nighthorse made a motion adjourn to with a second by Mr. Hunter, motion carried unanimously at 7:22 PM.

• Delinquent Internet Payment Assistant	\$ 300

Eligibility:

1. Homeowner must attest to financial hardship

3. Hualapai Tribal Member residing within the State of Arizona

If you have had experienced financial hardship after January 21, 2020 due to the COVID Pandemic (*for example: job loss, reduction in income, increased costs due to healthcare or the need to care for a family member*) you may be eligible to receive assistance to help pay mortgage, house payments or other home expenses.
