### **Tribal Member Names and Addresses**

Our office is charged with maintaining current and accurate names and addresses of all tribal members; Hualapai Constitution, Article II. Our office has experienced delays in receiving name changes that may be the result of marriage, adoption or voluntarily changing of one’s name.

The process in changing your name with the Enrollment Office is as follows:

1. Provide a marriage license, adoption decree or court order of name change;
2. Provide an updated Social Security Card with changed name;
3. Issuance of new tribal ID and CIB;
4. Any other questions, please contact our office.

Addresses are important for tribal members to frequently update with our office. Enrollment Office supplies that information for tribal events like Election seasons and distributions. This will greatly establish a database of up-to-date tribal member data.

### **Tribal Member Death**

In the event of a death of a tribal member, please notify our office so we may inactivate their profile and once a death certificate is received, provide a copy to our office so we may officially close their tribal member file.

The Planning Department is looking for two new applicants for the Tribal Environmental Review Commission (TERC) Board of Commissioners. Below is a summary of what TERC is and what their function is.

Under the Hualapai Environmental Review Code (HERC) the Board of Commissioners has the primary authority, under the direction of the Hualapai Tribal Council, for regulating land use and development of Hualapai Tribal Lands. The Board of Commissioners is composed of seven (7) members who are appointed by the Tribal Council.

Their function is to review and regulate, including issuing permits for, all development activities that are proposed for any site within Hualapai Tribal lands, in order to ensure that:

- (1) no development activity will be carried out without a permit; and
- (2) all development activities will be carried out in accordance with all applicable tribal and federal environmental protection laws and regulations.

If any person is interested, you can pick up an application at the Hualapai Planning Department, fill it out and turn it in to the Department at 887 Hwy 66 (next to 76 fuel station). **The due date for applications is Monday, April 29, 2024.** If you have any questions please feel free to contact me at 769-1310.

### HUALAPAI MASTER PLAN MEETING #10 – Part 2

## Meeting Notes

Meeting Date: March 20, 2024, 5:00 PM

Multi-Purpose Building, Peach Springs, AZ Peach Springs, AZ

1. **DINNER** at 5:00 PM
2. **CALL TO ORDER:** Chairman Robert Bravo called the meeting to order at 5:44 PM.
3. **ROLL CALL:**

Present:

Andrea Nieto, Camille Nighthorse, Cheryl Beecher, Clay Bravo (Zoom), Joyce Powskey, Raelene Havatone (Zoom), Manny Siyuja, Marilyn Vaughn, Martina Dawley, Nick Hunter, Shana Talieje and Robert Bravo.

Also in attendance were Kevin Davidson, Director of the Hualapai Planning & Economic Development Department and Nona Baheshone, Bahozhoni Development (Zoom).

Absent:

Gensean Havatone-Putesoy, Longfeather Fox, and Loretta Jackson-Kelly (excused).

#### 4. AGENDA AND MINUTES APPROVAL:

Chairman Robert Bravo requested a motion to approve the meeting agenda. Andrea Nieto made a motion to approve the agenda and Nick Hunter seconded. Committee approved the agenda unanimously.

Chairman Bravo requested a motion to approve the March 5, 2024, meeting minutes. Ms. Andrea Nieto made a motion to approve the agenda and Mr. Hunter seconded. Committee approved the agenda unanimously.

#### 5. Recap of the Cattlemen's Meeting on February 15, 2024

Mr. Davidson began the presentation by noting this is the committee's tenth meeting – part 2 - where the committee will integrate the February input into the Master Plan. To recap, Mr. Davidson reviewed comments received during his presentation made at the Cattlemen's meeting held on February 15, 2024, as follows:

- Earth tanks should be shown on the land use maps since they attract cattle.
- Tribal members looking to place a home site near an earth tank should expect cattle on their home site lease, so they should build a fence.
- Housing Department should build a fence around the Box Canyon subdivision (north and west sides).
- The land use diagram should also depict the various grave sites so home site leases do not end up being near one or, even worse, on top of one.
- The Forestry, Ranching and Mining Element of the Master Plan should reference the various ordinances the tribe has in place, namely the Proper Utilization of Range Resources - Ordinance 2B and the Natural Resources Conservation Ordinance No. 24-70.
- The Natural Resources Element should address soil erosion, bark beetle infestation and other maladies brought on by drought and a warming earth.
- The Truxton aquifer, the primary water source for the Peach Springs and Buck & Doe communities, should not be used to supply water to Grand Canyon West.

#### 6. Recap Hualapai Nation Soil & Water Conservation District on February 8, 2024

Mr. Davidson next shared the comments received from his February 8, 2024, meeting with the Hualapai Nation Soil & Water Conservation District as follows:

- Keep new home sites applications to the west side of Peach Springs where infrastructure is better and limit the number of home sites on the east side of the reservation given the lack of infrastructure, namely potable water, and slow "911" response times which exceed 30 minutes or more.

- EMS/Fire Department response time to Valentine is also slow.
- Will the Master Plan allow for secondary residences (Granny Flat) on a home site?
- Are home sites allowed in the "Agricultural" land use designation?
- Need streetlights in Valentine.
- Can we designate a residential land use category adjacent to the old one-room schoolhouse on the north end of Valentine at the railroad underpass?
- Rather than expand the residential land uses further west into Grazing District No. 2, the Master Plan Update Committee should consider placing a new residential area along the 1926 alignment of US Route 66 which is now the path of the main water supply line from the Truxton pump house. The residential area would start at the Music Mountain School at approximately Mile Post 97.2 and extend to about Mile Post 99 along the southerly side of State Route 66. This requires a meeting with the Grazing Districts to discuss further.
- Youth Camp and Thorton Tower need internet service for safety reasons.
- The proposed Agribusiness land use in the Frazier Wells area, south and east of Route 18, would not have been contemplated in the past given the Hualapai's traditional uses of the land.

**7. Planning's assignment from the March 5, 2024, Committee Meeting was as follows:**

- a. Expand commercial area along Diamond Creek Road to include old laundromat and possible arcade.
- b. Locate boutiques, nail salon, dress shop & a florist in the commercial office space next to the Hualapai Market.
- c. Place commercial uses such as a swap meet, vendor village and a mini-drive-in around old gas station and up to the Cultural Office.
- d. Expand Tribal Government/Commercial land uses to accommodate a new Tribal Office, new Indian Health Services Clinic, a Cry House, a Detox Facility and an Elder Care Facility in Uptown Peach Springs.
- e. Designate more land for housing along old US Route 66 and less land for housing in District No. 2
- f. Remove golf course and mid-priced hotel from GCW.
- g. Expand uses at Eagle Point vs. developing open spaces at GCW.
- h. Attempt to resolve conflict on development for east side of reservation.
  - a. Natural vs. developed . . . Glamping? Agribusiness at Frazier Wells?
  - b. EMS response times and general lack of infrastructure may limit development and new home sites to land near or adjoining Route 18

**8. Proposed Detoxification and Re-Entry Facility Presentation by Hualapai Health Education and Welfare Department**

To key off of the need for a Detoxification and Re-Entry Facility, Mr. Davidson invited David Dawley, Director of Hualapai Health Education and Welfare Department (HEW), made a presentation on this proposal. Mr. Dawley said tribal council, at a recent strategic planning retreat, requested the Hualapai Healing House be-reopened (closed during the COVID-19 Pandemic) and that a Re-Entry Facility be established on the reservation. For the Re-Entry Facility, Mr. Dawley reviewed the need, facility size, pre-planning steps and potential locations as follows:

- a. **Need:** sober living crisis; take care of the tribal people; hard to provide counseling upon return if they go alone; transition directly to Healing House.

Mr. Dawley noted Arizona has a sober living home crisis with some 400 shut down throughout the state in recent years due to substandard and sometimes fraudulent practices namely miss-spending AHCCCS funds. In addition, those tribal members who attempt to ply their way through the rehabilitation system tend to return to rehabilitation centers vs. returning to the mainstream. Ms. Shana Talieje asked about the mission of the Healing House. Mr. Dawley explained the original intent as the Alternative to Corrections/Transitional Living Facility was to provide a space for low-level offenders and offer them life skills vs. sentencing them to the Adult Detention Center.<sup>1</sup> The Healing House continues this effort through grant funding. Manny Siyuja asked how long the Healing House's waiting list is. Mr. Dawley replied the list is being prepared and added that the City of Kingman is also requesting use of the facility. Vice-Chair Marilyn Vaughn asked about the future of the facility. Mr. Dawley said the tribe has secured just over \$1 million in grant funding. Most of this will be paid for staffing. With that Mr. Dawley said it is important that the money be used to "train the trainers" to keep the facility operating.

<sup>1</sup> The old Indian Health Services Clinic was remodeled in 2013-2014 with a grant from the Department of Justice (CTAS – Purpose Area 4). DOJ also provided funding for staffing in the first few years of operation.

b. **Facility:** 20 - 40 beds; modular or frame building (s); number of staff; building size & site acreage.

Vice Chair Vaughn asked if some of this funding could be used to help tribal members start their own in-home sober living facility on the reservation. Mr. Dawley said HEW attempted to purchase a home across from the tribal office but had their request denied by tribal council. Vice Chair Vaughn commented that building a new facility, as proposed, will be more expensive than distributing the care at various homes throughout the community. Mr. Dawley said a new facility will have doctors and nurses on duty which would be difficult for home-based facilities to employ.

c. **Preliminary Planning:** feasibility study; environmental assessment; architecture/design; building permits, etc.; bidding & contractor selection.

Andrea Nieto added that Indian Health Services is looking to move out of the current clinic and into a new and larger clinic that is in the pre-planning stage (see minutes from 3/5/2024 meeting). Mr. Dawley said the existing clinic, being in-town is not remote enough.

d. **Location Options:**

1. Youth Camp area which is remote but has no telephone service and difficult winter access.
2. Cholla Ranch which is remote but has no telephone service and little to no 911 response.
3. GCW property (old Ranch) which is remote enough so people don't leave, has bus route for staff access and clientele can reintegrate into the working world via GCRC.
4. Other Locations could be along Indian Route 18 and along State Route next to Music Mountain High School?

Mr. Dawley said the GCW site may be the best location. Ms. Talieje said this location may not be remote enough for those who are motivated to take flight. Also, does the tribe want to introduce this element at its primary tourist destination? Ms. Nieto replied that Sedona, a major tourist destination, has re-entry facilities. Ms. Talieje commented that Sedona has many more resources to draw upon than does GCW, namely medical expertise and 911 responders. Also, GCW has enough negative reviews on social media due to suicides so adding this type of use may add to that count.

Mr. Davidson said the Youth Camp location should be seeing better infrastructure in the near future. The four-mile roadway from Route 18 is on Hualapai Public Works list for paving and the Havasupai Tribe plans to run a fiber optic line on the Mohave Electric Cooperative power poles that parallel Route 18. Vice Chair Vaughn said the re-entry facility should be relatively close to resources vs. being too remote. Patients at the facility should be able to assimilate back into the tribal community.

Ms. Nieto asked about the benefit of adding the re-entry facility to the Master Plan. Mr. Dawley said having the facility listed as a goal will give more weight to tribe's grant applications to construct and then operate it. Mr. Davidson said it can be added as an objective to the Public Buildings and Facilities Element akin to the cry house and the multi-use recreation/sports complex. Vice Chair Vaughn advised an artist rendering to be presented to the community as part of a grant application.

Mr. Siyuja said some people who enter rehabilitation do not want to be around people they know. Mr. Dawley cited studies saying that many people in rehabilitation prefer to be around their family and friends. Ms. Talieje asked if people will still be using the Healing House. Mr. Dawley responded "yes" since it will be offering job counseling and life skills training. Ms. Cherlye Beecher said the tribe needs this type of facility. We can start small and expand as the need increases. Placing the facility in the Frazier Wells area, possibly at the old school, or near the Youth Camp seems logical. Ms. Camille Nighthorse said the old school's floor is in poor condition and advised the building to be razed. Ms. Nighthorse said she is looking at establishing a retreat on Route 18 which will cater to those people looking to escape their hectic urban lives for a week or so. Mr. Dawley said the location should be close enough for staff to access and 911 responders to be on-site in a reasonable amount of time.

With discussion coming to a conclusion, Chairman Bravo made a motion to add the Re-Entry and Detox Facility to the Master Plan. Motioned seconded by Ms. Nighthorse, motion carried unanimously.

## 9. Master Plan Land Use Diagrams

Turning to the land use diagrams, Mr. Davidson began with central Peach Springs where there was consensus from the public meeting to start up a laundromat at the location of the old doll factory on Diamond Creek Road and build a Sports

Center/Multi-Purpose Complex in Rodeo Circle east of the tribal courthouse. Other requests placed a boutique, dress shop, salon, arcade and a florist shop in downtown between the lodge and the Walapai Market.

Three locations for a Cry House were also shown: 1) west of the McGee Cemetery, 2) southerly side of Route 66 across from Juvenile Detention, and 3) at the Pow Wow grounds south of the Day Care. The revised land use diagram now shows a 20-acre Government/Commercial land use designation east of Route 66 for a new Tribal Office, IHS Clinic and a Cry House. Also, the area around the Earthship has now been designated as a Government/Commercial land use designation to accommodate a potential restaurant. The commercial area has been extended up Diamond Creek Road to include the old doll factory for use as a laundromat. The existing commercial area around the old gas station can hold a swap meet, vendor village and a mini-drive-in. The existing 15-acre Government/Commercial land use designation within Rodeo Circle can accommodate the Multi-Use Recreation/Sports Complex.

Vice Chair Vaughn related her visit to another tribe where their funeral infrastructure was significantly more advanced than on the Hualapai Reservation. Ms. Martina Dawley said some of the larger Hualapai families need their own cry houses, ideally at the families' cemeteries. Ms. Nieto said the cry houses should be distributed in such a way as to serve the nearly one dozen cemeteries on the reservation and in Valentine. For the cry house functions, Ms. Talieje noted the dinner to honor of the deceased and the funeral service are two separate events with the service coming first and not in the same facility. Ms. Nieto asked if there are funding sources for the tribe to apply to. Ms. Dawley added that the new building(s) must be maintained by the tribe. Mr. Nick Hunter advised no structures to be built at the cemetery because they will prevent the spirit from ascending. Ms. Joice Powskey agreed. Ms. Dawley said outside funeral homes tend to take advantage of tribal members and added that the tribe could support a full-time program to perform funeral home services for the grieving families. Ideally, the cry house is close to the cemetery for logistical reasons. For example, building one in Valentine and another in Peach Springs would make sense. Mr. Davidson displayed a map showing the 20-acres surrounding the Valentine Cemetery that was recently brought into trust. The traditional cemetery area is out of room, being surrounded by a hillside, causing some tribal members to be buried elsewhere on the reservation. Mr. Davidson said the north part of the 20-acre site has yet to be used for grave sites.

Looking at the Buck and Doe area, Mr. Davidson said land use requests ranged from constructing a resort north of Buck and Doe Road near Mile Post 2, building luxury homes to rent, placing luxury apartments near the Buck and Doe Road intersection with Route 66 around the water tank, a ropes course and ball fields for recreation and fitness, brand name shopping along the highway adjoining Music Mountain High School, and, most significantly, shifting a few hundred acres of land designated for housing from District No. 2 north of highway to the south side of the highway, along the old alignment of US Route 66, which places the homes in the Shipping Pasture. For the Truxton Triangle, an RV Park, apartments, homes for single people, a vending area and a mini casino along the highway were also proposed. The revised land use diagram places a 20-acre Government/Commercial land use designation both to the east and to the west of the Music Mountain High School, along State Route 66 for a new IHS Clinic and staff housing. A new 191-acre Low Density Residential land use designation has been designated along the southern boundary of the old alignment of US Route 66 which also contains the main water line that supplies Peach Springs from the Truxton well field. The Truxton Triangle Master Plan provides land uses for an RV park, multiple-family dwelling units and enough commercial acreage for a vending. Ms. Dawley said the space designated for the sewer lagoons for a wastewater treatment plant given the proximity of the site to a major wash that recharges the Truxton aquifer, the main source of water for Peach Springs. Ms. Talieje, relating the problems with the new homes being constructed in Box Canyon, said we should have homes placed further apart. The Committee agreed.

Shifting to the east side of the reservation, requests for luxury homes to rent along Frazier Wells Road, growing and then selling traditional food at Frazier Wells (near mile post 22 on Route 18), more utilization of the Youth Camp, and establishing a tribal herd were brought forth from the public. Vice Chair Vaughn said she liked the idea of having more homes along Route 18 in the vicinity of Frazier Wells. Also, can we add a new fire station on Route 18 to help decrease 911 response times to the east side and can the Havasupai tribe help the tribe with the funding since they would also benefit from the facility? Speaking of 911 response times, Chairman Bravo noted the slow response time to an incident over the weekend at GCW. Ms. Nieto also related her recent experience with a 911 call she made for Hualapai Transit which was less than ideal. Mr. Davidson mentioned that part of the 141-acres designated for Regional Commercial at the intersection of Route 18 and State Route 66 could be converted to a Government/Commercial land use designation for the new fire station. Mr. Clay Bravo suggested the northeast corner of the intersection; however, the Committee decided on placing next to the south bound lane of Route 18 given the higher ground and proximity to the Limestone airstrip.

Ms. Dawley asked about plans for glamping near the Youth Camp, Mr. Bravo said there was discussion several years ago about making room for such a use north and east of the Youth Camp. Mr. Davidson said the current tribal tourism plan

effort being performed by the tribe, with the support of third-party consultant, is also considering that area as well as a second location to west of the Youth Camp near Turkey Tank Trail. Also, a nine-acre Government/Commercial land use designation has been placed at Thorton Tower to cover the existing facilities operated by Forestry, Natural Resources, and the BIA.

Mr. Davidson next reviewed improvements requested at the Diamond Creek launch point on the Colorado River which included paving Diamond Creek Road, improving Diamond Creek Beach, removing the ramadas, improving the camping grounds, constructing a restroom & cleaning station, removing Tamarisk trees for water conservation, establishing a hiking trail up Hindu Canyon and creating an Indian Garden. Except for the hiking trail, these uses can be accommodated within the 10-acre area designated for Recreation.

For Valentine, the community asked that the old schoolhouse be remodeled into a museum, use native Cottonwood trees found along the Truxton Wash to build an artists' museum, and improve the area in general. To help these requests, Mr. Davidson pointed out the new Historical land use designation for the old one-room schoolhouse, the Valentine Boarding School, the old BIA superintendent's office and nearly two acres to preserve the Schrum Family's ceremonial site. Also, the 20-acre Valentine Cemetery site has been designated as "Open Space," a land use designed to protect cultural sites.

To conclude the Community Meeting comments, requests for Grand Canyon West are as follows: build the most at GCW, expand development at Eagle Point to the north and south of the Skywalk, make Hualapai Point look more traditional, remove the golf course, start ATV rides along the Canyon Rim, preserve native plants, including pre-historic palms, at Guano Point, plant grass, and pave Buck & Doe Road for a scenic driving experience but also keep things indigenous.

Mr. Davidson noted the commercial area at Eagle Point contains 17-acres which allows room to expand operations to the north. The golf course and mid-priced hotel have been removed to lessen the impact of the land. In addition, some 733 acres encompassing Quartermaster Point have been designated Open Space to prevent development of this sacred site. Areas adjacent to and supporting GCW include 6 acres designated for Manufacturing Industrial land use at the borrow pit/quarry on Buck and Doe Road, a 2-acre Government/Commercial land use for the proposed electrical substation and 11 acres around the existing 400,000 water tanks to accommodate a water treatment plant and evaporation pond, part of the new facilities needed to perfect the tribe's 2022 Water Rights Settlement.

Thinking of operations at GCW, namely transporting tourists by helicopter from the airport terminal down to the pontoon docks, Mr. Bravo said the tribe should look into building a sky tram. Given the tribe's experience with helicopter operations, such as those at Whitmore Wash, such an option will help the tribe regain control of the tourist trade visiting the reservation. Mr. Bravo advised the sky tram to be located in Descent Canyon. Mr. Bravo also suggested that GCW's western boundary line be shifted further east to allow the two dry tanks that lay within the GCW boundary, unimpeded access to cattle.

The last set of slides depicted land uses for the Big Sandy Valley, Cholla Ranch, Hunt Ranch and Clay Springs. These have been designated with the Agricultural (Clay Springs), Manufacturing Industrial (flagstone quarry west of Buck and Doe Road), Government/Commercial (West Water) or Agricultural Business land use designations to mirror their current and planned uses. To align with the current effort to save the Ha' Kamwe' sacred spring at Cholla Ranch, the 40 acres surrounding it have been designated Open Space.

## 10. Goals, Objectives and Policies

Mr. Davidson next reviewed the revised draft language for goals, objectives, and policies that were the last part of Planning's March 5<sup>th</sup> as follows.

### Revised Economic Development Goals, Policies & Objectives based on Public Comments and Committee Discussion

- *Policy 3.6*      *Maintain and improve campgrounds (trails, ramadas, sanitary facilities, etc.) to meet and exceed visitors' expectations.*
- *Goal 9:*        *Maximize the development potential of lands held in fee by the Hualapai Tribe*
- *Policy 9.1*      *Commission a "Highest and Best Use" study to determine the economic potential of the tribe's various properties.*
- *Policy 9.2*      *Create a development plan for the highest and best use of the land.*
- *Policy 9.3*      *Seek land entitlements from the local jurisdiction to obtain the highest and best use of the land.*
- *Policy 9.4*      *Develop the land.*

- *Implementation Measure 14. Separate the economic development functions from the Planning and Economic Development Department to create a stand-alone Economic Department when the tribe's partnership with Mohave Community College that established the Small Business Development Center in Peach Springs is concluded.*

#### Revised Ranching, Forestry and Mining Goals, Policies & Objectives based on Public Comments and Committee Discussion

- **Policy 1.1** Manage livestock grazing consistent with Master Plan objectives *as further specified in the Hualapai Grazing Ordinance (2B).*

#### Revised Environmental Goals, Policies & Objectives based on Public Comments and Committee Discussion

- **Policy 1.3** Natural resources should be managed *in accordance with the Hualapai Natural Resources Conservation Ordinance and* in a manner which is consistent with sound conservation practices and ecological principles that assures the resource is protected from adverse impacts.
- **Objective 3.1** Expand the sidewalk system, particularly in Peach Springs, along existing streets *and on existing trails.*

#### Revised Transportation Goals, Policies & Objectives based on Public Comments and Committee Discussion

- **Objective 1.9** *Install streetlights where needed to reduce traffic accidents and increase overall community safety.*

#### Revised Public Facilities & Buildings Goals, Policies & Objectives based on Public Comments and Committee Discussion

- **Objective 1.8** *Build a sole-purpose Cry House*
- **Objective 1.9** *Construct a Multi-Use Recreation and Sports Complex*
- **Objective 1.10** *Create a Re-Entry and companion Detoxification Facility*

#### Revised Housing Goals, Policies & Objectives based on Public Comments and Committee Discussion

- **Policy 6.4** *New home sites should only be approved where emergency response times are less than 30 minutes in all weather conditions.*

Given some objection by Committee members and recollections of family members living off-grid for decades, Ms. Dawley advised Planning research language from other rural communities to see how they handle emergency responses to remote homes sites in their jurisdictions. Allowing a 30-minute response time is too generous. Ms. Talieje opined that people who chose to live in a remote area must take some responsibility for doing so. Mr. Bravo advised the Planning staff's recommendations prepared for IDT, TERC and tribal council note these potential long response times.

Mr. Davidson handed out the first five sections of the draft Master Plan for the committee members to review for the next meeting.

#### 11. ADJOURNMENT

The Committee agreed to meet again in two weeks. Chairman Bravo requested a motion to adjourn the meeting. Ms. Nighthorse made a motion to adjourn with a second by Ms. Dawley, motion carried unanimously at 8:20 PM.

## Apply for the American Indian/Alaska Native Veteran Copayment Exemption

### What is the copay exemption?

The law stating American Indian/Alaska Native Veterans do not pay copays for VA health care services and urgent care visits.

### Who can receive the copay exemption?

American Indian/Alaska Native Veterans who are enrolled in VA health care. Access the QR code on the right for more information.



### How do I apply for the copay exemption?

Complete the following three steps:

1. Make a **copy** of only **one** of the following Official Tribal Documents, including, but not limited to:
  - Tribal Enrollment or Citizenship/Membership ID Card, or
  - Certificate of Degree of Indian or Alaska Native Blood issued by the Bureau of Indian Affairs, or
  - Documentation issued by a Tribe on official letterhead indicating individual affiliation.
2. Fill out VA Form 10-334 and make a **copy**. The form can be found at <https://www.va.gov/find-forms/about-form-10-334>.
3. Mail both documents to the address below:

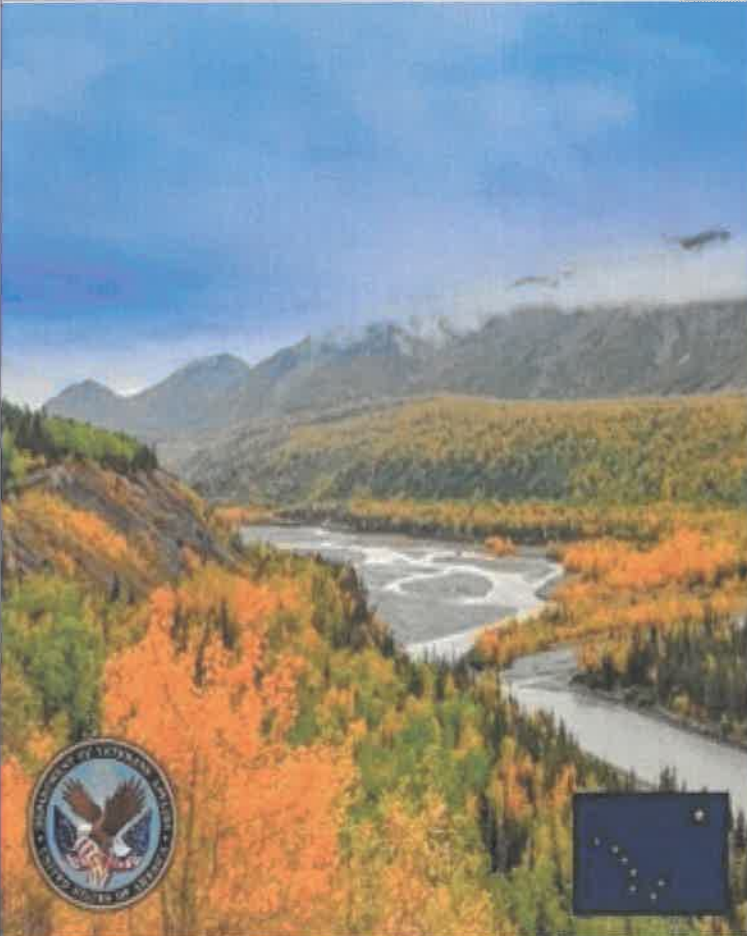

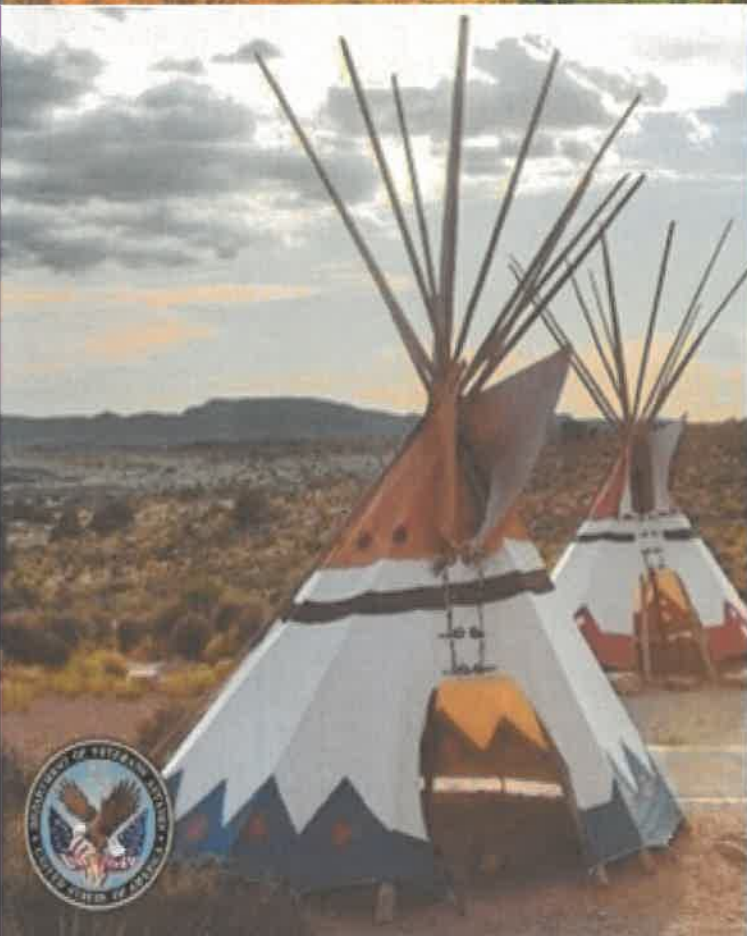

## Toolkit Purpose and How to Use This Document

To celebrate the one-year anniversary of VA’s implementation of the American Indian/Alaska Native Veteran Copayment Exemption, this toolkit aims to 1) equip external partners with materials to promote the copayment exemption and encourage Veterans’ applications, 2) inform external partners of the VHA Office of Tribal Health’s upcoming outreach engagements, which partners are encouraged to attend and/or participate, and 3) promote partners’ sharing of engagements in which the Office of Tribal Health and others can participate to provide outreach on the copayment exemption and enrollment in VA health care.

The Office of Tribal Health developed this toolkit for use by its external partners, including, but not limited to the White House, congress, other federal agencies, Tribal nations, and Tribal-related organizations. The Office recommends that partners use the communications content in Native Veteran-facing outreach, care sites, newsletters, social media channels, radio and news broadcasts, and online partner organization platforms. OTH encourages maximal reach through:

- **Using social media messages** on social media channels and re-posting and tagging Veterans Health Administration’s social media posts;
- **Displaying the national poster** in medical facilities, office buildings, community centers, and on digital or printed poster displays;
- **Including messaging** in local and national newsletters, GovDelivery, blogs, and more; and
- **Sharing content with existing Veteran Service Organizations and partner contacts** to amplify messaging with all audiences and encourage cross-promotion.

## Main Message and National Poster

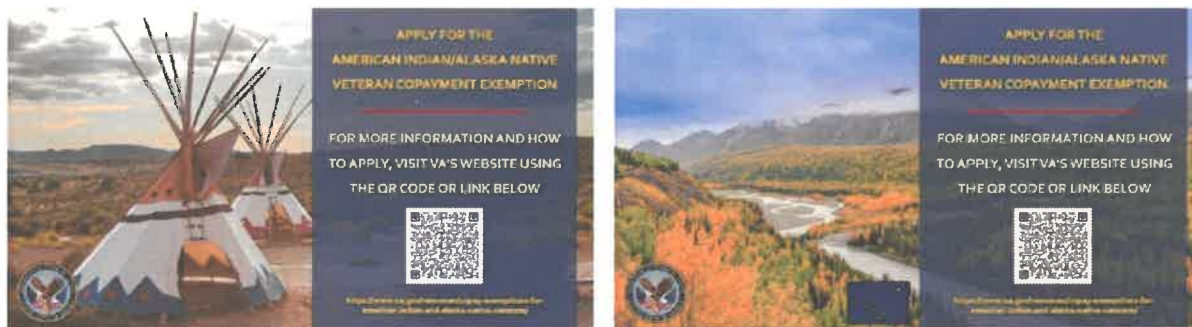


Figure 1: National Poster

*Communications to Native Veterans and Tribal Nations should focus on the following main message and call to action. The Office of Tribal Health recommends sharing the national poster (Appendix A) with the main message or other messaging, as desired. Three versions of the poster are available for use; two of the versions are displayed in Figure 1, below. The poster can be incorporated into website updates, blogs, emails, digital publications, and facility and clinic walls or digital displays.*

American Indian/Alaska Native Veterans serve at a higher rate compared to any other group of Veterans. To honor these Veterans and treaties with sovereign nations, eligible Native Veterans no longer have a copayment when receiving VA health care and are eligible for retroactive refunds for copayments for VA health care services (inpatient, outpatient, urgent care, and prescriptions) provided on or after January 5, 2022. The copayment exemption aims to address health care access and health care disparities experienced by Native Veterans by eliminating copayment requirements so that Veterans are more likely to utilize the benefits they have earned.

Approximately 65,000 Native Veterans are enrolled in VA health care and more than 4,000 of those Veterans have been approved for the copayment exemption. So far, VA has exempted and/or reimbursed more than 168,000 copayments totaling more than \$3 million. These numbers continue to grow, and so does VA’s outreach to increase applications for the copayment exemption. VA welcomes the support of its partners to amplify its outreach for this important effort.

### American Indian/Alaska Native Veteran Copayment Exemption

- The American Indian/Alaska Native Veteran Copayment Exemption was made possible by the legislation titled “Johnny Isakson and David P. Roe, M.D. Veterans Health Care and Benefits Improvement Act of 2020,” also known as “Megabus Section 3002.”
  - Through this legislation, American Indian/Alaska Native Veterans no longer have a copayment when receiving VA health care and are eligible for retroactive refunds for copayments for VA health care services (inpatient, outpatient, urgent care, and prescriptions) provided on or after January 5, 2022.
  - The copayment exemption honors treaties with sovereign nations, addresses health care access and health care disparities, provides more health care options, and continues VA’s efforts to strengthen and build trust.
    - **[Note: The copayment exemption has been earned by American Indian/Alaska Native Veterans and is not financial aid/relief.]**
- Thousands of American Indian/Alaska Native Veterans have been approved for the copayment exemption, but many more can apply.
  - Approximately 65,000 Native Veterans are enrolled in VA health care and more than 4,000 of those Veterans have been approved for the copayment exemption.
  - Among the Veterans who have used the copayment exemption, VA has exempted and/or reimbursed more than 168,000 copayments totaling more than \$3 million. This also includes reimbursement of copayments for Native Veterans who are deceased.
  - These numbers continue to grow, and so does VA’s outreach to increase applications for the copayment exemption. VA welcomes the support of its partners to amplify its outreach efforts.
  - The VHA Office of Tribal Health is available to conduct outreach during events hosted by other organizations. Please contact the Office at [VHAOfficeofTribalHealth@va.gov](mailto:VHAOfficeofTribalHealth@va.gov) to partner during outreach events.

- American Indian/Alaska Native Veterans enrolled in VA health care can apply for the copayment exemption by completing three steps:
  - Make a copy of only one of the following official Tribal documents, including, but not limited to:
    - Tribal Enrollment or Citizenship/Membership ID Card, or
    - Certificate of Degree of Indian or Alaska Native Blood issued by the Bureau of Indian Affairs, or
    - Documentation issued by a Tribe on official letterhead indicating individual affiliation.
  - Fill out VA Form 10-334 and make a copy. The form can be found at <https://www.va.gov/find-forms/about-form-10-334>.
  - Mail both documents to the address below:

- There are five ways to enroll in VA health care, including calling VA at 877-222-8387.

  - Information and documents needed to enroll in VA health care include:
    - Military discharge papers (DD 214 or other separation documents).
    - Social Security numbers for you, your spouse and your qualified dependents.
    - Insurance card information for all health insurance companies that currently cover you.
    - Income verification.
  - ***Did you know?*** American Indian/Alaska Native Veterans can receive health care from VA, Indian Health Service, and private health care. Veterans do not have to pick one or the other and can use all three to receive health care services.

### American Indian/Alaska Native Veteran Copayment Exemption

As you may have heard, American Indian/Alaska Native Veterans no longer have copayments for VA health care, urgent care, or prescriptions. VA also reimburses American Indian/Alaska Native Veterans for copayments paid on or after January 5, 2022.

"To live their best lives, Veterans need access to affordable health care," says VA Under Secretary for Health Dr. Shereef Elnahal. "This copayment exemption honors our treaties with sovereign nations and the distinguished service of American Indian and Alaska Native Veterans."

Eligible Veterans include any American Indian/Alaska Native Veteran who meets the definition of "Indian" or "urban Indian" under the Indian Health Care Improvement Act.





Since VA began the copayment exemption in April 2023, more than 4,000 Native Veterans have been approved for the exemption and VA has exempted and/or reimbursed more than 168,000 copayments totaling more than \$3 million.

VA is proud of this progress, but encourages its partners to help increase awareness of the copayment exemption. Veterans can apply by completing three steps: 1) complete [VA Tribal Documentation Form \(VA Form 10-334\)](#); 2) make a copy of official documentation of Tribal affiliation; 3) mail both documents to VHA Tribal Documentation at P.O. Box 5100, Janesville, WI 53547.

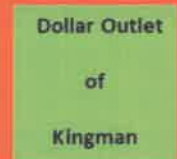

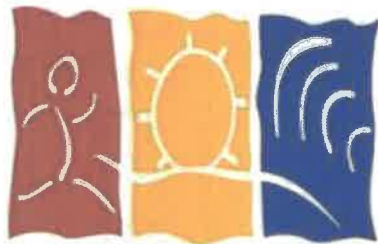

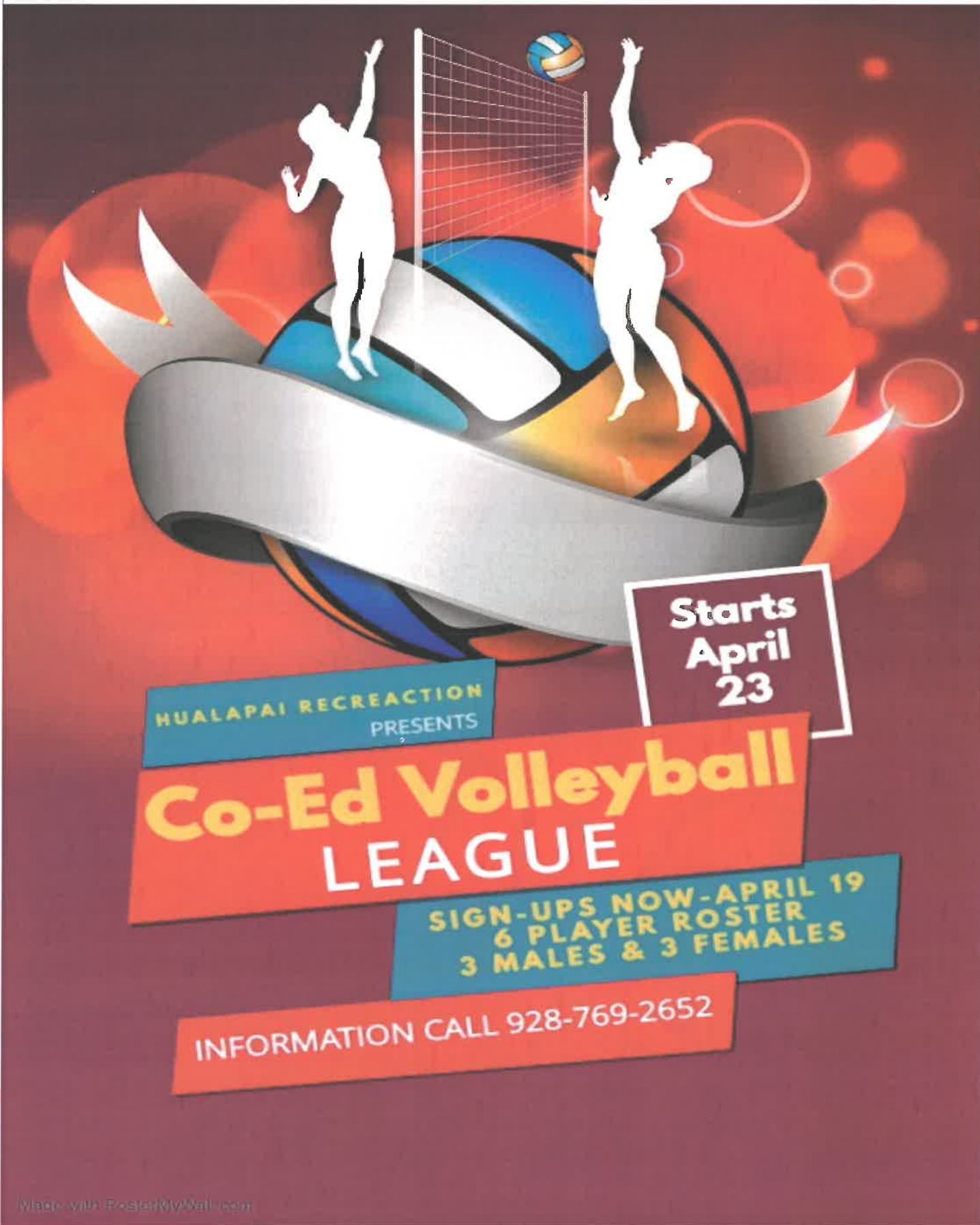
