Dear Hualapai Tribal Members,

It is with great pride I can say I am Hwal'bay. My name is Robert Bravo Jr. and I am running for a Hualapai Tribal Council seat. My professional background is business and was very successful in my interim position as the CEO of Grand Canyon Resort Corporation from September 2009 thru September 2011. I also served as a Hualapai Tribal Council member in 2013. I have over 25 years of upper business management and leadership experience and since 2020 I have served our people as a Hualapai Tribal Court Advocate and support Hualapai Tribal entrepreneurs.

Family is of most importance to me. I enjoy hunting, camping, golfing and spending quality time with my entire family and friends. My father and mother are Robert Bravo Sr. and Marilyn "Imus Bravo. My father was born and raised in Nelson Arizona where his father Torivio Bravo was raised from the age of 14. My mother Marilyn is full blooded Hwal'Bay. My paternal great grandmother is Queenie Imus who was married to John "Wath-Nack-A-Ma Imus who was an Indian Scout for the U.S. Army. My maternal great grandmother was Alma "Lane" Fielding from the Big Sandy. Alma was married to Tom Lane who was from the Blue Mountain area.

It will be my honor to serve our people as a Hualapai Tribal Council Member. Our Constitution permits "all" tribal members to share in the responsibility of tribal government. The responsibility is not just an elected position, but to become a leader of our great nation to help make decisions that will be in the best interest of our people and the land we live on.

As your Council Member here are some focus points:

- As your Council Member I will devote official time and my own personal time to the problems of basic policy and also work
  as a liaison between the Tribal Council and our Hualapai people.
- I will promote economic development opportunities to ensure a stable working environment to provide more jobs for "all" Hualapai's and show the world once again that Hualapai's are great entrepreneurs.
- I will serve the Hualapai people first and foremost in everything that I do and not my own personal interests. Putting the Hualapai people first means doing what is in the best interest of the community.
- I will avoid any conflict of interest that would keep me from putting the Hualapai people first.
- I will focus my efforts on day to day operations and also the future development of the tribe. I feel it is a public official's
  responsibility to be honest with the public, disclose any possible conflict of interest and provide information to the Tribal
  Membership as needed.
- I will focus on a one specific change in our Hualapai Tribal Constitution to lower the blood quantum to 1/8. This is important for the longevity of our tribe and our people.
- I will execute a plan to utilize and develop the Truckee California property that belongs to the Tribe.
- I will make a commitment to look out for the best interest and quality of life for our Hualapai Tribal Elders.

As Hualapai Tribal members we are truly blessed to live in such a unique area which is encompassed within one million acres of beautiful pristine land. Our reservation borders 108 miles of the Colorado River that is located on one of the World's Natural Seven Wonders, the "Grand Canyon". There are many issues we need to focus on so we can continue to be self sufficient and not allow anyone to take away our great opportunities for economic development. For example, our tribe has been in negotiations with the National Parks on the Colorado River Management Plan. For many years the National Parks has tried to regulate and cap our business to less than what the Hualapai River Runners, Grand Canyon 9 Rapids and the Grand Canyon Pontoon operations are currently doing. This could potentially mean that the amount of passengers the Hualapai Tribe can sell in our tourism operations will be controlled by the National Parks. Many of the companies that travel from Lees Ferry are not paying for their guests who encroach on our tribal lands. I will help adopt a procedure that monitors our land to make sure we are getting paid for each guest that trespasses on our property. As an example, at Whitmore Wash (Hualapai Tribal Land) upper river rafter commercial concessioners and Bar 10 do helicopter exchanges and the river rafters allowed to despoil our land. My commitment will be to execute a plan on how to monitor the area to make sure our tribe is getting the revenue for each transfer and implement fines for the desecration of our land. In other words, I will do my research to see why the Hualapai Natural Resources Conservation 24-70 Ordinance has been violated.

The lithium mining where the Australian mining company Hawkstone has been drilling on three sides of Hualapai land in Arizona's Big Sandy River Valley is also of concern. Our argument is that the BLM has violated their rights in the oversight of the project. My responsibility and commitment will be to form an alliance with County, State and US Government officials to continually seek resolution.

I was fortunate to start working with the Grand Canyon Resort Corporation in 1997. During my tenure I have seen many challenges and have had the opportunity to be part of the newest changes that have occurred. I was also involved with the runway project team and worked closely with FAA representatives to develop the new runway. I participated with the Hualapai Tribal Council, GCRC and the National Parks to discuss the Colorado River Management Plan.

When elected, I will gather information and share it all tribal members have a clear understanding of the issues that affect the Hualapai Tribe. Political terms don't last forever therefore communication is very important. We must all know what is at risk so our younger generations can continue to protect our land and our constitutional rights. My duty to mitigate most situations instead of paying our attorney's for advice. They don't dictate to us how to run our tribal government they work for us and follow our lead and direction.

We have a great community that every tribal member should take pride in. What can we do as tribal members to make it a better place to live? What can we do to turn Peach Springs into a more cohesive community? My goal as an elected official will be to help our community be a better living place for all tribal members and provide more job opportunities.

We have social issues similar to other communities and reservations and we need to focus and devote more of our resources on:

- Better prepared and pro-active for potential crisis situations
- Substance abuse
- Domestic violence
- Political interference
- Separation of powers between the judicial and administrative arms of the Tribe.

As your elected Council member it would be my responsibility to help implement programs to curb these and other issues to help our people. We also must never forget about our culture and traditions. Our parents and grandparents were taught in order to have respect we must show respect everyone. I feel we must regain that pride and have respect for one another within our community if we are to move forward as a united tribe. As your potential elected official I give you my word it will be my responsibility to work with our Chairman, Vice Chairman and the entire Council to look out for the best interest of the Hualapai people, our tribal businesses, the Hualapai tribal assets and the tribes Natural Resources. I will support Council decisions and promise to keep you informed. Currently, I am familiar with the issues the Hualapai tribal council has been dealing with. If elected, I pledge to lead by example and enforce the Hualapai Constitution and all laws within our tribal government. In closing, I would appreciate your vote and support as your newly elected Council member of our "Great" Hualapai Nation.

### **Tribal Member Names and Addresses**

Our office is charged with maintaining current and accurate names and addresses of all tribal members; Hualapai Constitution, Article II. Our office has experienced delays in receiving name changes that may be the result of marriage, adoption or voluntarily changing of one's name.

The process in changing your name with the Enrollment Office is as follows:

- 1. Provide a marriage license, adoption decree or court order of name change;
- 2. Provide an updated Social Security Card with changed name;
- 3. Issuance of new tribal ID and CIB;
- 4. Any other questions, please contact our office.

Addresses are important for tribal members to frequently update with our office. Enrollment Office supplies that information for tribal events like Election seasons and distributions. This will greatly establish a database of up-to-date tribal member data.

### **Tribal Member Death**

In the event of a death of a tribal member, please notify our office so we may inactivate their profile and once a death certificate is received, provide a copy to our office so we may officially close their tribal member file.

The Hualapai Master Plan Update Committee is scheduled to complete its twelfth meeting on Wednesday, May 15, 2024, beginning 5:00 PM at the Multi-Purpose Building, located at 470 Hualapai Drive in Peach Springs.

The 18-member Committee was formed by Hualapai Tribal Council on March 6, 2023, with the task of updating the tribe's existing draft Master Plan. The Master Plan is a statement of community values and aspirations, written as goals and policies, and shown on maps and diagrams. This will be the primary tool for managing community change to achieve the desired quality of life for tribal members living on the reservation, trust lands and private property owned by the tribe.



- 2. CALL TO ORDER: Chairman Robert Bravo called the meeting to order at 6:06 PM.

#### 3. ROLL CALL:

#### Present:

Also in attendance were Olin Beecher, Game & Fish Director, tribal members Adina Guy and Lisa Gala, Kevin Davidson, Director of the Hualapai Planning & Economic Development Department and Nona Baheshone, Bahozhoni Development.

#### 4. AGENDA AND MINUTES APPROVAL:

Chairman Robert Bravo requested a motion to approve the meeting agenda. Ms. Camille Nighthorse made a motion to approve the agenda and Ms. Andrea Nieto seconded. Committee approved the agenda unanimously.

Chairman Bravo requested a motion to approve the March 20, 2024, meeting minutes. Ms. Andrea Nieto made a motion to approve the agenda and Ms. Nighthorse seconded. Committee approved the minutes unanimously.

#### 5. REVIEW OF ALEXAS WALEMA

Mr. Davidson began the presentation by noting this is the committee's eleventh meeting where the committee will review the draft Master Plan Elements with the goal of transmitting the document to IDT and TERC for review. However, before beginning the review, Mr. Davidson shared highlights from a recent six-page letter sent to the Committee by Ms. Alexas Walema as follows:

- 1) Welcome signs/archway along State Route 66 at mile post 96 and at Juvenile Detention.
- 2) New boats for River Runners, camping supplies, precautionary measures, etc.
- 3) Block wall, landscaping & lighting along State Route 66 to protect homes and make community more attractive.
- 4) New homes, tribal office, dispensary, high-end hotel, movie theatre, splash pad, casino, truck stop, etc.
- 5) Land for renewable energy.
- 6) Respect sacred areas.
- 7) Public parks to host multiple sports, reconstruct Dam on Diamond Creek, go-cart track, horseback riding, etc.
- 8) Homes for single people, place homes west of 4H, south side of State Route 66, homes need fireplaces vs. electric space heaters.
- 9) Rebuild old gas station.
- 10) Construct a lift (ski lift) to connect all of Peach Springs including Diamond Creek Dam
- 11) Start a new Hualapai festival for land & cultural awareness.

Mr. Davidson said some of these ideas have made it into the Master Plan such as better street lighting, a new tribal office, homes for single people, and protecting sacred sites. Ms. Walema's letter also thanked the committee members for their dedication to help make the reservation a better place to live.

#### 6. HUNT RANCH TRESPASS

Prior to beginning the formal review of the document, Chairman Robert Bravo asked the Committee if they would like to hear from Mr. and Mrs. Hunt on two situations unfolding on one of the Hunt Ranch parcels which has recently achieved trust status and is now under the care of the Hualapai Tribe. Hearing no objection, Chairman Bravo asked the Hunt's to explain the situation. The first was what appears to be hunters trespassing on tribal land. Game and Fish should investigate this apparent trespass. The second concerns the poor condition of the ranch home and accessory buildings which are now the tribe's responsibility to maintain. Chairman Bravo advised the Hunts prepare a proposal for the Hualapai Department of Natural Resources to consider since it appears the tribe will have to out-source the maintenance of the buildings. With the discussion concluded, Mr. Davidson began the formal review as follows:

Mr. Davidson noted the vision statement leads off the document followed by a general introduction to the tribe and its history, highlights of key development goals, a review of multiple community needs assessments performed over the past two decades, a list of critical situations such as high unemployment, lack of business opportunities, high poverty and aging infrastructure and ways to respond to these situations, a list of priority projects for 13 development areas from Peach Springs to Truckee, and concluding with a statement of the plan's intent which uses goals, objectives and policies across nine Elements or chapters to put into practice the tribe's values and aspirations. With the Committee raising no concerns with the wording, Mr. Davidson moved on to the second part of the Master Plan.

Mr. Davidson said this chapter provides an inventory of the reservation, trust and private land held by the tribe with definitions of the various land uses such as commercial, residential, and open space and how they are overlain on the dozen plus planning areas. Ms. Nieto was hoping to see a more declarative statement in Section 2.2 which notes the Rural Residential land use designation shall allow for a home site which contains one acre or more in size. Mr. Davidson said he would look to add more definition to the section which will help those home site lease holders with land at the lower end of the size range expand their home sites. The committee was agreeable to this modification. Mr. Manny Siyuja was skeptical of the efficacy of the Master Plan as policy document in general given the political winds or "realpolitik" of our times. Mr. Davidson noted the rather lengthy discussion the Committee began in September of 2023 dissecting the language of several dozen goals and scores of objectives and policies to make them more relevant for today. Chairman Bravo asked if the Master Plan should include a policy to prevent the sales of tribal land, e.g. Truckee. Mr. Davidson replied this may not be necessary since the 2016 attempt by tribal council to sell the Truckee land was halted because it was not put out to referendum vote as required by the tribe's constitution.<sup>2</sup>

To follow-up with the Committee's discussion from March 20<sup>th</sup> about placing a new EMS facility on Route 18, Mr. Davidson displayed the revised land use diagram showing a 20-acre Governmental/Commercial land use designated on the high ground north of State Route 66/Route 18 intersection on the west side of Route 18 for a future fire station. The Committee agreed with this location. Ms. Nighthorse also pointed out that the Commercial land use designation on the northeast corner of the State Route 66/Route 18 intersection was designated for an RV park. Mr. Davidson briefly reviewed the 2021 feasibility study for a 100-space RV park like what one would expect to find at the Avi Casino. Ms. Nieto said in all likely hood the RV park would just need a few basic hook-ups for sewer, water and electric, and could forgo the club house, pool and other amenities.

With the charge given by the Committee to Planning to research policies for rural development considering public safety and public service concerns faced by people living in the outlying areas of the reservation, Mr. Davidson proposed new Policy 2.8 as follows: "In reviewing home site proposals, the tribe shall consider issues of community character, compatibility of use, environmental impact, resident security and safety, and provision of public services." This language is based on Mohave County's General Plan Policy 11.8 for rezoning property in rural parts of the county. Mr. Davidson said this policy is designed to replace Housing Policy 6.4 discussed at the March 20<sup>th</sup> Committee meeting where the Committee noted the problems of only allowing new home sites within a 30-minute response time from the nearest fire or police station. The Committee agreed by consensus to incorporate new Policy 2.8 into the Land Use Element and remove proposed Policy 6.4 from the Housing Element. Ms. Nieto added that Public Works will not spend money building or maintaining roads that are not officially designated by the tribe/BIA so those applying for home site leases should beware. Mr. Davidson replied that Planning, IDT, TERC and tribal council will use the language in Policy 2.8 to consider public facilities, such as roads, during the home site review process.

Mr. Davidson brought to the Committee's attention that some 1 million acres of the reservation, laying outside the development area listed above, have not received an official land use designation. The leading options include:

- . Open Space for the preservation areas that culturally significant, have difficult terrain and are generally inaccessible,
- · Agricultural that allows ranching, farming & forestry pursuits, and
- <u>Agricultural Residential</u> which is designed to accommodate small-scale ranching and farming on large residential parcels (5-acres).

The map of the reservation shows 306,000 acres in the canyons leading down to the Colorado River. Placing the Open Space designation on these lands seems appropriate. Mr. Siyuja asked if the grazing district boundary lines could be shifted to allow for more development and less conflict with the ranchers. Mr. Beecher said that fence lines would have to be moved and new carrying capacity assessments conducted to determine how many cattle the smaller land area could sustain. Ms. Nighthorse asked about keeping large animals on her home site. Mr. Beecher said the tribe's Animal Control Ordinance only allows for pets. To keep livestock, you must be part of a cattle association, establish a brand, etc. Mr. Siyuja said he favored designating the undesignated portion of the reservation outside of the canyons as Agricultural Residential. Ms. Talieje agreed and said if development spreads then infrastructure will be obliged to follow. Additionally, this shows that the tribe is using their land which means it will less likely taken away by a future administration. Speaking of using the land, Chairman Bravo asked if tribal members could harvest sage and other native plants found on the reservation and sell it. Mr. Davidson said only the gathering of plants for traditional Hualapai uses and practices is allowed under the TERC Rules. Commercial use is not allowed without the tribe's approval (See Article V.n of the Hualapai Constitution). Ms. Talieje noted that during the COVID pandemic, non-tribal members where harvesting sage from the reservation for medicinal purposes. The tribe must be more vigilant to stop this activity. After additional discussion, the Committee agreed to designate the canyons as Open Space and the balance of the reservation land not already designated to be Agricultural Residential which allows the most flexibility for rural type development in the Hualapai hinterlands.

This element describes the current Indian Housing Plan that the Housing Department uses to implement its policies over a 5-year period. The plan must comply with NAHASDA which provides federal funding assistance to tribal housing programs. Major housing issues include long wait times for admittance to the program, overcrowded living conditions, need to modernize homes, providing homes for single people, and having more opportunities for home ownership units. The Growth Areas align with those noted in the Land Use Element. The chapter concludes with six goals and associated objectives and policies. To begin, Ms. Nighthorse asked about Policy 6.3 "New homes and home rehabilitations shall follow the International Energy Code and the International Residential Code," does this apply to all structures? Mr. Davidson said the codes are for custom, site-built homes such as those being constructed in Box Canyon and not manufactured homes or cabins which come "off the lot." Chairman Bravo asked if the language of Policy of 5.2 "Obtain funding for new homes and create rental opportunities for workers at Grand Canyon West," was too broad? This language aligns with federal housing policy. Ms. Talieje said we need a wall along SR 66 where the right-of-way adjoins the new LIHTC development in Box Canyon to protect the homes from automobiles which may crash off the highway. Mr. Davidson noted a wall would likely attract graffiti; however, some type of barrier is needed.<sup>3</sup>

The major issues are the lack of adequate public facilities and buildings on the reservation and the methods the tribe has used to secure funds to construct several public buildings over the past two-plus decades. Current Conditions list the existing buildings and a table of new buildings and facilities to be constructed within the time frame of the Master Plan. New objectives for public buildings include:

Ms. Nighthorse recommended the tribe visit the Salt River-Pima reservation to see good example of public facilities. With no additional comments from the Committee, Mr. Davidson turned next to the next element:

This chapter introduces the reader to past economic studies conducted in the greater western Arizona region, references the yet to be completed tribal tourism plan, which is still being drafted by the tribe's consultant, and mentions the tribe's role in implementing the Lower Grand Canyon Corridor Management Plan such as establishing the appropriate level of recreational use and providing proper sanitation facilities. Section 5.2 reviews the tribe's demographics such as education attainment, people working in various industries (education, health care, construction, etc.), household income, and poverty rates, with the latter showing that more than 50% of children are living in poverty on the reservation. Opportunity Zones, not something that directly affects the tribe given its tax-exempt status, covers that portion of the reservation that lies within Mohave County. In addition to the eight goals that are designed to stimulate the tribe's economic future, including supporting tribal entrepreneurship, Goal No. 9 seeks to maximize the development potential of the tribe's widely scattered private land holdings by commissioning "highest and best use" studies, creating development plans for the land and then executing the projects. The Committee was satisfied with the Element as written.

With 48 pages, Mr. Davidson noted this is the longest and most detailed chapter in the Master Plan largely given the work of three consultants whose analysis is summarized in the sections on renewable energy development and constructing a telecommunications system to deploy the internet on the reservation. The first five parts of the Element focus on land outside of Grand Canyon West (part six) and begins with a discussion on the water situation in Peach Springs which is plagued by aging infrastructure in need of replacement. The section also summarizes the tribe's 2022 water rights settlement and requests that Public Works and Natural Resources work together to expand the drinking water system to make non-potable water drinkable. Section 6.2 reviews the wastewater issues for Peach Springs and the Buck and Doe area and identifies the need to improve and expand the existing lagoon system in cooperation with Indian Health Services. Solid waste management, discussed in Section 6.3, notes the need to curtail wildcat dumping on the reservation and recommends the tribe create a waste recycling program to reduce waste going to the landfill.

Section 6.4 examines energy development beginning with electricity and summarizes the several feasibility studies for establishing a tribal utility authority, developing renewable energy projects for wind, solar and biomass, and then discussing ways to convey more electricity to and from the reservation via the regional transmission system. The section concludes with a brief discussion on natural gas service and the opportunities to improve the energy efficiency of buildings on the reservation. Goals and objectives encourage conversion from fossil-fuel derived energy (natural gas & coal) to renewable energy sources (solar & wind), distributed generation (roof top solar installation), a community-scale solar array to power Peach Springs, and the deployment of electric vehicle charging stations. The development of industrial-scale solar and wind farms on the reservation has been removed from the list of goals due to the amount of land disturbance required to establish such uses even though the reservation has a very good solar resource with some 300 sunny days per year.

Section 6.5 reviews the recently completed broadband study that discusses existing conditions on the reservation and lays out a roadmap to bring internet service to all points on the reservation and in Valentine. Mr. Davidson noted the Committee had yet to create a draft goal to implement broadband service on the reservation. Ms. Talieje and Ms. Nighthorse would like to see more access to the internet on the reservation, with Ms. Talieje saying the tribe should own and operate its own broadband network instead of relying upon third parties with the aim of serving communities outside of the reservation. Mr.

Davidson said he will draft a goal for a tribally controlled internet network and distribute it to the Committee for review before adding it to the Master Plan. The Committee was agreeable to this proposal.

To conclude the Element, the infrastructure needs of GCW are discussed, namely improving the water and waste water systems, the coming water line made possible by the tribe's 2022 water rights settlement, the proposed 36-mile, 69 KV power line and fiber optic line to help energize the anticipated growth made possible by the water rights settlement, and the successful deployment of the 885 KW solar array and battery bank at GCW which has significantly reduced the use of the existing diesel generators. To bring to head a few decades of discussion, new Goal No. 5 seeks to build a sky tram to connect the canyon rim to the pontoon operations along the Colorado River beginning with a feasibility study to determine if this is possible. The Committee had no additional comments on this part of the element.

The Element begins with a review of the five grazing districts operations and the allowable AUMs<sup>4</sup> for each totaling 2,963 AUMs for all five districts. Issues include the encroachment of non-native invasive species and tribal developments into grazing lands. Mr. Beecher noted the biggest conflict between ranchers and development lies with large-scale housing tract projects which bring forth a high concentration of people and their associated impacts vs. the individual tribal member establishing a home site lease.

Mr. Davidson reviewed Forestry's operations and their list of the duties that includes Forest Development, Timber and Wildland Fire Management Programs. Mr. Davidson concluded the review with Mining and pointed out the inactive flagstone mine on the west side of the reservation near West Water and the area reserved for mining adjoining the chemical lime plant at Nelson as the only mining locations on the reservation. Also of note is the tribe's 1980s resolution banning uranium mining on the tribe's lands. Goals for the Element include preserving and maintaining lands used for grazing, agricultural and forestry, promoting ranching and forestry activities for economic development, and limiting hard-rock mining activities on the reservation. The Committee had no additional comments.

The Element begins with an inventory of the 743 miles of roadways within the reservation and Valentine of which only 85 miles are paved. An additional 186 miles are designated to be added to the inventory. Major issues include poor roadway conditions, drainage issues, and traffic safety issues, including the at-grade railroad crossings on Diamond Creek Road and in Valentine, with a plan to construct an automobile bridge over the Diamond Creek Road crossing currently being pursued by the tribe through its Public Works Department. The Element lists a set of mid-term and long-term transportation goals to improve transportation access and safety as well as reduce train noise. Hearing no objection to the Element's contents, Mr. Davidson proceeded with the review of the next Element.

Major issues include maintaining the tribe's air quality which can be degraded by traveling on unpaved roadways and construction activity. Of note is the recent reduction in diesel generator usage at GCW thanks to the operation of the new solar array that provides about half of the energy needs of GCW. Water issues focus on maintaining groundwater quality, which is subject to pollution from run off, septic tanks, accidental spills from highway accidents and railroad operations, the need to treat Colorado River water made possible by the tribe's water rights settlement, and threat posed by a potential lithium mine being opened on public land adjoining the sacred Ha' Kamwe' spring on the Cholla Canyon Ranch. Preserving habitat, conserving soil and protecting the Colorado River, canyons leading to the river and the springs and seeps within those canyons is also discussed. Table 9.1 lists the sacred canyons and springs identified by tribal council via Resolution No. 67-97. Given that modern technology allows the public to look up these locations and map them on a hand-held device, the committee decided the table should be removed from the chapter and instead placed into an appendix which is not shared with the public. Goals include raising environmental awareness, protecting areas significant to the tribe, improving air quality and preserving the quality and quantity of water on the reservation in perpetuity. Mr. Clay Bravo noted the sacred designation of some canyons and springs was influenced by the politics of the time and warned against placing these designations on geographic features which gives them an apparent hierarchy of protection that reduces the importance of those not on the list. With the Committee having no further comment on the Element, Mr. Davidson turned the review to the final Element.

The final chapter discusses the importance of keeping the tribe on point in implementing the plan over the next 10 to 20 years with Planning's production of semi-annual reports showing the progress of the plan's implementation, forming relationships with outside entities where the tribe will need support from such entities to implement the plan, establishing an enterprise-wide geographic information system (GIS) so tribal departments can have access to the same information and avoid duplication of efforts and finally the creation of a comprehensive annual report by TERC describing the development activity which advances the Master Plan's goals, major issues that prevented the tribe from achieving its development goals and changes in circumstances which justify updating the Master Plan. Mr. Bravo asked if the Master Plan will require a NEPA review such as an EA be performed as part of the adoption process. Mr. Davidson said no; however, individual projects, such as the proposed Multi-Use Recreational Sports Complex will require a full NEPA review and development permit. With the review complete, Mr. Davidson asked the Committee if they were comfortable with transmitting the draft Master Plan to IDT and TERC. Ms. Nighthorse made a motion to transmit the draft Master Plan to IDT and TERC, with Mr. Siyuja seconding the motion. Motion approved 4-0-3 with Ms. Beecher, Mr. Hunter and Mr. Bravo not voting having arrived late to the meeting.

#### 17. COMMUNITY OPEN HOUSE - MAY 14, 2024

To conclude, Ms. Baheshone presented the outline for the third community meeting which will utilize the open house format as follows:

- 1. Presentation boards on what the Master Plan is about, the Plan's progress and how decisions were made.
- 2. Land use diagrams on display:
  - a. Changes to the land use diagrams
  - b. Review goal and policy changes that affect Land Use
  - c. Ranching, Forestry & Mining -

  - e. Economic Development -
- "We heard you" List other goals & objectives that were significantly changed based on community input from previous Community Meetings
  - a. Reference Committee meeting minutes
  - b. Reference Goals, Objectives and Policies from Master Plan on presentation boards
- 4. What is the next step? Timeline through to Tribal Council hearing at end of May

#### 18. ADJOURNMENT

The Committee was agreeable to the outline and holding the open house in mid-May. The Committee will meet the last week of April to review the IDT and TERC comments and make any changes prior the open house. Mr. Davidson congratulated the Committee for meeting some 15 times to parse the policy language of the Master Plan and thanked them for their time and dedication to the effort. Chairman Bravo called for a motion to adjourn. Ms. Nighthorse made a motion to adjourn with Mr. Hunter offering his second. Motion carried unanimously at 8:43 PM.
