POSTPONED: GENERAL ELECTION

By Court Order, Hualapai Court of Appeals

The new date of the General Election is:

Friday, June 28, 2024

Where: Multi-Purpose Building
Time: 8:00 am to 5:00 pm

On May 30, 2024, two days before the General Election, the Hualapai Court of Appeals (Justices April Olsen, Joe Keene, and Patty Ferguson) issued an Order requiring the Election Board to create a new, official ballot by adding one additional name as a candidate for Tribal Council Member.

In accordance with the Court Order, the General Election for Chairman, Vice Chairman, and three Council Member positions is rescheduled to June 28, 2024. New, official ballots in compliance with the Court Order will be mailed to all adult members of the Tribe at their last known address as soon as possible.

The lawsuit and Court Order involved the question of proof *residency* on the Reservation for at least 1-year immediately prior to the election, as well as the deadlines and process to submit documents to show residency. The Election Board initially denied the applicant's candidacy based on the documentation submitted. The Court of Appeals disagreed, and ordered the Election Board to prepare new ballots.

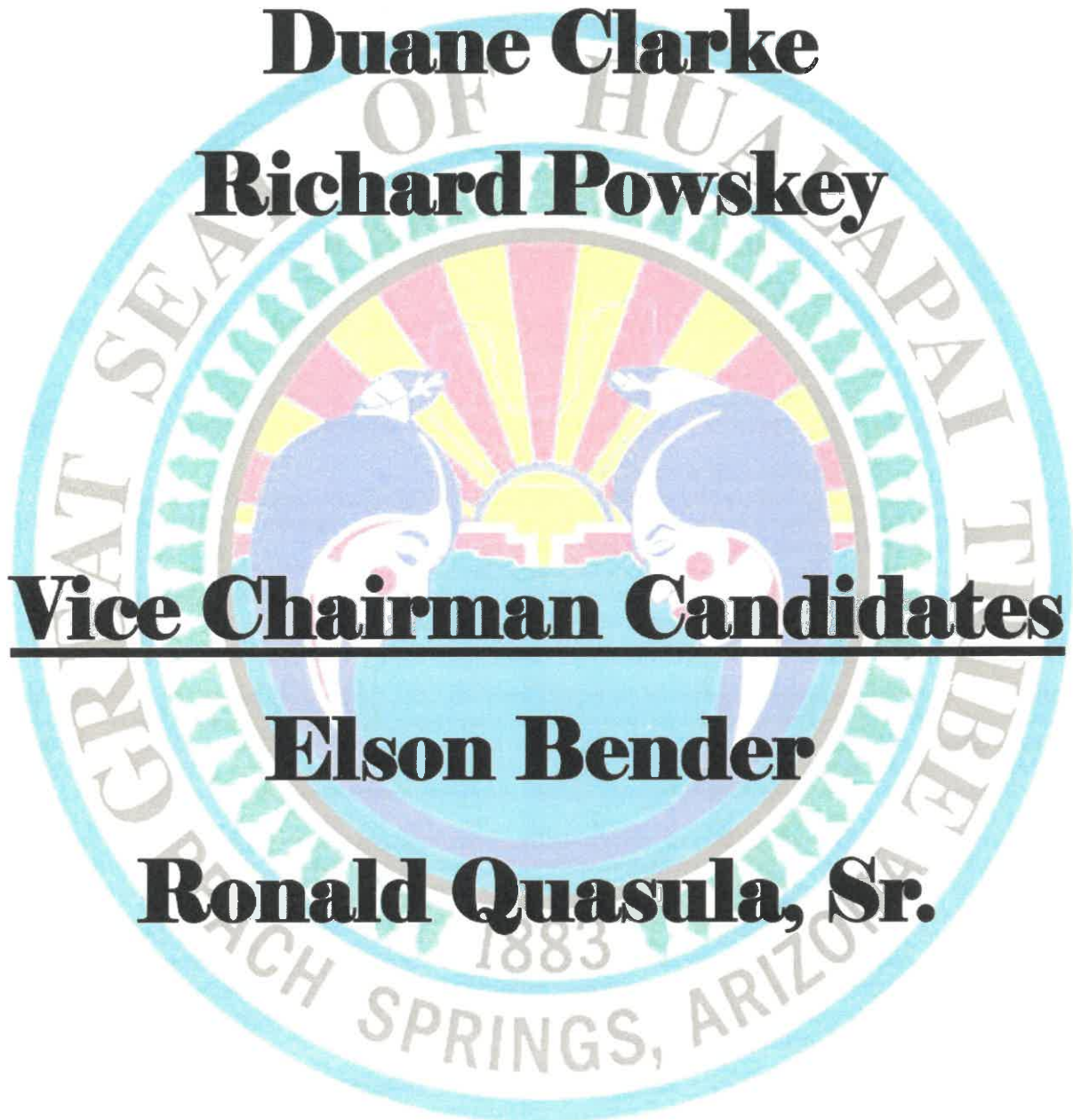

Greetings Hualapai Nation, Nyachyu, Elson Bender. First off, I would like to express my condolences and my thoughts to you all as you remember loved ones you lost over the past few years or as you continue to grieve. I understand the pain it brings.

A'HO, relatives, I humbly come to you as a candidate for the office of Vice-Chairman to serve the people of the Hualapai Tribe. I'm just like everybody else. No better. I have lived here in Peach Springs my whole life. Raised in a home with one alcoholic parent. Started school but dropped out, and got my GED. I was involved with the legal system for half of my life. Started a family then got sober. I have been sober for 19 years now.

My job experience has been a retail clerk at a gas station, a cook at the adult detention center, a medical transportation driver with Doris Butler, a driver for the elderly delivering food, I worked with Terri Hutchens when we first got EPCH internet radio going, as a teen mentor. I worked at the Boys & girls club with Lauri Crozier. I worked with the Alternative to Incarceration Program until the whole program was RIF'd in 2020 during the pandemic.

I have worked for the tribe in many capacities with the mind set of doing my best. I have ALWAYS went in with the mind set of change and doing my best to help the community. Although it may seem petty to some but like I said I am no different and I have the initiative and drive to bring different perspectives to the table.

I put my name in because as a community member I want things to change. Mostly, I am tired of seeing the same thing over and over from the same people. They get in there and what do they do? Some of the candidates have been on the council on and off since I was in high school and not much has changed. I want CHANGE. I want things to get better for our kids and their kids. I want PROGRESS. I want TRANSPARANCY. I want to be OPEN. The only way to change how it's been is TO BE THE CHANGE.

As I seek your vote, I will tell you now that I cannot make promises and say I will do things that I can not do alone; but I do have priorities and concerns. They are:

- holding directors and supervisor level employees to a higher standard
- Every department/program should have SOPs to eliminate the perception of favoritism and or discrimination – we have all felt discriminated against by certain programs.
- I will read old minutes for the past 10-15 years to “catch up”
- Investment to our infrastructure for existing and new homes
- Transparency – make public documents public and easily accessible.
- Providing information possibly through a tribal member portal accessible with unique usernames and passwords. Bring us into the 21st century.
- Issues that have plagued us for years which are: homelessness, housing shortage, grief, employment preparation, re-entry programs, domestic violence, victim services.
- Protecting our ancestral lands

A few gamyus ago, I saw that the tribe had put out an RFP for a large construction project. I attended this meeting as a community member for 2 days. There are projects that have been on the books for years. There is a building method that is called CMGC. A lot of the work can be done concurrently with one another. They will be building a new tribal administration building, paving roads in the community, out at youth camp and getting buck n doe shovel ready.

I know that the project team is worried that the new council will come in and stop their progress. I will not. I will support the team and their decisions as their work has the best interests of the Hualapai people at heart. I do not want to interfere with progress. It's been a

long time coming. I live here and our roads are in great need of repair. So, I commend the hard work of everyone who has a hand in making the upcoming changes in Peach Springs possible for our people and our community.

I encourage all tribal community members to get out and vote. Be a part of the change we long for. I am very much aware that I am one person, but I have a desire for change. Change has to happen for a better tomorrow.

Thank you for voting for me in May. In June I am asking you to VOTE FOR ME, Elson Bender for your next Vice Chairman. Hankyu.

I am running for Vice-Chairperson. I believe my many years of experience as a tribal council member gives me a running start. I will not have to undergo the “on-the-job-learning” to know the business of our tribal government. I will work full-time for all Hualapai people – for those that live on the reservation and for those that live off the reservation. I am asking tribal members to contact me and tell me what they would like to see changed or improved for the betterment of the tribe. As your Vice-Chairperson I will always have an open-door policy, meaning you can come to the office and talk with me, or you can call me.

Water will be a priority for me, particularly at Grand Canyon West. President Joe Biden signed the Hualapai Tribal Water Rights Settlement Act of 2022 into law in January 2023. The Act includes a trust fund of over \$300 million to develop water infrastructure on the reservation. We now have a right to 3,414 feet acre -feet of water per year from the Colorado River. Let us work together and get water to where we need it! The ball is in our court.

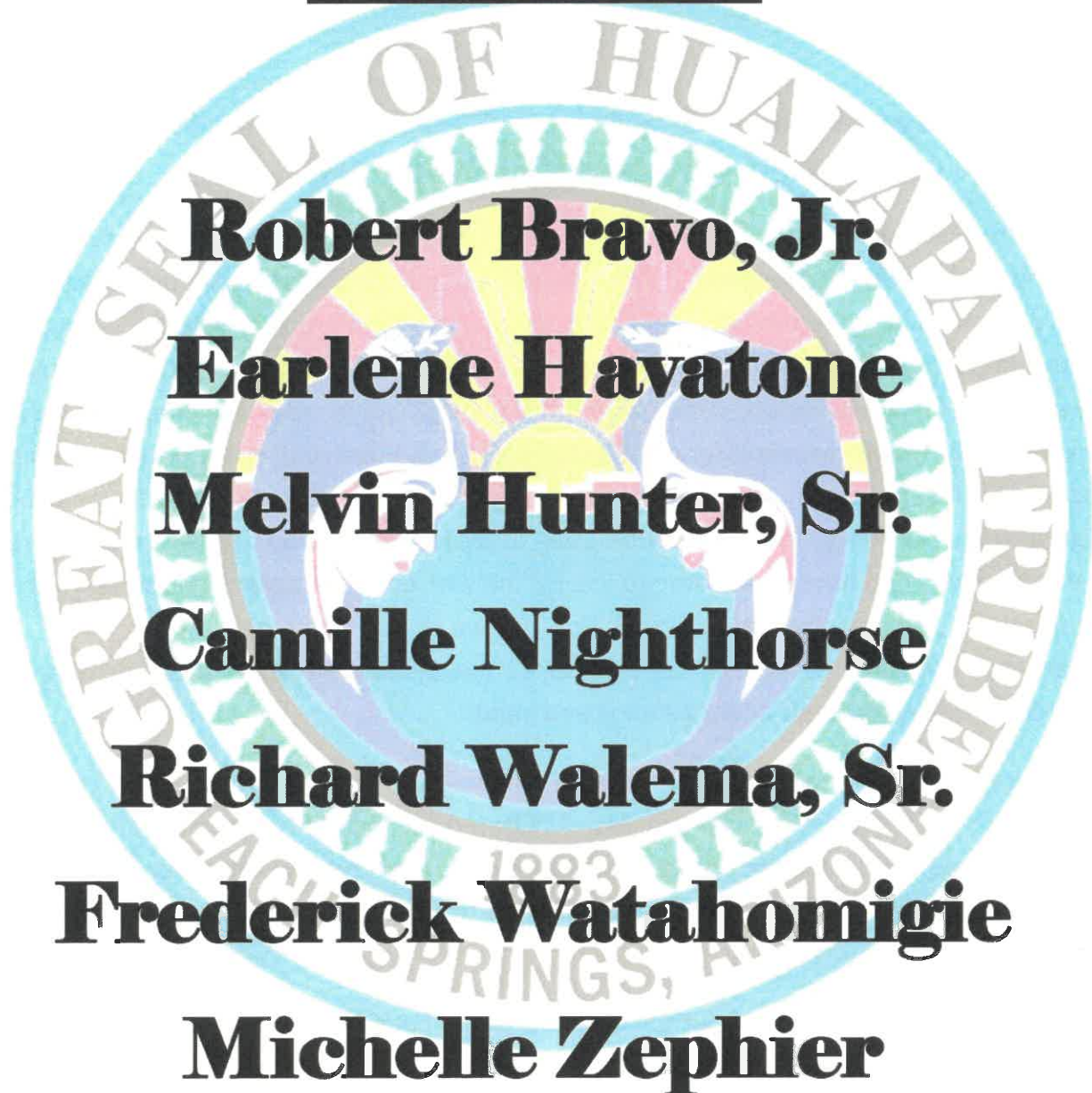
You will all agree that the cell phone and Wi-Fi service need a lot of improvement on the reservation. In today’s highly technical world our people need to have reliable access to modern communication conveniences. Education access for young and old immediately comes to mind. For example, we can have an on-line Hualapai language learning classes. All tribal members should be able to access council meetings – bear in mind about half of our membership live off the reservation. Our tribal website needs to be updated and modernized. Our Constitution needs updating, particularly for Elections. The issue of residency must be clarified once and for all.

There are too many closed council meetings. This is very disrespectful to the tribal people! All tribal members have a right to be heard and be informed. The tribal council must work together for the good of all.

If you want an open, responsible, and accountable tribal government, vote for me. I look forward to hearing from you. Be safe and take care of one another.

Thank you for supporting me on my candidacy to be your next Hualapai Tribal Council Member. It is an honor to be a Council member for our great Hualapai Nation.

Special thanks to the community members for attending last night's Candidate Forum hosted by Sonwai Wakayuta. It was good to listen to our people with concerns and questions regarding our tribal government. Leadership is a role in our community where the people rely on the entire council to look out for the best interest of the people and to protect our tribal assets and the land we live on. Although our Tribal Constitution may have areas that seem unclear, we must still respect it for what it is and must also realize that any ordinance does not supersede what is written. I truly understand the concerns from the people in the audience regarding the residency. If elected, I would like to create a workshop with all the directors and the entire council to have a mediator go line by line with every paragraph and sentence to get a clearer understanding of what is written. How can we change something if we don't understand what is written by our predecessor's? I would also invite any tribal member to attend the session for their understanding and input.

As an elected official of our tribal government it is the people who elect us into office and can also take us out through the recall process. As I stated last night if I am elected and any individual feels that I have not fulfilled my commitment and I have violated our code of ethics then any tribal member can go through the process to remove me. It is clearly written in our constitution.

A community member asked about the thoughts of the Council members becoming full time positions. Personally, I feel that our council seats should be a full time position. Our tribal government has multiple issues and concerns that need daily attention. There should be no reason to have special meetings unless a crisis situation arises. Full time Council positions would alleviate issues that need immediate attention. I support the full time positions but would leave that to the people through referendum vote to make the change if that is what you want.

Another concern is with the tribe's largest revenue producer. Grand Canyon Resort Corporation has had multiple deficiencies for the past two decades. We continue to hire Board members, attorneys and CEO's to make decisions on how we should conduct our own business. GCRC received a 5.5 million dollar loan in the mid 90's to build the Hualapai Lodge, food facility, and tent structure at Guano Point. The bank that provided the loan made a stipulation on the contract of the loan that the tribe put a board in place to create a separation of powers between the tribal government and its enterprise. The loan balance was paid off during my administration while working for GCRC in 2011.

We have a lot of experienced Hualapai Tribal members and should be running our own businesses. The corporation was formed to create jobs for tribal members but the attorneys and previous non native board members have put stipulations and boundaries in place for our own people to be hired.

At last night's forum during my closing statement I talked about whitmore wash and Bar 10 Ranch. As Tribal members are you aware that Papillon Helicopters is no longer doing lifts for Hualapai River Runners. They claim that they have no pilots. I previously worked for Grand Canyon West for many years. A stipulation in the helicopter agreements was always put in place that they would do the lifts. Why are the helicopter companies dictating to us what they can and can't do? Grand Canyon Resort Corporation has implemented a policy at Grand Canyon West that the EC130 helicopters are the only helicopters to fly below the rim based on a quiet technology ruling. Yet on the other hand at whitmore wash (our reservation) Papillon Helicopters are allowed to use a jet ranger. Please google Bar 10 Ranch and Papillon Helicopters and you will see that they are in direct competition with our own business at GCW. Again, I ask, why are we allowing outsiders to make decisions that impact our own business?

As your elected Council member I give you my word it will be my responsibility to work with our Chairman, Vice-Chair and other Council members to look out for the best interest of the Hualapai People, our tribal businesses, the Hualapai tribal assets, and the Hualapai tribe's natural resources. I will support all Council decisions and promise to keep you informed.

In closing, I ask for your support to represent our great Nation and together we can build a better future for "all" Hualapai Tribal Members. United we stand, divided we fall.

Dear Hualapai Tribal Members,

It is with great pride I can say I am Hwal'bay. My name is Robert Bravo Jr. and I am running for a Hualapai Tribal Council seat. My professional background is business and was very successful in my interim position as the CEO of Grand Canyon Resort Corporation from September 2009 thru September 2011. I also served as a Hualapai Tribal Council member in 2013. I have over 25 years of upper business management and leadership experience and since 2020 I have served our people as a Hualapai Tribal Court Advocate and support Hualapai Tribal entrepreneurs.

Family is of most importance to me. I enjoy hunting, camping, golfing and spending quality time with my entire family and friends. My father and mother are Robert Bravo Sr. and Marilyn "Imus Bravo. My father was born and raised in Nelson Arizona where his father Torivio Bravo was raised from the age of 14. My mother Marilyn is full blooded Hwal'Bay. My paternal great grandmother is Queenie Imus who was married to John "Wath-Nack-A-Ma Imus who was an Indian Scout for the U.S. Army. My maternal great grandmother was Alma "Lane" Fielding from the Big Sandy. Alma was married to Tom Lane who was from the Blue Mountain area.

It will be my honor to serve our people as a Hualapai Tribal Council Member. Our Constitution permits "all" tribal members to share in the responsibility of tribal government. The responsibility is not just an elected position, but to become a leader of our great nation to help make decisions that will be in the best interest of our people and the land we live on.

As your Council Member here are some focus points:

- As your Council Member I will devote official time and my own personal time to the problems of basic policy and also work as a liaison between the Tribal Council and our Hualapai people.
- I will promote economic development opportunities to ensure a stable working environment to provide more jobs for "all" Hualapai's and show the world once again that Hualapai's are great entrepreneurs.
- I will serve the Hualapai people first and foremost in everything that I do and not my own personal interests. Putting the Hualapai people first means doing what is in the best interest of the community.
- I will avoid any conflict of interest that would keep me from putting the Hualapai people first.
- I will focus my efforts on day to day operations and also the future development of the tribe. I feel it is a public official's responsibility to be honest with the public, disclose any possible conflict of interest and provide information to the Tribal Membership as needed.
- I will focus on a one specific change in our Hualapai Tribal Constitution to lower the blood quantum to 1/8. This is important for the longevity of our tribe and our people.
- I will execute a plan to utilize and develop the Truckee California property that belongs to the Tribe.
- I will make a commitment to look out for the best interest and quality of life for our Hualapai Tribal Elders.

As Hualapai Tribal members we are truly blessed to live in such a unique area which is encompassed within one million acres of beautiful pristine land. Our reservation borders 108 miles of the Colorado River that is located on one of the World's Natural Seven Wonders, the "Grand Canyon". There are many issues we need to focus on so we can continue to be self sufficient and not allow anyone to take away our great opportunities for economic development. For example, our tribe has been in negotiations with the National Parks on the Colorado River Management Plan. For many years the National Parks has tried to regulate and cap our business to less than what the Hualapai River Runners, Grand Canyon 9 Rapids and the Grand Canyon Pontoon operations are currently doing. This could potentially mean that the amount of passengers the Hualapai Tribe can sell in our tourism operations will be controlled by the National Parks. Many of the companies that travel from Lees Ferry are not paying for their guests who encroach on our tribal lands. I will help adopt a procedure that monitors our land to make sure we are getting paid for each guest that trespasses on our property. As an example, at Whitmore Wash (Hualapai Tribal Land) upper river rafter commercial concessioners and Bar 10 do helicopter exchanges and the river rafters allowed to despoil our land. My commitment will be to execute a plan on how to monitor the area to make sure our tribe is getting the revenue for each transfer and implement fines for the desecration of our land. In other words, I will do my research to see why the Hualapai Natural Resources Conservation 24-70 Ordinance has been violated.

The lithium mining where the Australian mining company Hawkstone has been drilling on three sides of Hualapai land in Arizona's Big Sandy River Valley is also of concern. Our argument is that the BLM has violated their rights in the oversight of the project. My responsibility and commitment will be to form an alliance with County, State and US Government officials to continually seek resolution.

I was fortunate to start working with the Grand Canyon Resort Corporation in 1997. During my tenure I have seen many challenges and have had the opportunity to be part of the newest changes that have occurred. I was also involved with the runway project team and worked closely with FAA representatives to develop the new runway. I participated with the Hualapai Tribal Council, GCRC and the National Parks to discuss the Colorado River Management Plan.

When elected, I will gather information and share it all tribal members have a clear understanding of the issues that affect the Hualapai Tribe. Political terms don't last forever therefore communication is very important. We must all know what is at risk so our younger generations can continue to protect our land and our constitutional rights. My duty to mitigate most situations instead of paying our attorney's for advice. They don't dictate to us how to run our tribal government they work for us and follow our lead and direction.

We have a great community that every tribal member should take pride in. What can we do as tribal members to make it a better place to live? What can we do to turn Peach Springs into a more cohesive community? My goal as an elected official will be to help our community be a better living place for all tribal members and provide more job opportunities.

We have social issues similar to other communities and reservations and we need to focus and devote more of our resources on:

- Better prepared and pro-active for potential crisis situations
- Substance abuse
- Domestic violence
- Political interference
- Separation of powers between the judicial and administrative arms of the Tribe.

As your elected Council member it would be my responsibility to help implement programs to curb these and other issues to help our people. We also must never forget about our culture and traditions. Our parents and grandparents were taught in order to have respect we must show respect everyone. I feel we must regain that pride and have respect for one another within our community if we are to move forward as a united tribe. As your potential elected official I give you my word it will be my responsibility to work with our Chairman, Vice Chairman and the entire Council to look out for the best interest of the Hualapai people, our tribal businesses, the Hualapai tribal assets and the tribes Natural Resources. I will support Council decisions and promise to keep you informed. Currently, I am familiar with the issues the Hualapai tribal council has been dealing with. If elected, I pledge to lead by example and enforce the Hualapai Constitution and all laws within our tribal government. In closing, I would appreciate your vote and support as your newly elected Council member of our "Great" Hualapai Nation.

May 22nd offered a clear and windy afternoon for some 150 community members, consultants and contractors who gathered in front of the Hualapai Veterans’ Memorial at Rodeo Circle to break ground on the first of nearly three dozen construction projects which will be overseen by the Hualapai Public Services Department. Pastor and tribal council member Pete Imus gave the blessing. Chairperson Sherry J. Parker, citing the first project, which will renovate the baseball fields, stressed the importance of providing physical activities for youth that will also help bring the community together again, something that was lost during the COVID-19 pandemic. In addition to the baseball fields, the project suite will include paving the Youth Camp Road, repairing local roads in the community, building a bridge over the BNSF Railroad in downtown

Peach Springs, a new tribal administration office, and a new transportation building for the tribe’s bus service and Public Services Department. These top priority projects, plus the other two dozen on the list, will take some ten years to fully fund and then complete.

Procedures for Service of Process**

Adopted this 31st day of May 2024

AUTHORITY: This General Administrative Order is established pursuant to the authority vested in the Hualapai Judiciary at Article VI, Section 3(d) in the Constitution of the Hualapai Indian Tribe; to “establish court procedures for the Hualapai Judiciary” and Sec. 3.22 of the Hualapai Law and Order Code which provides that “details of judicial procedure not prescribed by this Code shall be set forth in rules of court promulgated by the Tribal Court.”

PURPOSE: The judicial duties of the Hualapai Tribal Court is serving documents to individuals who are in litigation, or individuals who are called to serve as potential jurors or other legal business in the Tribal Court. The General Administrative Order 2002-2007 provides limited process for service of documents to individuals and is no longer viable for service of process. The law for service of process is directed in Chapter 4, Section 4.5 which does not specify how documents should be served to individuals who are called to court for their legal business. The tribal community on the Hualapai Reservation do not have the knowledge on the importance of service of court documents; and consequences for failing to respond to court documents, therefore this General Administrative Order shall give guidance on service of process to court litigants and to other interested parties.

IT IS HEREBY ORDERED that this General Administrative Order supersedes GAO 2002-2007 and establishes the legal process for serving documents to individuals who are summoned to the court for a hearing or other legal businesses. ” Procedures for Service of Process” as set forth in Appendix A attached hereto and incorporated herein by reference, is adopted and shall be effective commencing May 31, 2024, and shall remain in effect until further order of this Court or upon enactment of superseding legislation by the Hualapai Tribal Council or upon order of the Hualapai Court of Appeals vacating this Order.

APPENDIX "A"

PROCEDURE FOR HUALAPAI TRIBAL SERVICE OF PROCESS

INTRODUCTION:

Serving someone (also known as process serving) is a person delivering legal and court documents to individuals involved in a legal dispute. A process server is an “Officer of the Court” acts as a messenger, officially notifying people about their involvement in a court case.

Process serving ensures that individuals involved in legal proceedings are notified about it, allowing them to respond and defend themselves accordingly. It’s a critical component of the justice system and must be carried out accurately and according to the law to maintain the integrity of any legal case.

PROCESS:

The Hualapai Tribal Court must serve legal document to individuals involved in legal proceeding to protect their individual rights to due process of law (to be informed of the nature of a complaint) as prescribed in the Hualapai Tribe’s Constitution, Article VI. Section 13 (c) therefore the Court mandates service of process pursuant to the law as prescribed in the Hualapai Law and Order Code.

Hualapai Tribal Code, Chapter 4, Section 4.5, Service of Process, directs the Trial Court to serve documents to individuals involved in court cases and provides three (3) types of services.

1. **Personal Service:** documents are served upon any individual by any Peace Officer or Court approved process server.
2. **Registered or Certified Mail:** If service cannot be completed upon an individual the Court may serve process on individual by registered or certified mail. Once the certified receipt is returned, it acts as proof of service.
3. **Publication:** if service of process is unsuccessful to an individual, publication of the service is published in the local newspaper.

SERVICE OF PROCESS:

The Hualapai Law Enforcement Officers and the Tribal Court Process Server have the authority to serve an individual by the following procedures:

1. **Personal Service:** Process Server personally hands over the legal papers to the person involved in a court case;
2. An individual being served is informed of the nature of the document/s and refuses to accept the documents, the Process Server shall inform the person that he/she has been served and may leave the documents on the individual’s door or porch and shall note it as such on the Return of Service.

3. Personal service of document/s may be served on an individual at a public event, Process Server must be discreet in serving process in a public place.
4. If the named person on the document is not present for personal service, leave the papers with a responsible adult at the residence. Service must be handed to a person who is the age of 18 or older.
5. A person who is summoned and is not found at his/her residence, he/she may be served with the documents at place of employment and can be served to a person in charge. Return of service must be signed by the person being served with the documents.
6. A person who cannot be found at his/her residence, place of employment or a public event, the documents shall be sent to the individual by certified mail, return certified receipt shall be proof of service.
7. If personal service on an individual fails after several attempts, the Court may publish the notice to the party in the GAMYU Newsletter. Publication of a Notice to the individual serves as a legal service of process.
8. Summons to be served to a potential juror is not subject to publication.

Consequences for Failing to Answer to a Summons, Subpoena, or Legal Notices:

The court's Summons, Subpoena and legal notices are orders of the Court and mandates a person to answer to the orders by appearing in court that notes a date and time; if a person fails to appear as ordered by the Court, the person failing to answer or appear in court may be held in contempt of court. Contempt of Court includes a behavior of an individual who is in actual court hearing.

Contempt of Court is defined in Chapter 8, Section 81 of the Hualapai Law and Order Code are as follows:

- A. Disorder, contemptuous or insolent behavior committed during the sitting of a court of justice in immediate view and presence of the court, and directly tending to disrupt its proceedings or to impair respect due to the authority; or
- B. Behavior or like character committed in the presence of a referee while actually engaged in trial or hearing, pursuant to the order of the court, or in the presence of a jury while actually sitting during a trial of a case or upon inquest or other proceeding authorized by law; or
- C. Any breach of the peace, noise or other disturbance directly tending to interrupt the proceeding of a court; or
- D. Willful disobedience of process or an order lawfully issued by a court; or
- E. Resistance willfully offered to the lawful order or process of a court; or
- F. The unlawful refusal to be sworn as a witness or, when so sworn, refusal to answer a material question; or
- G. The publication of a false or grossly inaccurate report of a proceeding of a court

Any violations of the law for contempt of court is found guilty and is sentenced to a fine or detention time as provided in Section 8.2 of the code.

Sec, 8.2 Contempt in Presence of Court; Summary Punishment

“When a contempt is committed in the immediate view and presence of the Court, it may be punished summarily and immediately by a fine not to exceed \$500, or imprisonment in a detention facility for a term not more than 30 days, or both.”

The law mentioned for contempt of court is finding a person failing to answer to a Criminal/Civil Summons and Subpoena.

The establishment of procedures for process serving is necessary due to individuals who refuse acceptance or question the validity of the documents being served.

The Court in providing the procedure and consequences for failing to comply with the orders of court, the procedures educates the Hualapai Tribal Community on the importance of service of process.
