The Yavapai-Prescott Indian Tribe (YPIT) is pleased to invite you to the Annual Pai Pride Co-ed Youth Basketball Tournament, to be held on April 22, 2023, at Prescott Mile High, Grace Sparkes Activity Center, Granite Mountain, and Yavapai College campuses. On the evening of April 22, YPIT will host a Pizza Party for players and coaches at the Community Gathering Center on the Reservation in open house style from 6pm-7:30pm. Dinner tickets for up to 10 players and 2 coaches will be dispersed on game day according to team rosters.

This is an open tournament to all communities. The planned format will include:

- Tournament Entry Fee: \$50.00 per team. Registration is guaranteed when entry fee is paid. Limit of 6 teams per age category. Make checks payable to YPIT, 530 E. Merritt, Prescott, Arizona, 86301. Payment deadline is April 14, 2023. If no response by April 14, 2023 Bracket will be cut.
- Liability waiver to be executed by each parent or guardian for each player.
- Four (4) Age Brackets: 8-10 year olds, 11-12 year olds, 13-14 year olds, and 15-17 year olds. Birth certificates will be verified prior to each team's first game.
- Double elimination competition, except for final championship game, in each age bracket. One final championship game.
- Co-ed Tournament: 5 players per team on court, when possible; a minimum of two players per team are designated female. If there is only 1 female player available, the team will play with only 4 players. There must be both male and female representation on the court at all times.
- Throughout tournament play, beverages and snacks may be available for purchase at the school gyms. Cash only. We ask that all trash and drinks be cleaned up.
- Award Presentations: Awards will be presented to 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> place winners, and MVP boys and girls. Awards will be given to each of the winning teams.
- Hotel reservations with the Prescott Resort may be made for \$79/per night for a quad, based upon availability. The resort is close to movies, shopping and restaurants. Reservations must be made by April 7, 2023. Please call the Prescott Resort at 855-957-4637 and ask for the Pai Pride Tournament rate.

**Basic Rules**

1. All games will consist of 8 minute running quarters, with stop and go clock for last 2 minutes of game if score is within 20 points.
2. Three (1 minute) time-outs per game.
3. Team Managers will submit their lineup to the score keepers 15 minutes prior to their scheduled game time.
4. After a 10 minute grace period, absent teams will forfeit game.
5. All players must have a visible number on the back of their shirts.
6. 5 players per team on court, when possible; a minimum of two players per team are designated female. If there is only 1 female player available, the team will play with only 4 players. There must be both male and female representation on the court at all times.
7. Substitutes must report to the scorekeeper and wait to be summoned by officials.
8. No basketball shooting, dribbling, or ball handling allowed while games are in progress.
9. Protests will be handled by the on-site Gym Supervisor, YPIT Staff and/or referee. All protests must be made BEFORE the start of the game to the official and noted on the score sheet. Protest regarding referees and scorekeepers WILL NOT be allowed. Officials' decisions will be final. Any questions pertaining to the eligibility of a player or team shall be directed to the Gym Supervisor before the start of the game. If a protest is instituted once a game has started, it will not be recognized. The Tribe is not responsible for lost jewelry players are wearing during play.
10. Players cannot wear hats or any jewelry while on the play floor unless jewelry is taped to the player's body. Shirts must be tucked in.
11. Players penalized with technical fouls will sit out for 2 minutes.
12. Age brackets will be 8-10 year olds, 11-12 year olds, 13-14 year olds, and 15-17 year olds.
13. Ten player limit on roster. Team rosters will be verified with birth certificates or other acceptable ID one hour before the beginning of each team's first game. Original or copy of original birth certificate are acceptable. Any exceptions to be approved by YPIT staff. Other acceptable ID will be an original Tribal ID or State ID with printed birth date. Birthday restrictions for eligibility requirements are: players as of **December 31, 2022** to be 10 years old or younger; 12 years old or younger; 14 years old or younger; and 17 years old or younger. Birthdays after January 1 will not disqualify a player from age eligibility.
14. All players must be on original roster submitted the morning of the tournament.
15. All players are to be on one team only. Any younger player than posted age bracket is allowed to move up, but rosters for all teams are set at the beginning of each team's first game of tournament.
16. Any personal belongings left behind will **not** be collected by tournament officials and will **not** be the responsibility of YPIT.
17. Coaches and players to abide by Rules of Conduct, Penalties and Discipline attached.
18. Double elimination competition, except for final championship game, in each age bracket. One game championship.
19. Coaches are responsible for making sure bench area is clean after each game.



# PAI Pride Basketball Tournament

## April 22, 2023

### **RULES OF CONDUCT** (for all participants-coaches, players, parents and fans)

No smoking, chewing tobacco, alcohol, nonprescription drugs are allowed at any time, and anyone believed to be under the influence, even to the slightest degree at practices or games, will be asked to leave the facility and/or grounds immediately.

Do NOT criticize players in front of spectators. Positive reinforcement and constructive criticism at appropriate times is encouraged.

Do NOT yell at referees and DO NOT allow your players, parents, or fans to do so.

Do NOT criticize an opposing team, its players, coaches, or fans by word of mouth or by gestures.

No abusive or profane language is allowed by coaches or players. Ejection from games and/or suspension from future games may be the penalty.

### **PENALTIES, DISCIPLINE** (for all participants-coaches, players, parents and fans):

The YPIT Tournament staff is responsible for enforcing rules and regulations of the tournament.

Violation of rules and regulations will be decided by majority vote of the YPIT Tournament Staff.

The YPIT Tournament staff can reprimand, suspend for any length of time, or replace any player, coach, fan or official, for violation of tournament rules.

Disciplinary action may include, but is not limited to the following:

- Verbal warning by an official or site supervisor.

- Written warning by an official or site supervisor.

- Game suspension with written documentation of incident kept on file.

- Game forfeiture through an official or site supervisor.

- Permanent suspension from future tournaments.

**Note:** Coaches are responsible for notifying parents and players of all tournament rules.

## RECREATIONAL ACTIVITIES LIABILITY WAIVER

In consideration for being allowed to participate in any way in the Yavapai-Prescott Indian Tribe's Pai Pride Co-ed Youth Basketball Tournament, and related events and activities, including transportation to and from the gyms and YPIT Gathering Center in Prescott, Arizona, to take place April 22, 2023 the undersigned:

1. Agrees that prior to participating, he or she will each supply him or herself with adequate water and/or other supplies, including appropriate attire and necessary equipment.
2. Understands that this is a drug and alcohol free event, and possession or use of any of these substances will result in immediate expulsion from the event.
3. Acknowledges and fully understands that the Pai Pride Co-ed Youth Basketball Tournament may be physically demanding and that each participant will be engaging in potentially hazardous activities that involve risk of accident, injury or illness, as well as risk of other social and economic losses that might result from their own actions, inactions, negligence or gross negligence, or from the Tribe's. Further, that there may be other risks not known to the Tribe, or not reasonably foreseeable to it, such as disability or death.
4. Assumes responsibility for obtaining and paying for all medical care necessary in case of accident, injury, illness or other circumstances that require medical attention.
5. Assumes all the foregoing risks and accepts personal responsibility for the damages following such injury, permanent disability or death.
6. Releases, waives and discharges the Yavapai-Prescott Indian Tribe, the Tribe's Community Services Department, or their agents or employees, from demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the actions, inactions, negligence or gross negligence of the Yavapai- Prescott Indian Tribe, the Tribe's Community Services Department, or the undersigned, and covenants not to sue any of these parties in Tribal Court, State Court or Federal Court.
7. Nothing in this waiver shall be construed as a limitation of the sovereignty rights of the Yavapai-Prescott Indian Tribe, including sovereign immunity.
8. **THE UNDERSIGNED HAS READ THE ABOVE WAIVER AND RELEASE, UNDERSTANDS THAT HE OR SHE HAS GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGNS IT VOLUNTARILY.**
