Dear Chairwoman Parker,

I recently visited the Cholla Canyon Ranch, thanks to the generosity of my friend Michael Whatoname who got permission to take me to the Cofer Hot Springs in Wikieup. This land was once owned by my late husband's Great-Grandparents, Clyde and Irene Cofer but yesterday was my first visit. Prior to this visit, my only knowledge was the many amazing stories and family photographs.

I must say, seeing this beautiful oasis in the desert was breathtaking and I can't help but imagine how this may someday be developed as a tourist destination, respecting the unique spiritual value of the Hualapai customs and history.

The Mohave County Board of Supervisors and Directors from several departments were invited to go on a tour of the proposed Arizona Lithium Company mine. According to the Navajo Transitional Energy Company, if approved the mine could bring critical infrastructure along with direct and indirect economic development to the area.

It is my understanding since 2017, 50 exploratory boreholes have been drilled which produced results and high-grade lithium value. The project is currently waiting for approval for phase 3, drilling additional exploratory boreholes prior to going through the regulatory process for final approval for a full-scale shallow pit Lithium mine.

I have been told the Hualapai Tribe is opposed to further drilling because there has been a noticeable reduction of water to the Cofer Hot Springs. I suspect that the Bagdad Mine pulling water from the same aquifer may also influence the water availability but regardless, I believe more information must be available before any additional permits are issued by the BLM.

I believe the Cofer Hot Springs should be protected at all costs due to the historical and spiritual value to Mohave County and to the Hualapai people. I also believe if the area could be opened for a yearly celebration, inviting all Mohave County residents, (much like you do at Grand Canyon West) you might find more support to protect this natural wonder.

This project, if approved, is many years away from becoming a reality. The regulatory pathway will require more permits, environmental and cultural baseline studies and a full-blown Environmental Impact Statement to move forward.

My position is to respect the land's natural and cultural heritage while engaging in constructive conversations with BLM, Arizona Lithium Company, Mohave County, and Navajo and Hualapai council leaders.

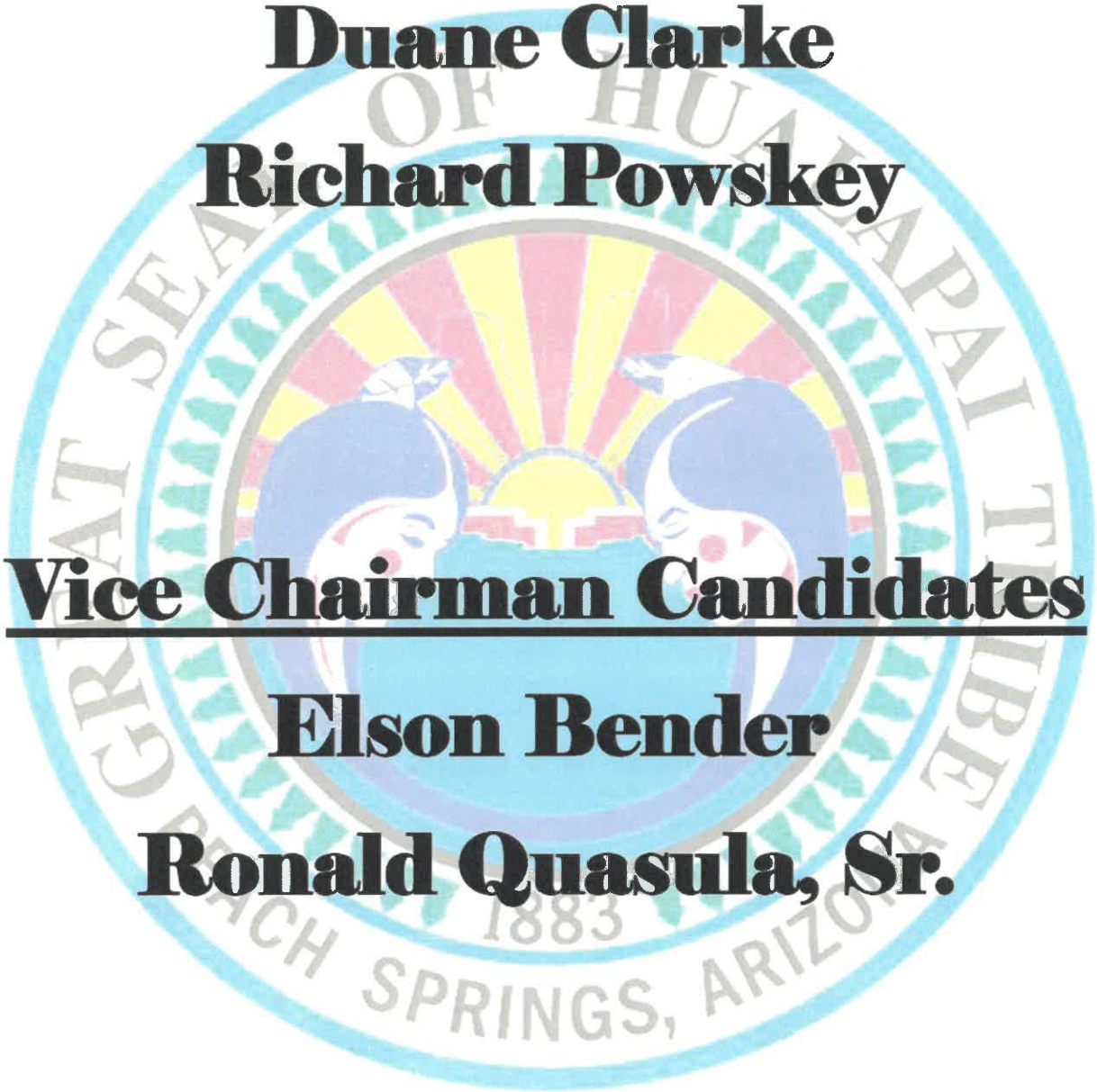

Dear Hualapai Tribal Members,

It is with great pride I can say I am Hwal'bay. My name is Robert Bravo Jr. and I am running for a Hualapai Tribal Council seat. My professional background is business and was very successful in my interim position as the CEO of Grand Canyon Resort Corporation from September 2009 thru September 2011. I also served as a Hualapai Tribal Council member in 2013. I have over 25 years of upper business management and leadership experience and since 2020 I have served our people as a Hualapai Tribal Court Advocate and support Hualapai Tribal entrepreneurs.

Family is of most importance to me. I enjoy hunting, camping, golfing and spending quality time with my entire family and friends. My father and mother are Robert Bravo Sr. and Marilyn "Imus Bravo. My father was born and raised in Nelson Arizona where his father Torivio Bravo was raised from the age of 14. My mother Marilyn is full blooded Hwal'Bay. My paternal great grandmother is Queenie Imus who was married to John "Wath-Nack-A-Ma Imus who was an Indian Scout for the U.S. Army. My maternal great grandmother was Alma "Lane" Fielding from the Big Sandy. Alma was married to Tom Lane who was from the Blue Mountain area.

It will be my honor to serve our people as a Hualapai Tribal Council Member. Our Constitution permits "all" tribal members to share in the responsibility of tribal government. The responsibility is not just an elected position, but to become a leader of our great nation to help make decisions that will be in the best interest of our people and the land we live on.

As your Council Member here are some focus points:

- As your Council Member I will devote official time and my own personal time to the problems of basic policy and also work as a liaison between the Tribal Council and our Hualapai people.
- I will promote economic development opportunities to ensure a stable working environment to provide more jobs for "all" Hualapai's and show the world once again that Hualapai's are great entrepreneurs.
- I will serve the Hualapai people first and foremost in everything that I do and not my own personal interests. Putting the Hualapai people first means doing what is in the best interest of the community.
- I will avoid any conflict of interest that would keep me from putting the Hualapai people first.
- I will focus my efforts on day to day operations and also the future development of the tribe. I feel it is a public official's responsibility to be honest with the public, disclose any possible conflict of interest and provide information to the Tribal Membership as needed.
- I will focus on a one specific change in our Hualapai Tribal Constitution to lower the blood quantum to 1/8. This is important for the longevity of our tribe and our people.
- I will execute a plan to utilize and develop the Truckee California property that belongs to the Tribe.
- I will make a commitment to look out for the best interest and quality of life for our Hualapai Tribal Elders.

As Hualapai Tribal members we are truly blessed to live in such a unique area which is encompassed within one million acres of beautiful pristine land. Our reservation borders 108 miles of the Colorado River that is located on one of the World's Natural Seven Wonders, the "Grand Canyon". There are many issues we need to focus on so we can continue to be self sufficient and not allow anyone to take away our great opportunities for economic development. For example, our tribe has been in negotiations with the National Parks on the Colorado River Management Plan. For many years the National Parks has tried to regulate and cap our business to less than what the Hualapai River Runners, Grand Canyon 9 Rapids and the Grand Canyon Pontoon operations are currently doing. This could potentially mean that the amount of passengers the Hualapai Tribe can sell in our tourism operations will be controlled by the National Parks. Many of the companies that travel from Lees Ferry are not paying for their guests who encroach on our tribal lands. I will help adopt a procedure that monitors our land to make sure we are getting paid for each guest that trespasses on our property. As an example, at Whitmore Wash (Hualapai Tribal Land) upper river rafter commercial concessioners and Bar 10 do helicopter exchanges and the river rafters allowed to despoil our land. My commitment will be to execute a plan on how to monitor the area to make sure our tribe is getting the revenue for each transfer and implement fines for the desecration of our land. In other words, I will do my research to see why the Hualapai Natural Resources Conservation 24-70 Ordinance has been violated.

The lithium mining where the Australian mining company Hawkstone has been drilling on three sides of Hualapai land in Arizona's Big Sandy River Valley is also of concern. Our argument is that the BLM has violated their rights in the oversight of the project. My responsibility and commitment will be to form an alliance with County, State and US Government officials to continually seek resolution.

I was fortunate to start working with the Grand Canyon Resort Corporation in 1997. During my tenure I have seen many challenges and have had the opportunity to be part of the newest changes that have occurred. I was also involved with the runway project team and worked closely with FAA representatives to develop the new runway. I participated with the Hualapai Tribal Council, GCRC and the National Parks to discuss the Colorado River Management Plan.

When elected, I will gather information and share it all tribal members have a clear understanding of the issues that affect the Hualapai Tribe. Political terms don't last forever therefore communication is very important. We must all know what is at risk so our younger generations can continue to protect our land and our constitutional rights. My duty to mitigate most situations instead of paying our attorney's for advice. They don't dictate to us how to run our tribal government they work for us and follow our lead and direction.

We have a great community that every tribal member should take pride in. What can we do as tribal members to make it a better place to live? What can we do to turn Peach Springs into a more cohesive community? My goal as an elected official will be to help our community be a better living place for all tribal members and provide more job opportunities.

We have social issues similar to other communities and reservations and we need to focus and devote more of our resources on:


- Better prepared and pro-active for potential crisis situations
- Substance abuse
- Domestic violence
- Political interference
- Separation of powers between the judicial and administrative arms of the Tribe.

As your elected Council member it would be my responsibility to help implement programs to curb these and other issues to help our people. We also must never forget about our culture and traditions. Our parents and grandparents were taught in order to have respect we must show respect everyone. I feel we must regain that pride and have respect for one another within our community if we are to move forward as a united tribe. As your potential elected official I give you my word it will be my responsibility to work with our Chairman, Vice Chairman and the entire Council to look out for the best interest of the Hualapai people, our tribal businesses, the Hualapai tribal assets and the tribes Natural Resources. I will support Council decisions and promise to keep you informed. Currently, I am familiar with the issues the Hualapai tribal council has been dealing with. If elected, I pledge to lead by example and enforce the Hualapai Constitution and all laws within our tribal government. In closing, I would appreciate your vote and support as your newly elected Council member of our "Great" Hualapai Nation.

I have over 26 years in the field of management. Asst. Center Manager, Fire Management and Asst. Fire Management Officer under the Bureau of Indian Affairs. As a council member, I will attend council meetings and share my perspective. More importantly, I will take the time to understand matters and vote confidently as a member of the Hualapai Tribal Council.

I believe that with your vote, we can make a difference for the Hualapai Tribe. I will be a voice that will benefit Hualapai-our children and youth, adults and our elders.

HUALAPAI MASTER PLAN MEETING #12

Meeting Notes

Meeting Date: April 30, 2024, 5:00 PM

1. DINNER at 5:00 PM

2. CALL TO ORDER: Chairman Robert Bravo called the meeting to order at 6:03 PM

3. ROLL CALL:

Present:

Andrea Nieto, Camille Nighthorse, Clay Bravo, Raelene Havatone (Zoom), Manny Siyuja, Marilyn Vaughn (Zoom), Martina Dawley, Shana Talieje and Robert Bravo.

Absent:

Cheryle Beecher (excused), Gensean Havatone-Putesoy, Joyce Powskey (excused), Longfeather Fox (excused), Loretta Jackson-Kelly (excused), Nick Hunter (excused).

Also in attendance were Josh Gordon, Olin Beecher, Director of Game and Fish, Annette Bravo, Kevin Davidson, Director of the Hualapai Planning & Economic Development Department and Nona Baheshone, Bahozhoni Development.

Chairman Robert Bravo requested a motion to approve the meeting agenda. Andrea Nieto made a motion to approve the agenda and Clay Bravo seconded. Committee approved the agenda unanimously.

4. AGENDA AND MINUTES APPROVAL:

Chairman Bravo requested a motion to approve the April 2, 2024, meeting minutes. Ms. Nieto made a motion to approve the agenda and Camille Nighthorse seconded. Committee approved the meeting minutes unanimously.

5. REVIEW OF COMMENTS FROM HUALAPAI SOIL & WATER CONSERVATION DISTRICT

Mr. Davidson began the presentation by saying this is the Committee's twelfth meeting where the Committee will finalize the draft Master Plan for presentation at the third public meeting coming up in two weeks. In the past two weeks, Planning presented the draft Master Plan to three tribal commissions beginning with the Hualapai Soil & Water Conservation District on April 18, 2024. Comments and questions are as follows:

- 1) New home sites reduce the Animal Unit Months (AUMs) available to the cattle ranchers. The grazing fees that the Districts pay to the tribe should be reduced as more land is given over to housing development in the districts.
- 2) Will development in the new 190-acre housing area south of old US Route 66 be similar to the scattered home sites found along Buck and Doe Road?
- 3) The original northerly boundary of the Shipping Pasture was US Route 66. This boundary shifted northward around 1960 when State Route 66, the current roadway, was constructed isolating the land in the middle which became District No. 2's Shipping Pasture and their responsibility to maintain. The 190-acre residential area is proposed in the shared Shipping Pasture that is bounded on the north by old US Route 66.
- 4) Cultural sites should be protected from new development.
- 5) What protocol does the tribe follow if a tribal member finds artifacts on their home site lease? Should a buffer zone be established around the artifacts?
- 6) The tribe should look at developing homes in the Truxton Triangle.

- 7) Many tribal members do not qualify for LIHTC homes because their household incomes are too high.
- 8) The Master Plan's land use diagrams are similar to zoning in that only certain types of development can occur in the various land use designations.

To address the first concern, Mr. Clay Bravo requested the Master Plan include a discussion on AUMs or Animal Units per Month. These fees are 80% of the rate set by the Department of Interior which equals \$1.08 per AUM or \$12.96 per year.¹ Ms. Nieto asked about the costs to the rancher of reducing their AUMs and Mr. Bravo said each AUM is worth about \$3,000 per year when cattle are sold, sometimes more at an auction. Josh Gordon asked about the cost of processing beef off-reservation as compared to on the reservation. Mr. Bravo said meat processing facilities have to butcher a large number cattle per day to be profitable, making an on-reservation operation economically unfeasible. To follow-up, Mr. Gordon asked if grass fed beef could help subsidize an on-reservation meat processing plant given that grass fed beef fetches a higher price per pound. Shana Talieje said butchering is becoming a lost art and would like to see tribal members be trained in this trade. Mr. Bravo said a meat processing plant needs about a dozen people to handle the various steps and constant USDA inspections.

For Item Nos. 4 and 5, concerning cultural clearances performed on land to be developed, Martina Dawley explained the Class III cultural site investigation and said it is not the lease holder's fault if the tribe missed identifying artifacts on land where a home site lease was afterward approved by the tribe. The onus should be on the Cultural Department to resolve the issue at no cost to the lease holder. The remedy could be paying for a new survey plat that either modifies the parcel boundary to remove the artifacts from the lease area or relocating the home site lease elsewhere. Ms. Nieto advised the Planning and Cultural Departments meet to develop a protocol. Mr. Bravo also commented that his discussion of Grand Canyon West's 9,000-acre boundary and the status of Grand Canyon Resort Corporation's lease for this area was not included in the comments. Mr. Davidson apologized for the omission.

6. REVIEW OF COMMENTS FROM INTERDISCIPLINARY TEAM (IDT)

On April 24, 2024, Planning presented the draft Master Plan to the Interdisciplinary Team (IDT) who had these comments and questions:

- 1) Not in favor of allowing additional home sites on the east side of the reservation due to a lack of infrastructure.
- 2) There is a need for a third EMS/fire station to help with emergency response times to the east side.
- 3) Havasupai Tribe will soon be building a fiber optic line along Route 18 which can help with communications and speed up 911 responses.
- 4) The tribe should focus its housing development activities in the Truxton Triangle.
- 5) One AUM (Animal Unit per Month) is lost for every mile of fence line constructed (1 mile of fence will enclose 40 acres).
- 6) Homes in the Box Canyon LIHTC project are too close together so new development should be on larger lots.
- 7) Will opening up some 190 acres of the Shipping Pasture for housing development along the southerly side of the old US Route 66 alignment from 1926 be in conflict with the decades-old tribal council resolution that prohibits new home sites along the highway? This is so motorists will not see tribal homes from the highway.

Mr. Clay Bravo asked about TERC's response to Item No. 1 to which Mr. Davidson quoted, "it seems a bit drastic." For Item No. 5, Mr. Bravo said 40 acres will likely not be able to support an AUM for more than a month, ideally the tribe, i.e. Natural Resources, can do a test by fencing-in 40 acres which is a mile of fence line, for cow and calf to graze. Mr. Davidson added that IDT is okay with locating a third fire station just north of SR 66 along Indian Route 18.

Ms. Nieto agreed with Item No. 6 – Box Canyon homes being too close together - and said if the homes did not have garages they would not crowd the lots. Camille Nighthorse advised a buffer be placed between the lots. Mr. Davidson noted the Box Canyon subdivision was designed some 15 years ago and is reflective of a typical urban subdivision one would find in Kingman

with the goal of reducing development costs, namely laying water, sewer, and electric lines and paving roadways with curbs. Ms. Talieje said the Housing Board, of which she is a member, was locked into this design that has resulted in at least one instance where vehicles have to cross the neighboring property line to access their own garage. Providing landscaping, retaining walls, paved roads and drainage improvements to avoid issues that plague Phase I (2012) is also a request by the Housing Board. On the home interior, the concern is having the space adapted to meet the needs of clients who have disabilities. This includes lowering the height of countertops, sufficient room to maneuver a wheel chair, etc.²

To conclude, and to answer concerns of those who are not eligible for the new the LIHTC homes because they are over-income, Ms. Talieje said many families who are in Housing's rental program will transition to these new homes in Box Canyon freeing up their current housing units in Peach Springs which in turn will be made available to over-income families. Ms. Nieto noted the irony of the tax credit program's policy which provides new homes to persons who have been somewhat less than kind to their rental properties while making the newly vacated rental properties available to over-income people. Ms. Talieje said that is the general impression but it is not the case for most renters in Housing's program. As a side note, monthly rent is based on income and family size. Mr. Clay Bravo advised new homes be of quality construction and placed on larger lots. Ms. Talieje advised the Committee to make its concerns on the LIHTC homes known to tribal council. Mr. Davidson turned to IDT's last issue about placing tribal homes within sight of SR 66. The Committee agreed that the Box Canyon subdivision has basically invalidated the decades-old tribal council resolution and advised trees be planted along the highway to block the view of the new homes in Box Canyon.

7. REVIEW OF COMMENTS AND QUESTIONS FROM TRIBAL ENVIRONMENTAL REVIEW COMMISSION (TERC)

Comments and questions from the Tribal Environmental Review Commission made to Planning at their April 26, 2024, are as follows:

- 1) Does the Master Plan address infrastructure such as providing better sewer treatment facilities, water delivery and solar arrays on roof tops?
- 2) What is the status of the proposed water line to connect the last fire hydrant on Buck and Doe Road (near mile post 2.7) to West Water?
- 3) Does the tribe have sufficient electric energy (MEC) to pump water from the Colorado River to deliver water to Peach Springs and GCW?
- 4) Is there a goal in the Master Plan for the tribe to assume control of the electrical distribution system on the reservation?
- 5) Placing a moratorium on new home sites on the east is a bit drastic. Tribal members understand the risks when they choose to live in the countryside. Such a policy could be seen as placing cattle over people.
- 6) More home site development on the east side will place additional stress on wildlife.
- 7) Reference the tribe's Water Resources, Wetlands Protection, Groundwater Protection Overlay and Air Quality Ordinances in the Environmental Element, akin to the Natural Resources Conservation Ordinance (24-70).

Mr. Davidson answered "yes" to the first question and referenced several goals and objectives in the Master Plan's Infrastructure Element. Mr. Davidson next gave an update on the Environmental Assessment being written for the 16-mile pipe line to West Water and said he and the HTUA have talked to MEC about the power needs to pump water up from the Colorado River to Peach Springs where MEC assured the tribe they have sufficient power to do so. To respond to the fourth point, Mr. Davidson said the HTUA's Ordinance provides language for the HTUA to assume control of MEC's assets on the reservation if it receives tribal council approval to do so. To return to IDT's first concern about allowing more home sites on the east side, TERC is looking at it from the perspective of the tribal member who understands the risks of living in a rural environment. Policy 2.8 in the Land Use Element, as noted on page 4 of the April 2, 2024, meeting minutes, provides guidance to Planning staff when reviewing home site lease applications in rural parts of the reservation. Mr. Davidson said he will add the various ordinances listed in Item No. 7 to the Natural Resources Element.

7. DRAFT BROADBAND GOAL, OBJECTIVE AND POLICY

To conclude the goal and policy discussion, Mr. Davidson reviewed the draft broadband goal, objective and policy that was e-mailed out to the Committee members on April 4, 2024, for comment –

Goal 5: Provide equal and affordable internet access to tribal members living on or adjacent to the Hualapai Reservation and its trust lands.

Objectives:

5.1 - Determine the feasibility of expanding the telecommunications mission of the Hualapai Tribal Utility Authority (HTUA) to be an internet service provider (ISP) to tribal members living on or adjacent to the Hualapai reservation and its trust lands and to surrounding communities outside of the boundaries of the Hualapai Reservation.

5.2 - Establish relationships with existing internet service providers to provide backhaul for the HTUA to utilize as the tribe's ISP.

5.3 - Develop a capital improvement plan to deploy the first, middle and last-mile fiber optic or fixed base wireless network on the Hualapai Reservation and trust lands.

5.4 - Renew the tribe's current 2.5 GHz license granted by the FCC (FRN 0029663200) by 2030.

Policies:

5.1 - Seek tribal, state, federal and private grant funding sources to develop, operate and maintain the tribal broadband network.

5.2 - Prioritize development and expansion of the HTUA's broadband network instead of relying upon a third-party to be the tribe's ISP.

Mr. Clay Bravo was skeptical of Policy 5.1 regarding tribal support of telecommunication efforts launched by tribal members based on his own experience with Hualapai Towers and his partnership with Wecom over a decade ago. Even though he was looking at obtaining \$3.5 million grant to launch the venture, tribal council did not approve the land lease.

Ms. Talieje asked if the HTUA Ordinance should be modified to separate out telecommunications from water, sewer and electrical service given how different it is from the others. Mr. Bravo said that when he was on tribal council he requested the tribe establish a communications office to do this type of work – a home grown effort vs. relying on third-parties. In general, the tribe should educate and train its members to be successful. Such training should also include cultural awareness. Not having reached a consensus on the Goal 5, Mr. Davidson advised the Committee keep it in the draft and wait to hear what the community thinks about it on May 14th.

8. PREPARATION FOR COMMUNITY MEETING

Speaking of the community presentation on May 14th, Mr. Clay Bravo advised that we emphasize the long-term nature of the Master Plan because some tribal members are worried that tribe will try to achieve every goal, implement every policy and reach full build-out in just a few years. Chairman Bravo advised we not put a time limit on tribal members making comment on the Master Plan. Mr. Davidson recommended a written protocol be developed for the speakers and to make them aware their time at the microphone is not time to make a campaign speech for those running for tribal council (election on June 1st). Chairman Bravo also advised we have raffle to help boost attendance.

The Committee agreed to meet again on May 15, 2024, after the community meeting. Chairman Bravo requested a motion to adjourn the meeting. Ms. Dawley made a motion adjourn with a second by Mr. Siyuja, motion carried unanimously at 8:00 PM.

Hualapai Master Plan Update Committee Meeting • Update

Hualapai Master Plan Update Committee holds Third Community Meeting on May 14, 2024



Approximately two dozen community members were greeted by Mr. Kevin Davidson, Hualapai Planning Director, and Ms. Nona Baheshone to give public testimony on the draft Hualapai Master Plan at the Elementary School Gym last Wednesday evening. Ms. Baheshone was hired by the tribe in 2023 to facilitate the public meetings to update the tribe's Master Plan. The 18-member Hualapai Master Plan Update Committee was formed by Hualapai Tribal Council on March 6, 2023.

The Master Plan is a statement of community values and aspirations, written as goals and policies, and shown on maps and diagrams. This will be the primary tool for managing community change to achieve the desired quality of life for tribal members living on the reservation, trust lands and private property owned by the tribe.

A summary of the public testimony is as follows:

1. Developing the east side of the reservation for tourist activities such as glamping must be done in a way that does not trample on cultural sites. Mitigation measures are required such as directing people to the appropriate areas and employing more Hualapai Rangers to patrol these activities.
2. We need to preserve the tribe's cultural history and identity, two things that should not be sacrificed in the name of economic growth.
3. Our water supplies should be protected from lithium mining (reference to the exploratory mining work be done by prospectors around the Cholla Canyon Ranch).
4. Can the tribe set up a drive-in movie theatre in Peach Springs?
5. Regarding a tram at GCW, the tribe is charged with protecting the Canyon and its numerous cultural sites that may be disturbed by such an ambitious construction project (see p. 6.49 for goal and policies).
6. Need to build infrastructure so the tribe and GCRC are not caught unprepared as tourists' flood the reservation as was the case when the Skywalk opened in 2007.
7. Some tribal members saw the construction of the Skywalk as a desecration of Grand Canyon West's landscape.
8. Advise the tribe establish check points on various local roads, like those set up during the COVID-19 pandemic, to both protect and calm the community.
9. The tribe should be promoting the Hualapai language.
10. New housing should not be placed so close together as is the case in the Box Canyon Subdivision which makes it difficult for some residents to drive into their garages.
11. GCW should not look like the South Rim which is cluttered.
12. Tribal leadership must set the example for the community. Our goal is to teach our youth to be good citizens which is a decade-long process.
13. The tribe needs to provide good homes for its members, the kind you find in a gated community.
14. I do not feel safe in Peach Springs anymore.
15. Council should be setting aside \$2 million per year for new housing development as they promised in a resolution a few years ago.
16. The Grand Canyon Resort Corporation was created over 30 years ago to employ and train Hualapai Tribal members to run their own commercial enterprises. Today, only about a third of those employed by GCRC are Hualapai Tribal members.

USDA Announces \$22 Million to Support Underserved and Veteran Farmers and Ranchers Through the 2501 Program

WASHINGTON, May 7, 2024 – The U.S. Department of Agriculture (USDA) today announced approximately \$22.3 million available to community-based and nonprofit organizations, institutions of higher education, and Tribal entities that help underserved and veteran farmers and ranchers own and operate successful farms. Funding is made through USDA’s 2501 Program. This program is administered by USDA’s Office of Partnerships and Public Engagement (OPPE).

“2501 Program partners are based in local communities and rural areas where they serve a critical role in maximizing USDA’s outreach efforts to underserved communities,” said OPPE Director Lisa Ramírez. “They provide training and technical assistance to help these agricultural producers succeed and also connect them to USDA programs and services.”

For more than 30 years, and in partnership with organizations nationwide, the 2501 Program has helped reach underserved farmers and ranchers. The 2014 Farm Bill expanded the program to include assistance to veteran farmers and ranchers. The 2018 Farm Bill increased mandatory funding for the program through fiscal year 2024. With 2501 funding, organizations conduct education, training, farming demonstrations, and conferences on farming and agribusiness.

Since 2010, the 2501 Program has continued to increase access to USDA’s programs and services and awarded 615 grants totaling more than \$194 million. For example, FY 2023 grantee Farm to Table Guam is helping farmers in Guam with business training, financial planning, and technical assistance in crop production and distribution. Quivira Coalition is reaching rural producers in New Mexico with radio spots in English, Spanish, and Diné Bizaad (Navajo) about arid land stewardship practices and conservation.

Eligible applicants include not-for-profit organizations, community-based organizations, and a range of higher education institutions.
